AN ACT

Making appropriations for the Department of Homeland Security for the fiscal year ending September 30, 2004, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That the following sums are appropriated, out of any
- 4 money in the Treasury not otherwise appropriated, for the
- 5 Department of the Homeland Security for the fiscal year
- 6 ending September 30, 2004, and for other purposes,

- 4 For necessary expenses, as determined by the Sec-
- 5 retary of Homeland Security, \$20,000,000, to remain

- 9 cluding payment of rewards in connection with these ac-
- 10 tivities: Provided, That the Secretary shall notify the Com-

- 14 stances or items; the provision of support to Department

23	SALARIES AND EXPENSES
24	For the necessary expenses of the Federal Law En-
25	forcement Training Center, \$136,629,000, of which

\$26,635,000 shall be for material and support costs of 1 Federal law enforcement basic training and shall remain available until September 30, 2006, and of which not to 3 4 exceed \$12,000 shall be for official reception and represen-5 tation expenses: Provided, That notwithstanding any other provision of law, the Center is authorized to expend appropriations for the purchase of police-type pursuit vehicles 8 without regard to the general purchase price limitation; student athletic and related recreational activities; con-10 ducting and participating in firearms matches and the presentation of awards for such matches; public awareness and enhancing community support of law enforcement training, including the advertisement and marketing of available law enforcement training programs; room and board for student interns; short-term medical services for students undergoing training at Center training facilities; 16 travel expenses of non-Federal personnel attending course development meetings; services authorized by section 3109 18 of title 5, United States Code; support of Federal law en-20 forcement accreditation; and a flat monthly reimbursement to employees authorized to use personal cell phones 21 for official duties: Provided further, That: (1) funds appropriated to this account may be used at the discretion of the Center's Director to train United States Postal Service law enforcement personnel, State and local law enforce-

24	\$10,000,000), to remain available until expended: Pro-
