# RESOLUTION

Providing for consideration of the bill (H.R. 3180) to authorize appropriations for fiscal year 2018 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System, and for other purposes; waiving a requirement of clause 6(a) of rule XIII with respect to consideration of certain resolutions reported from the Committee

on Rules; and providing for proceedings during the period from July 31, 2017, through September 4, 2017.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 3180) to authorize appropriations for fiscal year 2018 for  
4 intelligence and intelligence-related activities of the United  
5 States Government, the Community Management Ac-  
6 count, and the Central Intelligence Agency Retirement  
7 and Disability System, and for other purposes. All points  
8 of order against consideration of the bill are waived. The  
9 amendment in the nature of a substitute recommended by  
10 the Permanent Select Committee on Intelligence now  
11 printed in the bill shall be considered as adopted. The bill,  
12 as amended, shall be considered as read. All points of  
13 order against provisions in the bill, as amended, are  
14 waived. The previous question shall be considered as or-  
15 dered on the bill, as amended, and on any further amend-  
16 ment thereto, to final passage without intervening motion  
17 except: (1) one hour of debate equally divided and con-  
18 trolled by the chair and ranking minority member of the  
19 Permanent Select Committee on Intelligence; and (2) one  
20 motion to recommit with or without instructions.

21       SEC. 2. The requirement of clause 6(a) of rule XIII  
22 for a two-thirds vote to consider a report from the Com-  
23 mittee on Rules on the same day it is presented to the

1 House is waived with respect to any resolution reported  
2 through the legislative day of August 1, 2017.

3 SEC. 3. On any legislative day during the period from  
4 July 31, 2017, through September 4, 2017—

5 (a) the Journal of the proceedings of the previous day  
6 shall be considered as approved; and

7 (b) the Chair may at any time declare the House ad-  
8 journed to meet at a date and time, within the limits of  
9 clause 4, section 5, article I of the Constitution, to be an-  
10 nounced by the Chair in declaring the adjournment.

11 SEC. 4. The Speaker may appoint Members to per-  
12 form the duties of the Chair for the duration of the period  
13 addressed by section 3 of this resolution as though under  
14 clause 8(a) of rule I.

15 SEC. 5. Each day during the period addressed by sec-  
16 tion 3 of this resolution shall not constitute a calendar  
17 day for purposes of section 7 of the War Powers Resolu-  
18 tion (50 U.S.C. 1546).

19 SEC. 6. Each day during the period addressed by sec-  
20 tion 3 of this resolution shall not constitute a legislative  
21 day for purposes of clause 7 of rule XIII.

22 SEC. 7. Each day during the period addressed by sec-  
23 tion 3 of this resolution shall not constitute a calendar  
24 or legislative day for purposes of clause 7(c)(1) of rule  
25 XXII.
