# RESOLUTION

Providing for further consideration of the bill (H.R. 5895) making appropriations for energy and water development and related agencies for the fiscal year ending September 30, 2019, and for other purposes, and providing for consideration of the bill (H.R. 3) to rescind certain budget authority proposed to be rescinded in special messages transmitted to the Congress by the President on May 8, 2018, in accordance with title X of the Congressional Budget and Impoundment Control Act 1974.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for further  
5 consideration of the bill (H.R. 5895) making appropria-  
6 tions for energy and water development and related agen-  
7 cies for the fiscal year ending September 30, 2019, and  
8 for other purposes. The further amendment printed in  
9 part A of the report of the Committee on Rules accom-  
10 panying this resolution shall be considered as adopted in  
11 the House and in the Committee of the Whole. No further  
12 amendment to the bill, as amended, shall be in order ex-  
13 cept those printed in part B of the report of the Com-  
14 mittee on Rules and available pro forma amendments de-  
15 scribed in section 4 of House Resolution 918. Each further  
16 amendment printed in part B of the report shall be consid-  
17 ered only in the order printed in the report, may be offered  
18 only by a Member designated in the report, shall be con-  
19 sidered as read, shall be debatable for the time specified  
20 in the report equally divided and controlled by the pro-  
21 ponent and an opponent, may be withdrawn by the pro-  
22 ponent at any time before action thereon, shall not be sub-  
23 ject to amendment except amendments described in sec-  
24 tion 4 of House Resolution 918, and shall not be subject  
25 to a demand for division of the question in the House or

1 in the Committee of the Whole. All points of order against  
2 such further amendments are waived. At the conclusion  
3 of consideration of the bill for amendment the Committee  
4 shall rise and report the bill, as amended, to the House  
5 with such further amendments as may have been adopted.  
6 The previous question shall be considered as ordered on  
7 the bill and amendments thereto to final passage without  
8 intervening motion except one motion to recommit with  
9 or without instructions.

10       SEC. 2. Upon adoption of this resolution it shall be  
11 in order to consider in the House the bill (H.R. 3) to re-  
12 scind certain budget authority proposed to be rescinded  
13 in special messages transmitted to the Congress by the  
14 President on May 8, 2018, in accordance with title X of  
15 the Congressional Budget and Impoundment Control Act  
16 1974. All points of order against consideration of the bill  
17 are waived. The amendment printed in part C of the re-  
18 port of the Committee on Rules accompanying this resolu-  
19 tion shall be considered as adopted. The bill, as amended,  
20 shall be considered as read. All points of order against  
21 provisions in the bill, as amended, are waived. The pre-  
22 vious question shall be considered as ordered on the bill,  
23 as amended, and on any further amendment thereto, to  
24 final passage without intervening motion except: (1) one  
25 hour of debate equally divided and controlled by the Ma-

1 jority Leader and the Minority Leader or their respective  
2 designees; and (2) one motion to recommit with or without  
3 instructions.

4       SEC. 3. The provisions of section 1017 of the Im-  
5 poundment Control Act of 1974 shall not apply to a bill  
6 or joint resolution introduced with respect to the special  
7 message transmitted under section 1012 of that Act on  
8 May 8, 2018.
