RESOLUTION

Providing for further consideration of the bill (H.R. 2) to provide for the reform and continuation of agricultural and other programs of the Department of Agriculture through fiscal year 2023, and for other purposes.

- 1 *Resolved*, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of
- 4 the Whole House on the state of the Union for further
- 5 consideration of the bill (H.R. 2) to provide for the reform
- 6 and continuation of agricultural and other programs of the

1 Department of Agriculture through fiscal year 2023, and
2 for other purposes. No further amendment to the com-
3 mittee amendment in the nature of a substitute shall be
4 in order except those printed in the report of the Com-
5 mittee on Rules accompanying this resolution. Each such
6 further amendment may be offered only in the order print-
7 ed in the report, may be offered only by a Member des-
8 ignated in the report, shall be considered as read, shall
9 be debatable for the time specified in the report equally
10 divided and controlled by the proponent and an opponent,
11 shall not be subject to amendment, and shall not be sub-
12 ject to a demand for division of the question in the House
13 or in the Committee of the Whole. All points of order
14 against such further amendments are waived. At the con-
15 clusion of consideration of the bill for amendment pursu-
16 ant to this resolution the Committee shall rise and report
17 the bill to the House with such amendments as may have
18 been adopted. Any Member may demand a separate vote
19 in the House on any amendment adopted in the Com-
20 mittee of the Whole to the bill or to the committee amend-
21 ment in the nature of a substitute. The previous question
22 shall be considered as ordered on the bill and amendments
23 thereto to final passage without intervening motion except
24 one motion to recommit with or without instructions.
