# RESOLUTION

Providing for consideration of the bill (H.R. 953) to amend the Federal Insecticide, Fungicide, and Rodenticide Act and the Federal Water Pollution Control Act to clarify Congressional intent regarding the regulation of the use of pesticides in or near navigable waters, and for other purposes.

- 1        *Resolved*, That at any time after adoption of this reso-
- 2 lution the Speaker may, pursuant to clause 2(b) of rule
- 3 XVIII, declare the House resolved into the Committee of

1 the Whole House on the state of the Union for consider-  
2 ation of the bill (H.R. 953) to amend the Federal Insecti-  
3 cide, Fungicide, and Rodenticide Act and the Federal  
4 Water Pollution Control Act to clarify Congressional in-  
5 tent regarding the regulation of the use of pesticides in  
6 or near navigable waters, and for other purposes. The first  
7 reading of the bill shall be dispensed with. All points of  
8 order against consideration of the bill are waived. General  
9 debate shall be confined to the bill and shall not exceed  
10 one hour equally divided and controlled by the chair and  
11 ranking minority member of the Committee on Transpor-  
12 tation and Infrastructure. After general debate the bill  
13 shall be considered for amendment under the five-minute  
14 rule. It shall be in order to consider as an original bill  
15 for the purpose of amendment under the five-minute rule  
16 an amendment in the nature of a substitute consisting of  
17 the text of Rules Committee Print 115-21. That amend-  
18 ment in the nature of a substitute shall be considered as  
19 read. All points of order against that amendment in the  
20 nature of a substitute are waived. No amendment to that  
21 amendment in the nature of a substitute shall be in order  
22 except those printed in the report of the Committee on  
23 Rules accompanying this resolution. Each such amend-  
24 ment may be offered only in the order printed in the re-  
25 port, may be offered only by a Member designated in the

1 report, shall be considered as read, shall be debatable for  
2 the time specified in the report equally divided and con-  
3 trolled by the proponent and an opponent, shall not be  
4 subject to amendment, and shall not be subject to a de-  
5 mand for division of the question in the House or in the  
6 Committee of the Whole. All points of order against such  
7 amendments are waived. At the conclusion of consider-  
8 ation of the bill for amendment the Committee shall rise  
9 and report the bill to the House with such amendments  
10 as may have been adopted. Any Member may demand a  
11 separate vote in the House on any amendment adopted  
12 in the Committee of the Whole to the bill or to the amend-  
13 ment in the nature of a substitute made in order as origi-  
14 nal text. The previous question shall be considered as or-  
15 dered on the bill and amendments thereto to final passage  
16 without intervening motion except one motion to recommit  
17 with or without instructions.
