# RESOLUTION

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the joint resolu-  
3 tion (H.J. Res. 44) disapproving the rule submitted by  
4 the Department of the Interior relating to Bureau of Land  
5 Management regulations that establish the procedures  
6 used to prepare, revise, or amend land use plans pursuant  
7 to the Federal Land Policy and Management Act of 1976.  
8 All points of order against consideration of the joint reso-  
9 lution are waived. The joint resolution shall be considered  
10 as read. All points of order against provisions in the joint  
11 resolution are waived. The previous question shall be con-  
12 sidered as ordered on the joint resolution and on any  
13 amendment thereto to final passage without intervening  
14 motion except: (1) one hour of debate equally divided and  
15 controlled by the chair and ranking minority member of

1 the Committee on Natural Resources; and (2) one motion  
2 to recommit.

3 SEC. 2. Upon adoption of this resolution it shall be  
4 in order to consider in the House any joint resolution spec-  
5 ified in section 3 of this resolution. All points of order  
6 against consideration of each such joint resolution are  
7 waived. Each such joint resolution shall be considered as  
8 read. All points of order against provisions in each such  
9 joint resolution are waived. The previous question shall be  
10 considered as ordered on each such joint resolution and  
11 on any amendment thereto to final passage without inter-  
12 vening motion except: (1) one hour of debate equally di-  
13 vided and controlled by the chair and ranking minority  
14 member of the Committee on Education and the Work-  
15 force; and (2) one motion to recommit.

16 SEC. 3. The joint resolutions referred to in section  
17 2 of this resolution are as follows:

18 (a) The joint resolution (H.J. Res. 57) providing for  
19 congressional disapproval under chapter 8 of title 5,  
20 United States Code, of the rule submitted by the Depart-  
21 ment of Education relating to accountability and State  
22 plans under the Elementary and Secondary Education Act  
23 of 1965.

24 (b) The joint resolution (H.J. Res. 58) providing for  
25 congressional disapproval under chapter 8 of title 5,
