Mr. BURGESS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 6) to provide for opioid use disorder prevention, recovery, and treatment, and for other purposes; providing for consideration of the bill (H.R. 5797) to amend title XIX of the Social Security Act to allow States to provide under Medicaid services for certain individuals with opioid use disorders in institutions for mental diseases; and providing for consideration of the bill (H.R. 6082) to amend the Public

Health Service Act to protect the confidentiality of substance use disorder patient records.

1 *Resolved*, That at any time after adoption of this reso-
2 lution the Speaker may, pursuant to clause 2(b) of rule
3 XVIII, declare the House resolved into the Committee of
4 the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 6) to provide for opioid use disorder
6 prevention, recovery, and treatment, and for other pur-
7 poses. The first reading of the bill shall be dispensed with.
8 All points of order against consideration of the bill are
9 waived. General debate shall be confined to the bill and
10 shall not exceed one hour equally divided and controlled
11 by the chair and ranking minority member of the Com-
12 mittee on Energy and Commerce. After general debate the
13 bill shall be considered for amendment under the five-
14 minute rule. An amendment in the nature of a substitute
15 consisting of the text of Rules Committee Print 115-76,
16 modified by Rules Committee Print 115-78 and the
17 amendment printed in part A of the report of the Com-
18 mittee on Rules accompanying this resolution, shall be
19 considered as adopted in the House and in the Committee
20 of the Whole. The bill, as amended, shall be considered
21 as the original bill for the purpose of further amendment
22 under the five-minute rule and shall be considered as read.
23 All points of order against provisions in the bill, as amend-
24 ed, are waived. No further amendment to the bill, as

1 amended, shall be in order except those printed in part
2 B of the report of the Committee on Rules. Each such
3 further amendment may be offered only in the order print-
4 ed in the report, may be offered only by a Member des-
5 igned in the report, shall be considered as read, shall
6 be debatable for the time specified in the report equally
7 divided and controlled by the proponent and an opponent,
8 shall not be subject to amendment, and shall not be sub-
9 ject to a demand for division of the question in the House
10 or in the Committee of the Whole. All points of order
11 against such further amendments are waived. At the con-
12 clusion of consideration of the bill for amendment the
13 Committee shall rise and report the bill, as amended, to
14 the House with such further amendments as may have
15 been adopted. The previous question shall be considered
16 as ordered on the bill, as amended, and any further
17 amendment thereto to final passage without intervening
18 motion except one motion to recommit with or without in-
19 structions.

20 SEC. 2. At any time after adoption of this resolution
21 the Speaker may, pursuant to clause 2(b) of rule XVIII,
22 declare the House resolved into the Committee of the
23 Whole House on the state of the Union for consideration
24 of the bill (H.R. 5797) to amend title XIX of the Social
25 Security Act to allow States to provide under Medicaid

1 services for certain individuals with opioid use disorders
2 in institutions for mental diseases. The first reading of
3 the bill shall be dispensed with. All points of order against
4 consideration of the bill are waived. General debate shall
5 be confined to the bill and shall not exceed one hour equal-
6 ly divided and controlled by the chair and ranking minor-
7 ity member of the Committee on Energy and Commerce.
8 After general debate the bill shall be considered for
9 amendment under the five-minute rule. The amendment
10 in the nature of a substitute recommended by the Com-
11 mittee on Energy and Commerce now printed in the bill,
12 modified by the amendment printed in part C of the report
13 of the Committee on Rules accompanying this resolution,
14 shall be considered as adopted in the House and in the
15 Committee of the Whole. The bill, as amended, shall be
16 considered as the original bill for the purpose of further
17 amendment under the five-minute rule and shall be consid-
18 ered as read. All points of order against provisions in the
19 bill, as amended, are waived. No further amendment to
20 the bill, as amended, shall be in order except those printed
21 in part D of the report of the Committee on Rules. Each
22 such further amendment may be offered only in the order
23 printed in the report, may be offered only by a Member
24 designated in the report, shall be considered as read, shall
25 be debatable for the time specified in the report equally

1 divided and controlled by the proponent and an opponent,
2 shall not be subject to amendment, and shall not be sub-
3 ject to a demand for division of the question in the House
4 or in the Committee of the Whole. All points of order
5 against such further amendments are waived. At the con-
6 clusion of consideration of the bill for amendment the
7 Committee shall rise and report the bill, as amended, to
8 the House with such further amendments as may have
9 been adopted. The previous question shall be considered
10 as ordered on the bill, as amended, and any further
11 amendment thereto to final passage without intervening
12 motion except one motion to recommit with or without in-
13 structions.

14 SEC. 3. Upon adoption of this resolution it shall be
15 in order to consider in the House the bill (H.R. 6082)
16 to amend the Public Health Service Act to protect the con-
17 fidentiality of substance use disorder patient records. All
18 points of order against consideration of the bill are waived.
19 An amendment in the nature of a substitute consisting
20 of the text of Rules Committee Print 115-75 shall be con-
21 sidered as adopted. The bill, as amended, shall be consid-
22 ered as read. All points of order against provisions in the
23 bill, as amended, are waived. The previous question shall
24 be considered as ordered on the bill, as amended, and on
25 any further amendment thereto, to final passage without

1 intervening motion except: (1) one hour of debate equally
2 divided and controlled by the chair and ranking minority
3 member of the Committee on Energy and Commerce; and
4 (2) one motion to recommit with or without instructions.

5 SEC. 4. In the engrossment of H.R. 6, the Clerk
6 shall—

7 (a) add the respective texts of H.R. 2851, H.R.
8 5735, and H.R. 5797, as passed by the House, as
9 new matter at the end of H.R. 6;

10 (b) assign appropriate designations to provi-
11 sions within the engrossment; and

12 (c) conform cross-references and provisions for
13 short titles within the engrossment.
