RESOLUTION

Providing for consideration of the bill (H.R. 4790) to amend the Volcker rule to give the Board of Governors of the Federal Reserve System sole rulemaking authority, to exclude community banks from the requirements of the Volcker rule, and for other purposes, and providing for consideration of motions to suspend the rules.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 4790) to amend the Volcker rule to give the Board of Gov-

1 errors of the Federal Reserve System sole rulemaking au-
2 thority, to exclude community banks from the require-
3 ments of the Volcker rule, and for other purposes. All
4 points of order against consideration of the bill are waived.
5 In lieu of the amendment in the nature of a substitute
6 recommended by the Committee on Financial Services now
7 printed in the bill, an amendment in the nature of a sub-
8 stitute consisting of the text of Rules Committee Print
9 115-67 shall be considered as adopted. The bill, as amend-
10 ed, shall be considered as read. All points of order against
11 provisions in the bill, as amended, are waived. The pre-
12 vious question shall be considered as ordered on the bill,
13 as amended, and on any further amendment thereto, to
14 final passage without intervening motion except: (1) one
15 hour of debate equally divided and controlled by the chair
16 and ranking minority member of the Committee on Finan-
17 cial Services; and (2) one motion to recommit with or with-
18 out instructions.

19 SEC. 2. (a) It shall be in order at any time on the
20 legislative day of April 12, 2018, for the Speaker to enter-
21 tain motions that the House suspend the rules, as though
22 under clause 1 of rule XV, relating to the joint resolution
23 (H.J. Res. 2) proposing a balanced budget amendment to
24 the Constitution of the United States. Debate on such a
25 motion shall be extended to four hours. (b) The Chair may

- 1 postpone further consideration of a motion considered pur-
- 2 suant to subsection (a) to such time as may be designated
- 3 by the Speaker.
