## AN ACT

To amend title II of the Social Security Act to authorize voluntary agreements for coverage of Indian tribal council members, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Tribal Social Security  
3 Fairness Act of 2018”.

4 **SEC. 2. VOLUNTARY AGREEMENTS FOR COVERAGE OF**  
5 **SERVICES BY AMERICAN INDIAN TRIBAL**  
6 **COUNCIL MEMBERS.**

7 (a) IN GENERAL.—Title II of the Social Security Act  
8 (42 U.S.C. 401 et seq.) is amended by inserting after sec-  
9 tion 218 the following new section:

10 “VOLUNTARY AGREEMENTS FOR COVERAGE OF INDIAN  
11 TRIBAL COUNCIL MEMBERS

12 “Purpose of Agreement

13 “SEC. 218A. (a)(1) The Commissioner of Social Se-  
14 curity shall, at the request of any Indian tribe, enter into  
15 an agreement with such Indian tribe for the purpose of  
16 extending the insurance system established by this title to  
17 services performed by individuals as members of such In-  
18 dian tribe’s tribal council. Any agreement with an Indian  
19 tribe under this section applies to all members of the tribal  
20 council, and shall include all services performed by individ-  
21 uals in their capacity as council members.

22 “(2) Notwithstanding section 210(a), for the pur-  
23 poses of this title, the term ‘employment’ includes any  
24 service included under an agreement entered into under  
25 this section.

## 1 “Definitions

2 “(b) For the purposes of this section:

3 “(1) The term ‘member’ means, with respect to  
4 a tribal council, an individual appointed or elected to  
5 serve as a member or the head of the tribal council.6 “(2) The term ‘tribal council’ means the ap-  
7 pointed or elected governing body of a federally rec-  
8 ognized Indian tribe.

## 9 “Effective Date of Agreement

10 “(c)(1) Any agreement under this section shall be ef-  
11 fective with respect to services performed after an effective  
12 date specified in such agreement, provided that such date  
13 may not be earlier than the first day of the next calendar  
14 month after the month in which the agreement is executed  
15 by both parties.16 “(2) At the request of the Indian tribe at the time  
17 of the agreement, such agreement may apply with respect  
18 to services performed before such effective date for which  
19 there were timely paid in good faith (and not subsequently  
20 refunded) to the Secretary of the Treasury amounts equiv-  
21 alent to the sum of the taxes which would have been im-  
22 posed by sections 3101 and 3111 of the Internal Revenue  
23 Code of 1986 had such services constituted employment  
24 for purposes of chapter 21 of such Code. No agreement  
25 under this section may require payment to be made after

1 the effective date specified in such agreement of any taxes  
2 with respect to services performed before such effective  
3 date.

4 “Duration of Agreement

5 “(d) No agreement under this section may be termi-  
6 nated on or after the effective date of the agreement.”.

7 (b) CONFORMING AMENDMENTS.—

8 (1) SOCIAL SECURITY ACT.—Section 210(a) of  
9 the Social Security Act (42 U.S.C. 410(a)) is  
10 amended—

11 (A) in paragraph (20), by striking “or” at  
12 the end;

13 (B) in paragraph (21), by striking the pe-  
14 riod at the end and inserting “; or”; and

15 (C) by inserting after paragraph (21) the  
16 following new paragraph:

17 “(22) Service performed by members of Indian  
18 tribal councils as tribal council members in the em-  
19 ploy of an Indian tribal government, except that this  
20 paragraph shall not apply in the case of service in-  
21 cluded under an agreement under section 218A.”.

22 (2) INTERNAL REVENUE CODE OF 1986.—The  
23 Internal Revenue Code of 1986 is amended—

24 (A) in section 3121(b)—

1 (i) in paragraph (20), by striking “or”  
2 at the end;

3 (ii) in paragraph (21), by striking the  
4 period at the end and inserting “; or”; and

5 (iii) by inserting after paragraph (21)  
6 the following new paragraph:

7 “(22) service performed by members of Indian  
8 tribal councils as tribal council members in the em-  
9 ploy of an Indian tribal government, except that this  
10 paragraph shall not apply in the case of service in-  
11 cluded under an agreement under section 218A of  
12 the Social Security Act.”; and

13 (B) in section 3121(d)(4), by inserting “or  
14 218A” after “section 218”.

15 (c) RULE OF CONSTRUCTION.—Nothing in this Act  
16 or the amendments made by this Act shall be construed  
17 to affect application of any Federal income tax with-  
18 holding requirements under the Internal Revenue Code of  
19 1986.
