2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. JOHN HERVEY WHEELER UNITED STATES**  
4 **COURTHOUSE.**

5        (a) *DESIGNATION.*—*The United States courthouse lo-*  
6 *cated at 323 East Chapel Hill Street in Durham, North*  
7 *Carolina, shall be known and designated as the “John*  
8 *Hervey Wheeler United States Courthouse” during the pe-*  
9 *riod in which the facility is used as a Federal courthouse.*

10        (b) *REFERENCES.*—*During the period in which the fa-*  
11 *cility referred to in subsection (a) is used as a Federal*  
12 *courthouse, any reference in a law, map, regulation, docu-*  
13 *ment, paper, or other record of the United States to the*  
14 *United States courthouse referred to in subsection (a) shall*  
15 *be deemed to be a reference to the “John Hervey Wheeler*  
16 *United States Courthouse”.*
