# **A BILL**

To waive the application fee for any special use permit for veterans demonstrations and special events at war memorials on Federal land, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Free Veterans from Fees*  
5 *Act”.*

6 **SEC. 2. WAIVER OF SPECIAL USE PERMIT APPLICATION FEE**  
7 **FOR VETERANS DEMONSTRATIONS AND SPE-**  
8 **CIAL EVENTS.**

9 (a) *WAIVER.—The application fee for any special use*  
10 *permit solely for a veterans demonstration or special event*  
11 *at war memorials on Federal land shall be waived.*

12 (b) *DEFINITIONS.—In this section:*

13 (1) *DEMONSTRATION; SPECIAL EVENT.—The*  
14 *terms “demonstration” and “special event” have the*  
15 *meaning given those terms in section 7.96 of title 36,*  
16 *Code of Federal Regulations.*

17 (2) *VETERAN.—The term “veteran” has the*  
18 *meaning given that term in section 101(2) of title 38,*  
19 *United States Code.*

20 (3) *VETERANS DEMONSTRATION OR SPECIAL*  
21 *EVENT.—The term “veterans demonstration or special*  
22 *event” means a demonstration or special event whose*  
23 *primary purpose is to commemorate, or honor either*  
24 *a group of people because of their service as veterans*  
25 *or immediate family members of veterans.*

1           (4) *WAR MEMORIAL.*—*The term “war memorial”*  
2           *means any tangible object which has been erected or*  
3           *dedicated to commemorate—*

4                   (A) *war, conflict, victory, or peace;*

5                   (B) *casualties who served in, were affected*  
6                   *by, or killed as a result of war, conflict, or peace-*  
7                   *keeping; or*

8                   (C) *those who died as a result of accident*  
9                   *or disease while engaged in military service.*

10          (c) *APPLICABILITY.*—*This section shall apply to any*  
11          *special use permit application submitted after the date of*  
12          *the enactment of this Act.*

13          (d) *APPLICABILITY OF EXISTING LAWS.*—*Permit ap-*  
14          *plicants remain subject to all other laws, regulations, and*  
15          *policies regarding the application, issuance and execution*  
16          *of special use permits for a veterans demonstration or spe-*  
17          *cial event at war memorials on Federal land.*
