# **A BILL**

To amend title 38, United States Code, to provide for a five-year extension to the homeless veterans reintegration programs and to provide clarification regarding eligibility for services under such programs.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Homeless Veterans’ Re-*  
5 *integration Programs Reauthorization Act of 2018”.*

6 **SEC. 2. REAUTHORIZATION OF HOMELESS VETERANS RE-**  
7 **INTEGRATION PROGRAMS.**

8        (a) *FIVE-YEAR EXTENSION OF HOMELESS VETERANS*  
9 *REINTEGRATION PROGRAMS.*—*Section 2021(e)(1)(F) of*  
10 *title 38, United States Code, is amended by striking “2018”*  
11 *and inserting “2022”.*

12        (b) *FIVE-YEAR EXTENSION OF HOMELESS WOMEN*  
13 *VETERANS AND HOMELESS VETERANS WITH CHILDREN*  
14 *REINTEGRATION GRANT PROGRAM.*—*Section 2021A(f)(1) of*  
15 *such title is amended by striking “2018” and inserting*  
16 *“2022”.*

17        (c) *CLARIFICATION OF ELIGIBILITY FOR SERVICES*  
18 *UNDER HOMELESS VETERANS REINTEGRATION PRO-*  
19 *GRAMS.*—*Section 2021(a) of such title is amended by strik-*  
20 *ing “reintegration of homeless veterans into the labor force.”*  
21 *and inserting the following: “reintegration into the labor*  
22 *force of—*

23                *“(1) homeless veterans (including veterans who*  
24                *were homeless but found housing during the 60-day*

1       *period preceding the date on which the veteran begins*  
2       *to participate in a program under this section);*

3               “(2) *veterans participating in the Department of*  
4       *Veterans Affairs supported housing program for*  
5       *which rental assistance is provided pursuant to sec-*  
6       *tion 8(o)(19) of the United States Housing Act of*  
7       *1937 (42 U.S.C. 1437f(o)(19)) or the Tribal HUD–VA*  
8       *Supportive Housing (Tribal HUD–VASH) program;*

9               “(3) *Indians who are veterans and receiving as-*  
10       *stance under the Native American Housing Assist-*  
11       *ance and Self Determination Act of 1996 (25 U.S.C.*  
12       *4101 et seq.);*

13               “(4) *veterans described in section 2023(e) of this*  
14       *title or any other veterans who are transitioning from*  
15       *being incarcerated; and*

16               “(5) *veterans participating in the Department of*  
17       *Veterans Affairs rapid rehousing and prevention pro-*  
18       *gram authorized in section 2044 of this title.”.*
