1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REPEAL OF IMPOSITION OF 3 PERCENT WITH-**
4 **HOLDING ON CERTAIN PAYMENTS MADE TO**
5 **VENDORS BY GOVERNMENT ENTITIES.**

6 (a) IN GENERAL.—Section 3402 of the Internal Rev-
7 enue Code of 1986 is amended by striking subsection (t).

8 (b) EFFECTIVE DATE.—The amendment made by
9 this section shall apply to payments made after December
10 31, 2011.
