A BILL

To amend the Federal Insecticide, Fungicide, and Rodenticide Act to improve pesticide registration and other activities under the Act, to extend and modify fee authorities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) *SHORT TITLE.*—*This Act may be cited as the “Pes-*
 5 *ticide Registration Enhancement Act of 2017”.*

6 (b) *TABLE OF CONTENTS.*—*The table of contents for*

8 **SEC. 2. EXTENSION AND MODIFICATION OF MAINTENANCE**

9 **FEE AUTHORITY.**

10 (a) *MAINTENANCE FEE.*—*Section 4(i)(1) of the Fed-*
 11 *eral Insecticide, Fungicide, and Rodenticide Act (7 U.S.C.*
 12 *136a–1(i)(1)) is amended—*

13 (1) *in subparagraph (C), by striking “an aggre-*
 14 *gate amount of \$27,800,000 for each of fiscal years*
 15 *2013 through 2017” and inserting “an average*
 16 *amount of \$31,000,000 for each of fiscal years 2017*
 17 *through 2023”;*

18 (2) *in subparagraph (D)—*

19 (A) *in clause (i), by striking “\$115,500 for*
 20 *each of fiscal years 2013 through 2017” and in-*

1 serting “\$129,400 for each of fiscal years 2017
2 through 2023”; and

3 (B) in clause (ii), by striking “\$184,800 for
4 each of fiscal years 2013 through 2017” and in-
5 serting “\$207,000 for each of fiscal years 2017
6 through 2023”;

7 (3) in subparagraph (E)(i)—

8 (A) in subclause (I), by striking “\$70,600
9 for each of fiscal years 2013 through 2017” and
10 inserting “\$79,100 for each of fiscal years 2017
11 through 2023”; and

12 (B) in subclause (II), by striking “\$122,100
13 for each of fiscal years 2013 through 2017” and
14 inserting “\$136,800 for each of fiscal years 2017
15 through 2023”; and

16 (4) in subparagraph (I), by striking “2017” and
17 inserting “2023”.

18 (b) *PROHIBITION ON OTHER FEES.*—Section 4(i)(2) of
19 the *Federal Insecticide, Fungicide, and Rodenticide Act* (7
20 *U.S.C. 136a–1(i)(2)*) is amended—

21 (1) by striking “during the period beginning on
22 the date of enactment of this section and ending on
23 September 30, 2019” and inserting “until September
24 30, 2025”; and

1 *the purposes specified in paragraphs (4) and (5), and*
2 *to enhance the information systems capabilities to im-*
3 *prove the tracking of pesticide registration deci-*
4 *sions.”;*

5 *(3) in clause (i), by striking “are allocated sole-*
6 *ly” and all that follows through “3(g);” and inserting*
7 *the following: “are allocated solely for the purposes*
8 *specified in the first sentence of this subparagraph;”;*
9 *and*

10 *(4) in clause (ii), by striking “necessary to*
11 *achieve” and all that follows through “3(g);” and in-*
12 *serting the following: “necessary to achieve the pur-*
13 *poses specified in the first sentence of this subpara-*
14 *graph;”.*

15 *(b) SET-ASIDE FOR REVIEW OF INERT INGREDIENTS*
16 *AND EXPEDITED PROCESSING OF SIMILAR APPLICA-*
17 *TIONS.—Section 4(k)(3)(A) of the Federal Insecticide, Fun-*
18 *gicide, and Rodenticide Act (7 U.S.C. 136a–1(k)(3)(A)) is*
19 *amended, in the matter preceding clause (i), by striking*
20 *“The Administrator shall use” and all that follows through*
21 *“personnel and resources—” and inserting the following:*
22 *“For each of fiscal years 2017 through 2023, the Adminis-*
23 *trator shall use between $\frac{1}{9}$ and $\frac{1}{8}$ of the maintenance fees*
24 *collected in such fiscal year to obtain sufficient personnel*
25 *and resources—”.*

1 (c) *SET-ASIDE FOR EXPEDITED RULEMAKING AND*
2 *GUIDANCE DEVELOPMENT FOR CERTAIN PURPOSES.—*
3 *Paragraph (4) of section 4(k) of the Federal Insecticide,*
4 *Fungicide, and Rodenticide Act (7 U.S.C. 136a–1(k)) is*
5 *amended to read as follows:*

6 “(4) *EXPEDITED RULEMAKING AND GUIDANCE*
7 *DEVELOPMENT FOR CERTAIN PRODUCT PERFORMANCE*
8 *DATA REQUIREMENTS.—*

9 “(A) *SET-ASIDE.—For each of fiscal years*
10 *2017 through 2021, the Administrator shall use*
11 *not more than \$500,000 of the amounts made*
12 *available to the Administrator in the Reregistra-*
13 *tion and Expedited Processing Fund for the ac-*
14 *tivities described in subparagraph (B).*

15 “(B) *PRODUCTS CLAIMING EFFICACY*
16 *AGAINST INVERTEBRATE PESTS OF SIGNIFICANT*
17 *PUBLIC HEALTH OR ECONOMIC IMPORTANCE.—*
18 *The Administrator shall use amounts made*
19 *available under subparagraph (A) to develop, re-*
20 *ceive comments with respect to, finalize, and im-*
21 *plement the necessary rulemaking and guidance*
22 *for product performance data requirements to*
23 *evaluate products claiming efficacy against the*
24 *following invertebrate pests of significant public*

1 *health or economic importance (in order of im-*
2 *portance):*

3 “(i) *Bed bugs.*

4 “(ii) *Premise (including crawling in-*
5 *sects, flying insects, and baits).*

6 “(iii) *Pests of pets (including pet pests*
7 *controlled by spot-ons, collars, shampoos,*
8 *powders, dips).*

9 “(iv) *Fire ants.*

10 “(C) *DEADLINES FOR GUIDANCE.—The Ad-*
11 *ministrator shall develop, and publish guidance*
12 *required by subparagraph (B) with respect to*
13 *claims of efficacy against pests described in such*
14 *subparagraph as follows:*

15 “(i) *With respect to bed bugs, issue*
16 *final guidance not later than June 30,*
17 *2017.*

18 “(ii) *With respect to pests specified in*
19 *clause (ii) of such subparagraph—*

20 “(I) *submit draft guidance to the*
21 *Scientific Advisory Panel and for pub-*
22 *lic comment not later than June 30,*
23 *2018; and*

24 “(II) *complete any response to*
25 *comments received with respect to such*

1 *draft guidance and finalize the guid-*
2 *ance not later than September 30,*
3 *2020.*

4 *“(iii) With respect to pests specified in*
5 *clauses (iii) and (iv) of such subpara-*
6 *graph—*

7 *“(I) submit to the Scientific Advi-*
8 *sory Panel and for public comment*
9 *draft guidance not later than June 30,*
10 *2019; and*

11 *“(II) complete any response to*
12 *comments received with respect to such*
13 *draft guidance and finalize the guid-*
14 *ance not later than March 31, 2021.*

15 *“(D) REVISION.—The Administrator shall*
16 *revise the guidance required by subparagraph*
17 *(B) from time-to-time, but shall permit appli-*
18 *cants and registrants sufficient time to obtain*
19 *data that meet the requirements specified in such*
20 *revised guidance.*

21 *“(E) DEADLINE FOR PRODUCT PERFORM-*
22 *ANCE DATA REQUIREMENTS.—The Administrator*
23 *shall, not later than September 30, 2021, issue*
24 *regulations prescribing product performance*
25 *data requirements for any pesticide intended for*

1 *preventing, destroying, repelling, or mitigating*
2 *any invertebrate pest of significant public health*
3 *or economic importance specified in clauses (i)*
4 *through (iv) of subparagraph (B).”.*

5 *(d) SET-ASIDE FOR GOOD LABORATORY PRACTICES*
6 *INSPECTIONS.—Section 4(k) of the Federal Insecticide,*
7 *Fungicide, and Rodenticide Act (7 U.S.C. 136a–1(k)) is*
8 *amended—*

9 *(1) by redesignating paragraphs (5) and (6) as*
10 *paragraphs (6) and (7), respectively;*

11 *(2) by inserting after paragraph (4) the fol-*
12 *lowing new paragraph:*

13 “*(5) GOOD LABORATORY PRACTICES INSPEC-*
14 *TIONS.—*

15 “*(A) SET-ASIDE.—For each of fiscal years*
16 *2017 through 2023, the Administrator shall use*
17 *not more than \$500,000 of the amounts made*
18 *available to the Administrator in the Reregistra-*
19 *tion and Expedited Processing Fund for the ac-*
20 *tivities described in subparagraph (B).*

21 “*(B) ACTIVITIES.—The Administrator shall*
22 *use amounts made available under subparagraph*
23 *(A) for enhancements to the good laboratory*
24 *practices standards compliance monitoring pro-*
25 *gram established under part 160 of title 40 of the*

1 *Code of Federal Regulations (or successor regula-*
2 *tions), with respect to laboratory inspections and*
3 *data audits conducted in support of pesticide*
4 *product registrations under this Act. As part of*
5 *such monitoring program, the Administrator*
6 *shall make available to each laboratory inspected*
7 *under such program in support of such registra-*
8 *tions a preliminary summary of inspection ob-*
9 *servations not later than 60 days after the date*
10 *on which such an inspection is completed.”; and*
11 *(3) in paragraph (7), as so redesignated, by*
12 *striking “paragraphs (2), (3), and (4)” and inserting*
13 *“paragraphs (2), (3), (4), and (5)”.*

14 **SEC. 4. EXPERIMENTAL USE PERMITS FOR PESTICIDES.**

15 *Subsection (a) of section 5 of the Federal Insecticide,*
16 *Fungicide, and Rodenticide Act (7 U.S.C. 136c) is amended*
17 *to read as follows:*

18 “(a) *APPLICATION AND ISSUANCE.*—

19 “(1) *APPLICATION.*—*Any person may apply to*
20 *the Administrator for an experimental use permit for*
21 *a pesticide. An application for an experimental use*
22 *permit may be filed at any time.*

23 “(2) *REQUIREMENTS.*—*An application for an*
24 *experimental use permit shall conform with the re-*
25 *quirements of section 33(b).*

1 “(3) *ISSUANCE*.—*The decision whether to grant*
2 *an experimental use permit shall be made within the*
3 *time-frame specified in the applicable covered appli-*
4 *cation category specified in section 33(b)(3).”.*

5 **SEC. 5. PESTICIDE REGISTRATION SERVICE FEES.**

6 (a) *EXTENSION AND MODIFICATION OF FEE AUTHOR-*
7 *ITY*.—*Section 33(b) of the Federal Insecticide, Fungicide,*
8 *and Rodenticide Act (7 U.S.C. 136w–8(b)) is amended—*

9 (1) *in paragraph (2)—*

10 (A) *in the heading, by striking “PESTICIDE*
11 *REGISTRATION”;* and

12 (B) *in subparagraph (A), by inserting “or*
13 *for any other action covered by a table specified*
14 *in paragraph (3)” after “covered by this Act that*
15 *is received by the Administrator on or after the*
16 *effective date of the Pesticide Registration Im-*
17 *provement Act of 2003”;*

18 (2) *in paragraph (5)—*

19 (A) *in the heading, by striking “PESTICIDE*
20 *REGISTRATION APPLICATIONS” and inserting*
21 *“COVERED APPLICATION”;* and

22 (B) *by striking “pesticide registration ap-*
23 *plication” both places it appears and inserting*
24 *“covered application”;*

25 (3) *in paragraph (6)—*

1 (A) in subparagraph (A)—

2 (i) by striking “pesticide registration”;

3 and

4 (ii) by striking “October 1, 2013, and
5 ending on September 30, 2015” and insert-
6 ing “October 1, 2019, and ending on Sep-
7 tember 30, 2021”;

8 (B) in subparagraph (B)—

9 (i) by striking “pesticide registration”;

10 and

11 (ii) by striking “2015” both places it
12 appears, and inserting “2021”; and

13 (C) in subparagraph (C), by striking “re-
14 vised registration service fee schedules” and in-
15 serting “service fee schedules revised pursuant to
16 this paragraph”;

17 (4) in paragraph (7)—

18 (A) in subparagraph (A)—

19 (i) by striking “covered pesticide reg-
20 istration” and inserting “covered applica-
21 tion”; and

22 (ii) by inserting before the period at
23 the end the following: “, except that no
24 waiver or fee reduction shall be provided in
25 connection with a request for a letter of cer-

1 *tification (commonly referred to as a Gold*
 2 *Seal letter)”; and*

3 *(B) in subparagraph (F)(i), by striking*
 4 *“pesticide registration”; and*

5 *(5) in paragraph (8)—*

6 *(A) in subparagraph (A), by striking “pes-*
 7 *ticide registration”;*

8 *(B) in subparagraph (B)(i), by striking*
 9 *“pesticide registration”; and*

10 *(C) in subparagraph (C)—*

11 *(i) in clause (i), by striking “pesticide*
 12 *registration” and inserting “covered”; and*

13 *(ii) in clause (ii)(I), by striking “pes-*
 14 *ticide registration” and inserting “covered”.*

15 *(b) PESTICIDE REGISTRATION FUND SET-ASIDES FOR*
 16 *WORKER PROTECTION, PARTNERSHIP GRANTS, AND PES-*
 17 *TICIDE SAFETY EDUCATION.—Section 33(c)(3)(B) of the*
 18 *Federal Insecticide, Fungicide, and Rodenticide Act (7*
 19 *U.S.C. 136w–8(c)(3)(B)) is amended—*

20 *(1) in the heading, by inserting “, PARTNERSHIP*
 21 *GRANTS, AND PESTICIDE SAFETY EDUCATION” after*
 22 *“WORKER PROTECTION”;*

23 *(2) in clause (i)—*

24 *(A) by striking “2017” and inserting*
 25 *“2023”; and*

1 (B) by inserting before the period at the end
2 the following: “, with an emphasis on field-work-
3 er populations in the United States”;

4 (3) in clause (ii), by striking “2017” and insert-
5 ing “2023”; and

6 (4) in clause (iii), by striking “2017” and in-
7 serting “2023”.

8 (c) *REFORMS TO REDUCE DECISION TIME REVIEW*
9 *PERIODS.*—Section 33(e) of the Federal Insecticide, Fun-
10 gicide, and Rodenticide Act (7 U.S.C. 136w–8(e)) is amend-
11 ed—

12 (1) by striking “Pesticide Registration Improve-
13 ment Extension Act of 2012” and inserting “Pesticide
14 Registration Enhancement Act of 2017”; and

15 (2) by inserting at the end the following new sen-
16 tence: “Such reforms shall include identifying oppor-
17 tunities for streamlining review processes for applica-
18 tions for a new active ingredient or a new use and
19 providing prompt feedback to applicants during such
20 review process.”.

21 (d) *DECISION TIME REVIEW PERIODS.*—Section 33(f)

11 “(L) a review of the progress made in the
12 priority review and approval of new pesticides
13 to control vector-borne public health pests for use
14 in the United States, including each territory or
15 possession of the United States, and United
16 States military installations globally;

17 “(M) a review of the progress made in im-
18 plementing enhancements to the good laboratory
19 practices standards compliance monitoring pro-
20 gram established under part 160 of title 40 of the
21 Code of Federal Regulations (or successor regula-
22 tions);

23 “(N) the number of approvals for active in-
24 gredients, new uses, and pesticide end use prod-
25 ucts granted in connection with the Design for

1 *the Environment program (or any successor pro-*
2 *gram) of the Environmental Protection Agency;*
3 *and*

4 “(O) *with respect to funds in the Pesticide*
5 *Registration Fund reserved under subsection*
6 *(c)(3), a review that includes—*

7 “(i) *a description of the amount and*
8 *use of such funds—*

9 “(I) *to carry out activities relat-*
10 *ing to worker protection under clause*
11 *(i) of subsection (c)(3)(B);*

12 “(II) *to award partnership grants*
13 *under clause (ii) of such subsection;*
14 *and*

15 “(III) *to carry out the pesticide*
16 *safety education program under clause*
17 *(iii) of such subsection;*

18 “(ii) *an evaluation of the appropriate-*
19 *ness and effectiveness of the activities,*
20 *grants, and program described in clause (i);*

21 “(iii) *a description of how stakeholders*
22 *are engaged in the decision to fund such ac-*
23 *tivities, grants, and program; and*

24 “(iv) *with respect to activities relating*
25 *to worker protection carried out under sub-*

1 paragraph (B)(i) of such subsection, a sum-
2 mary of the analyses from stakeholders, in-
3 cluding from worker community-based orga-
4 nizations, on the appropriateness and effec-
5 tiveness of such activities.”.

6 (f) *TERMINATION OF EFFECTIVENESS.*—Section 33(m)
7 of the Federal Insecticide, Fungicide, and Rodenticide Act
8 (7 U.S.C. 136w–8(m)) is amended—

9 (1) in paragraph (1), by striking “2017” and in-
10 sserting “2023”; and

11 (2) in paragraph (2)—

12 (A) in subparagraph (A)—

13 (i) by striking “FISCAL YEAR 2018.—
14 During fiscal year 2018” and inserting
15 “FISCAL YEAR 2024.—During fiscal year
16 2024”; and

17 (ii) by striking “2017” and inserting
18 “2023”;

19 (B) in subparagraph (B)—

20 (i) by striking “FISCAL YEAR 2019.—
21 During fiscal year 2019” and inserting
22 “FISCAL YEAR 2025.—During fiscal year
23 2025”; and

24 (ii) by striking “2017” and inserting

12 *Paragraph (3) of section 33(b) of the Federal Insecti-*
13 *cide, Fungicide, and Rodenticide Act (7 U.S.C. 136w–8(b))*

The application must be received by the agency in one package. The base fee for the category covers a maximum of five new products. Each application for an additional new product registration and new inert approval that is submitted in the new active ingredient application package or first food use application package is subject to the registration service fee for a new product or a new inert approval. All such associated applications that are submitted together will be subject to the new active ingredient or first food use decision review time. In the case of a new active ingredient application, until that new active ingredient is approved, any subsequent application for another new product containing the same active ingredient or an amendment to the proposed labeling will be deemed a new active ingredient application, subject to the registration service fee and decision review time for a new active ingredient. In the case of a first food use application, until that first food use is approved, any subsequent application for an additional new food use or uses will be subject to the registration service fee and decision review time for a first food use. Any information that (a) was neither requested nor required by the Agency, and (b) is submitted by the applicant at the applicant's initiative to support the application after completion of the technical deficiency screening, and (c) is not itself a covered registration application, must be assessed 25% of the full registration service fee for the new active ingredient or first food use application.

(3) An application for a new end-use product using a source of active ingredient that (a) is not yet registered but (b) has an application pending with the Agency for review, will be considered an application for a new product with an unregistered source of active ingredient.

(4) (a) EPA-initiated amendments shall not be charged registration service fees. (b) Registrant-initiated fast-track amendments are to be completed within the timelines specified in FIFRA Section 3(c)(3)(B) and are not subject to registration service fees. (c) Registrant-initiated fast-track amendments handled by the Antimicrobials Division are to be completed within the timelines specified in FIFRA Section 3(h) and are not subject to registration service fees. (d) Registrant initiated amendments submitted by notification under PR Notices, such as PR Notice 98-10, continue under PR Notice timelines and are not subject to registration service fees. (e) Submissions with data and requiring data review are subject to registration service fees.

(5) Amendment applications to add the new use(s) to registered product labels are covered by the base fee for the new use(s). All items in the covered application must be submitted together in one package. Each application for an additional new product registration and new inert approval(s) that is submitted in the new use application package is subject to the registration service fee for a new product or a new inert approval. However, if a new use application only proposes to register the new use for a new product and there are no amendments in the application, then review of one new product application is covered by the new use fee. All such associated applications that are submitted together will be subject to the new use decision review time. Any application for a new product or an amendment to the proposed labeling (a) submitted subsequent to submission of the new use application and (b) prior to conclusion of its decision review time and (c) containing the same new uses, will be deemed a separate new-use application, subject to a separate registration service fee and new decision review time for a new use. If the new-use application includes non-food (indoor and/or outdoor), and food (outdoor and/or indoor) uses, the appropriate fee is due for each type of new use and the longest decision review time applies to all of the new uses requested in the application. Any information that (a) was neither requested nor required by the Agency, and (b) is submitted by the applicant at the applicant's initiative to support the application after completion of the technical deficiency screen, and (c) is not itself a covered registration application, must be assessed 25% of the full registration service fee for the new use application.

(6) Where the action involves approval of a new or amended label, on or before the end date of the decision review time, the Agency shall provide to the applicant a draft accepted label, including any changes made by the Agency that differ from the applicant-submitted label and relevant supporting data reviewed by the Agency. The applicant will notify the Agency that the applicant either (a) agrees to all of the terms associated with the draft accepted label as amended by the Agency and requests that it be issued as the accepted final Agency-stamped label; or (b) does not agree to one or more of the terms of the draft accepted label as amended by the Agency and requests additional time to resolve the difference(s); or (c) withdraws the application without prejudice for subsequent resubmission, but forfeits the associated registration service fee. For cases described in (b), the applicant shall have up to 30 calendar days to reach agreement with the Agency on the final terms of the Agency-accepted label. If the applicant agrees to all of the terms of the accepted label as in (a), including upon resolution of differences in (b), the Agency shall provide an accepted final Agency-stamped label to the registrant within 2 business days following the registrant's written or electronic confirmation of agreement to the Agency.

(3) If EPA data rules are amended to newly require clearance under section 408 of the FFDCA for an ingredient of an antimicrobial product where such ingredient was not previously subject to such a clearance, then review of the data for such clearance of such product is not subject to a registration service fee for the tolerance action for two years from the effective date of the rule.

(4) Any other covered application that is associated with and dependent on the HSRB review will be subject to its separate registration service fee. The decision review times for the associated actions run concurrently, but will end at the date of the latest review time.

(5) *Any other covered application that is associated with and dependent on the SAP review will be subject to its separate registration service fee. The decision review time for the associated action will be extended by the decision review time for the SAP review.*

(6) *An application for a new end-use product using a source of active ingredient that (a) is not yet registered but (b) has an application pending with the Agency for review, will be considered an application for a new product with an unregistered source of active ingredient.*

(7) *Where the action involves approval of a new or amended label, on or before the end date of the decision review time, the Agency shall provide to the applicant a draft accepted label, including any changes made by the Agency that differ from the applicant-submitted label and relevant supporting data reviewed by the Agency. The applicant will notify the Agency that the applicant either (a) agrees to all of the terms associated with the draft accepted label as amended by the Agency and requests that it be issued as the accepted final Agency-stamped label; or (b) does not agree to one or more of the terms of the draft accepted label as amended by the Agency and requests additional time to resolve the difference(s); or (c) withdraws the application without prejudice for subsequent resubmission, but forfeits the associated registration service fee. For cases described in (b), the applicant shall have up to 30 calendar days to reach agreement with the Agency on the final terms of the Agency-accepted label. If the applicant agrees to all of the terms of the accepted label as in (a), including upon resolution of differences in (b), the Agency shall provide an accepted final Agency-stamped label to the registrant within 2 business days following the registrant's written or electronic confirmation of agreement to the Agency.*

(8) *Due to low fee and short time frame this category is not eligible for small business waivers. Gold seal applies to one registered product.*

(9) *This category includes amendments the sole purpose of which is to add DfE (or equivalent terms that do not use "safe" or derivatives of "safe") logos to a label. DfE is a voluntary program. A label bearing a DfE logo is not considered an Agency endorsement because the ingredients in the qualifying product must meet objective, scientific criteria established and widely publicized by EPA."*
