A BILL

To require the Surface Board of Transportation to implement certain recommendations of the Inspector General of the Department of Transportation.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “STB Information Secu-*
5 *rity Improvement Act”.*

6 **SEC. 2. REQUIREMENTS.**

7 *(a) IN GENERAL.—The Surface Transportation Board*
8 *(in this section referred to as the “STB”) shall develop a*
9 *timeline and plan to implement the recommendations of the*
10 *Inspector General of the Department of Transportation in*
11 *Report No. FI2018002, including improvements—*

12 *(1) to identify controls, including risk manage-*
13 *ment, weakness remediation, and security authoriza-*
14 *tion;*

15 *(2) to protect controls, including configuration*
16 *management, user identity and access management,*
17 *and security training;*

18 *(3) to detect controls, including continuous mon-*
19 *itoring;*

20 *(4) to respond controls, including incident han-*
21 *dling and reporting;*

22 *(5) to recover controls for contingency planning;*
23 *and*

24 *(6) any additional tools that will improve the*
25 *implementation of the recommendations.*

1 **(b) IMPLEMENTATION.**—

2 **(1) IN GENERAL.**—*Not later than 180 days after*
3 *the date of enactment of this Act, the STB shall sub-*
4 *mit the plan and timeline developed under subsection*
5 *(a) to the Committee on Transportation and Infra-*
6 *structure of the House of Representatives and the*
7 *Committee on Commerce of the Senate.*

8 **(2) REPORT.**—*The STB shall report annually to*
9 *such Committees on the progress on implementation*
10 *of the recommendations until the implementation is*
11 *complete.*

12 **(3) PLAN IMPLEMENTATION.**—*The STB shall*
13 *designate an individual to implement the plan devel-*
14 *oped under subsection (a).*

15 **SEC. 3. NO ADDITIONAL FUNDS AUTHORIZED.**

16 *No additional funds are authorized to carry out the*
17 *requirements of this Act. Such requirements shall be carried*
18 *out using amounts otherwise authorized.*
