A BILL

To provide for the conveyance of certain National Forest System land within Kisatchie National Forest in the State of Louisiana.

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. SHORT TITLE.
4	This Act may be cited as the "Kisatchie National
5	Forest Land Conveyance Act".
6	SEC. 2. FINDING.
7	Congress finds that it is in the public interest to au-
8	thorize the conveyance of certain Federal land in the
9	Kisatchie National Forest in the State of Louisiana for
10	market value consideration.
11	SEC. 3. DEFINITIONS.
12	In this Act:
13	(1) Collins camp properties.—The term
14	"Collins Camp Properties" means Collins Camp
15	Properties, Inc., a corporation incorporated under
16	the laws of the State.
17	(2) Secretary.—The term "Secretary" means
18	the Secretary of Agriculture.
19	(3) STATE.—The term "State" means the State
20	of Louisiana.
21	SEC. 4. AUTHORIZATION OF CONVEYANCES, KISATCHIE NA-
22	TIONAL FOREST, LOUISIANA.
23	(a) Authorization.—
24	(1) In general.—Subject to valid existing
25	rights and subsection (b), the Secretary may convey

1 the Federal land described in paragraph (2) by quit-2 claim deed at public or private sale, including com-3 petitive sale by auction, bid, or other methods. 4 (2) Description of Land.—The Federal land 5 referred to in paragraph (1) consists of— 6 (A) all Federal land within sec. 9, T. 10 7 N., R. 5 W., Winn Parish, Louisiana; and 8 (B) a 2.16-acre parcel of Federal land lo-9 cated in the SW¹/₄ of sec. 4, T. 10 N., R. 5 W., 10 Winn Parish, Louisiana, as depicted on a cer-11 tificate of survey dated March 7, 2007, by Glen 12 L. Cannon, P.L.S. 4436. 13 (b) First Right of Purchase.—Subject to valid existing rights and section 6, during the 1-year period be-14 15 ginning on the date of enactment of this Act, on the provision of consideration by the Collins Camp Properties to 16 17 the Secretary, the Secretary shall convey, by quitclaim 18 deed, to Collins Camp Properties all right, title and inter-19 est of the United States in and to— 20 (1) not more than 47.92 acres of Federal land 21 comprising the Collins Campsites within sec. 9, T. 22 10 N., R. 5 W., in Winn Parish, Louisiana, as gen-23 erally depicted on a certificate of survey dated Feb-24 ruary 28, 2007, by Glen L. Cannon, P.L.S. 4436; 25 and

1	(2) the parcel of Federal land described in sub-
2	section $(a)(2)(B)$.
3	(c) Terms and Conditions.—The Secretary may—
4	(1) configure the Federal land to be conveyed
5	under this Act—
6	(A) to maximize the marketability of the
7	conveyance; or
8	(B) to achieve management objectives; and
9	(2) establish any terms and conditions for the
10	conveyances under this Act that the Secretary deter-
11	mines to be in the public interest.
12	(d) Consideration.—Consideration for a convey-
13	ance of Federal land under this Act shall be—
14	(1) in the form of cash; and
15	(2) in an amount equal to the market value of
16	the Federal land being conveyed, as determined
17	under subsection (e).
18	(e) Market Value.—The market value of the Fed-
19	eral land conveyed under this Act shall be determined—
20	(1) in the case of Federal land conveyed under
21	subsection (b), by an appraisal that is—
22	(A) conducted in accordance with the Uni-
23	form Appraisal Standards for Federal Land Ac-
24	quisitions; and
25	(B) approved by the Secretary; or

- 1 (2) if conveyed by a method other than the 2 methods described in subsection (b), by competitive 3 sale.
- 4 (f) Hazardous Substances.—
- (1) IN GENERAL.—In any conveyance of Federal land under this Act, the Secretary shall meet disclosure requirements for hazardous substances, but shall otherwise not be required to remediate or abate the substances.
- 10 (2) Effect.—Nothing in this section otherwise 11 affects the application of the Comprehensive Envi-12 ronmental Response, Compensation, and Liability 13 Act of 1980 (42 U.S.C. 9601 et seq.) to the convey-14 ances of Federal land.

15 SEC. 5. PROCEEDS FROM THE SALE OF LAND.

- 16 The Secretary shall deposit the proceeds of a convey-
- 17 ance of Federal land under section 4 in the fund estab-
- 18 lished under Public Law 90–171 (commonly known as the
- 19 "Sisk Act") (16 U.S.C. 484a).

20 SEC. 6. ADMINISTRATION.

- 21 (a) Costs.—As a condition of a conveyance of Fed-
- 22 eral land to Collins Camp Properties under section 4, the
- 23 Secretary shall require Collins Camp Properties to pay at
- 24 closing—
- 25 (1) reasonable appraisal costs; and

1 (2) the cost of any administrative and environ-2 mental analyses required by law (including regula-3 tions).

(b) Permits.—

- (1) In General.—An offer by Collins Camp Properties for the acquisition of the Federal land under section 4 shall be accompanied by a written statement from each holder of a Forest Service special use authorization with respect to the Federal land that specifies that the holder agrees to relinquish the special use authorization on the conveyance of the Federal land to Collins Camp Properties.
- (2) Special use authorizations.—If any holder of a special use authorization described in paragraph (1) fails to provide a written authorization in accordance with that paragraph, the Secretary shall require, as a condition of the conveyance, that Collins Camp Properties administer the special use authorization according to the terms of the special use authorization until the date on which the special use authorization expires.
