AN ACT

Making appropriations for the Department of Defense for the fiscal year ending September 30, 2005, and for other purposes.

MILITARY PERSONNEL

~~MILITARY PERSONNEL, ARMY~~

For pay, allowances, individual clothing, subsistence, interest on deposits, gratuities, permanent change of station travel (including all expenses thereof for organizational movements), and expenses of temporary duty travel between permanent duty stations, for members of the Army on active duty, (except members of reserve components provided for elsewhere), cadets, and aviation cadets; and for payments pursuant to section 156 of Public Law 97-377, as amended (42 U.S.C. 402 note), and to the Department of Defense Military Retirement Fund, \$29,507,672,000.

~~MILITARY PERSONNEL, NAVY~~

For pay, allowances, individual clothing, subsistence, interest on deposits, gratuities, permanent change of station travel (including all expenses thereof for organizational movements), and expenses of temporary duty travel between permanent duty stations, for members of the Navy on active duty (except members of the Reserve provided for elsewhere), midshipmen, and aviation cadets; and for payments pursuant to section 156 of Public Law 97-377, as amended (42 U.S.C. 402 note), and to the Depart-

1 ment of Defense Military Retirement Fund,
2 \$24,416,157,000.

3 MILITARY PERSONNEL, MARINE CORPS

4 For pay, allowances, individual clothing, subsistence,
5 interest on deposits, gratuities, permanent change of sta-
6 tion travel (including all expenses thereof for organiza-
7 tional movements), and expenses of temporary duty travel
8 between permanent duty stations, for members of the Ma-
9 rine Corps on active duty (except members of the Reserve
10 provided for elsewhere); and for payments pursuant to sec-
11 tion 156 of Public Law 97-377, as amended (42 U.S.C.
12 402 note); and to the Department of Defense Military Re-
13 tirement Fund, \$9,591,102,000.

14 MILITARY PERSONNEL, AIR FORCE

15 For pay, allowances, individual clothing, subsistence,
16 interest on deposits, gratuities, permanent change of sta-
17 tion travel (including all expenses thereof for organiza-
18 tional movements), and expenses of temporary duty travel
19 between permanent duty stations, for members of the Air
20 Force on active duty (except members of reserve compo-
21 nents provided for elsewhere), cadets, and aviation cadets;
22 and for payments pursuant to section 156 of Public Law
23 97-377, as amended (42 U.S.C. 402 note); and to the De-
24 partment of Defense Military Retirement Fund,
25 \$24,291,411,000.

1 RESERVE PERSONNEL, ARMY

2 For pay, allowances, clothing, subsistence, gratuities,
3 travel, and related expenses for personnel of the Army Re-
4 serve on active duty under sections 10211, 10302, and
5 3038 of title 10, United States Code, or while serving on
6 active duty under section 12301(d) of title 10, United
7 States Code, in connection with performing duty specified
8 in section 12310(a) of title 10, United States Code, or
9 while undergoing reserve training, or while performing
10 drills or equivalent duty or other duty, and for members
11 of the Reserve Officers' Training Corps, and expenses au-
12 thorized by section 16131 of title 10, United States Code;
13 and for payments to the Department of Defense Military
14 Retirement Fund, \$3,719,990,000.

15 RESERVE PERSONNEL, NAVY

16 For pay, allowances, clothing, subsistence, gratuities,
17 travel, and related expenses for personnel of the Navy Re-
18 serve on active duty under section 10211 of title 10,
19 United States Code, or while serving on active duty under
20 section 12301(d) of title 10, United States Code, in con-
21 nection with performing duty specified in section 12310(a)
22 of title 10, United States Code, or while undergoing re-
23 serve training, or while performing drills or equivalent
24 duty, and for members of the Reserve Officers' Training
25 Corps, and expenses authorized by section 16131 of title

1 10, United States Code; and for payments to the Depart-
2 ment of Defense Military Retirement Fund,
3 \$2,108,232,000.

4 RESERVE PERSONNEL, MARINE CORPS

5 For pay, allowances, clothing, subsistence, gratuities,
6 travel, and related expenses for personnel of the Marine
7 Corps Reserve on active duty under section 10211 of title
8 10, United States Code, or while serving on active duty
9 under section 12301(d) of title 10, United States Code,
10 in connection with performing duty specified in section
11 12310(a) of title 10, United States Code, or while under-
12 going reserve training, or while performing drills or equiv-
13 alent duty, and for members of the Marine Corps platoon
14 leaders class, and expenses authorized by section 16131
15 of title 10, United States Code; and for payments to the
16 Department of Defense Military Retirement Fund,
17 \$653,073,000.

18 RESERVE PERSONNEL, AIR FORCE

19 For pay, allowances, clothing, subsistence, gratuities,
20 travel, and related expenses for personnel of the Air Force
21 Reserve on active duty under sections 10211, 10305, and
22 8038 of title 10, United States Code, or while serving on
23 active duty under section 12301(d) of title 10, United
24 States Code, in connection with performing duty specified
25 in section 12310(a) of title 10, United States Code, or

1 while undergoing reserve training, or while performing
2 drills or equivalent duty or other duty, and for members
3 of the Air Reserve Officers' Training Corps, and expenses
4 authorized by section ~~16131~~ of title 10, United States
5 Code; and for payments to the Department of Defense
6 Military Retirement Fund, \$1,451,950,000.

7 NATIONAL GUARD PERSONNEL, ARMY

8 For pay, allowances, clothing, subsistence, gratuities,
9 travel, and related expenses for personnel of the Army Na-
10 tional Guard while on duty under section ~~10211~~, ~~10302~~,
11 or ~~12402~~ of title 10 or section 708 of title 32, United
12 States Code; or while serving on duty under section
13 ~~12301(d)~~ of title 10 or section 502(f) of title 32, United
14 States Code; in connection with performing duty specified
15 in section ~~12310(a)~~ of title 10, United States Code; or
16 while undergoing training, or while performing drills or
17 equivalent duty or other duty, and expenses authorized by
18 section ~~16131~~ of title 10, United States Code; and for pay-
19 ments to the Department of Defense Military Retirement
20 Fund, \$5,915,229,000.

21 NATIONAL GUARD PERSONNEL, AIR FORCE

22 For pay, allowances, clothing, subsistence, gratuities,
23 travel, and related expenses for personnel of the Air Na-
24 tional Guard on duty under section ~~10211~~, ~~10305~~, or
25 ~~12402~~ of title 10 or section 708 of title 32, United States

1 Code, or while serving on duty under section 12301(d) of
 2 title 10 or section 502(f) of title 32, United States Code,
 3 in connection with performing duty specified in section
 4 12310(a) of title 10, United States Code, or while under-
 5 going training, or while performing drills or equivalent
 6 duty or other duty, and expenses authorized by section
 7 16131 of title 10, United States Code; and for payments
 8 to the Department of Defense Military Retirement Fund,
 9 \$2,536,742,000.

OPERATION AND MAINTENANCE

OPERATION AND MAINTENANCE, ARMY

13

(INCLUDING TRANSFER OF FUNDS)

14

For expenses, not otherwise provided for, necessary
 15 for the operation and maintenance of the Army, as author-
 16 ized by law; and not to exceed \$11,144,000 can be used
 17 for emergencies and extraordinary expenses, to be ex-
 18 pended on the approval or authority of the Secretary of
 19 the Army, and payments may be made on his certificate
 20 of necessity for confidential military purposes,
 21 \$25,820,311,000: *Provided*, That of the funds appro-
 22 priated in this paragraph, not less than \$355,000,000
 23 shall be made available only for conventional ammunition
 24 care and maintenance: *Provided further*, That of funds
 25 made available under this heading, \$2,500,000 shall be

1 available for Fort Baker, in accordance with the terms and
2 conditions as provided under the heading “Operation and
3 Maintenance, Army”, in Public Law 107–117.

4 OPERATION AND MAINTENANCE, NAVY

5 For expenses, not otherwise provided for, necessary
6 for the operation and maintenance of the Navy and the
7 Marine Corps, as authorized by law; and not to exceed
8 \$4,525,000 can be used for emergencies and extraordinary
9 expenses; to be expended on the approval or authority of
10 the Secretary of the Navy, and payments may be made
11 on his certificate of necessity for confidential military pur-
12 poses, \$29,570,090,000.

13 OPERATION AND MAINTENANCE, MARINE CORPS

14 For expenses, not otherwise provided for, necessary
15 for the operation and maintenance of the Marine Corps,
16 as authorized by law, \$3,605,815,000.

17 OPERATION AND MAINTENANCE, AIR FORCE

18 For expenses, not otherwise provided for, necessary
19 for the operation and maintenance of the Air Force, as
20 authorized by law; and not to exceed \$7,699,000 can be
21 used for emergencies and extraordinary expenses; to be ex-
22 pended on the approval or authority of the Secretary of
23 the Air Force, and payments may be made on his certifi-
24 cate of necessity for confidential military purposes,
25 \$27,994,110,000: *Provided*, That notwithstanding any

1 other provision of law, that of the funds available under
2 this heading, \$750,000 shall only be available to the Sec-
3 retary of the Air Force for a grant to Florida Memorial
4 College for the purpose of funding minority aviation train-
5 ing.

6 OPERATION AND MAINTENANCE, DEFENSE-WIDE

7 (INCLUDING TRANSFER OF FUNDS)

8 For expenses, not otherwise provided for, necessary
9 for the operation and maintenance of activities and agen-
10 cies of the Department of Defense (other than the military
11 departments), as authorized by law, \$17,346,411,000, of
12 which not to exceed \$25,000,000 may be available for the
13 Combatant Commander Initiative Fund; and of which not
14 to exceed \$40,000,000 can be used for emergencies and
15 extraordinary expenses, to be expended on the approval
16 or authority of the Secretary of Defense, and payments
17 may be made on his certificate of necessity for confidential
18 military purposes: *Provided*, That notwithstanding any
19 other provision of law, of the funds provided in this Act
20 for Civil Military programs under this heading, \$500,000
21 shall be available for a grant for Outdoor Odyssey, Roar-
22 ing Run, Pennsylvania, to support the Youth Development
23 and Leadership program and Department of Defense
24 STARBASE program: *Provided further*, That of the funds
25 made available under this heading, \$3,000,000 shall be

1 available only for a Washington-based internship and im-
2 mersion program to allow U.S. Asian-American Pacific Is-
3 lander undergraduate college and university students from
4 economically disadvantaged backgrounds to participate in
5 academic and educational programs in the Department of
6 Defense and related Federal defense agencies: *Provided*
7 *further*, That none of the funds appropriated or otherwise
8 made available by this Act may be used to plan or imple-
9 ment the consolidation of a budget or appropriations liai-
10 son office of the Office of the Secretary of Defense, the
11 office of the Secretary of a military department, or the
12 service headquarters of one of the Armed Forces into a
13 legislative affairs or legislative liaison office: *Provided fur-*
14 *ther*, That \$4,000,000, to remain available until expended,
15 is available only for expenses relating to certain classified
16 activities, and may be transferred as necessary by the Sec-
17 retary to operation and maintenance appropriations or re-
18 search, development, test and evaluation appropriations,
19 to be merged with and to be available for the same time
20 period as the appropriations to which transferred: *Pro-*
21 *vided further*, That any ceiling on the investment item unit
22 cost of items that may be purchased with operation and
23 maintenance funds shall not apply to the funds described
24 in the preceding proviso: *Provided further*, That the trans-
25 fer authority provided under this heading is in addition

1 to any other transfer authority provided elsewhere in this
2 Act.

3 OPERATION AND MAINTENANCE, ARMY RESERVE

4 For expenses, not otherwise provided for, necessary
5 for the operation and maintenance, including training, or-
6 ganization, and administration, of the Army Reserve; re-
7 pair of facilities and equipment; hire of passenger motor
8 vehicles; travel and transportation; care of the dead; re-
9 cruiting; procurement of services, supplies, and equip-
10 ment; and communications, \$1,976,128,000.

11 OPERATION AND MAINTENANCE, NAVY RESERVE

12 For expenses, not otherwise provided for, necessary
13 for the operation and maintenance, including training, or-
14 ganization, and administration, of the Navy Reserve; re-
15 pair of facilities and equipment; hire of passenger motor
16 vehicles; travel and transportation; care of the dead; re-
17 cruiting; procurement of services, supplies, and equip-
18 ment; and communications, \$1,233,038,000.

19 OPERATION AND MAINTENANCE, MARINE CORPS
20 RESERVE

21 For expenses, not otherwise provided for, necessary
22 for the operation and maintenance, including training, or-
23 ganization, and administration, of the Marine Corps Re-
24 serve; repair of facilities and equipment; hire of passenger
25 motor vehicles; travel and transportation; care of the dead;

1 recruiting; procurement of services, supplies, and equip-
2 ment; and communications, \$187,196,000.

3 OPERATION AND MAINTENANCE, AIR FORCE RESERVE

4 For expenses, not otherwise provided for, necessary
5 for the operation and maintenance, including training, or-
6 ganization, and administration, of the Air Force Reserve;
7 repair of facilities and equipment; hire of passenger motor
8 vehicles; travel and transportation; care of the dead; re-
9 cruiting; procurement of services, supplies, and equip-
10 ment; and communications, \$2,227,190,000.

11 OPERATION AND MAINTENANCE, ARMY NATIONAL

12 GUARD

13 For expenses of training, organizing, and admin-
14 istering the Army National Guard, including medical and
15 hospital treatment and related expenses in non-Federal
16 hospitals; maintenance, operation, and repairs to struc-
17 tures and facilities; hire of passenger motor vehicles; per-
18 sonnel services in the National Guard Bureau; travel ex-
19 penses (other than mileage), as authorized by law for
20 Army personnel on active duty, for Army National Guard
21 division, regimental, and battalion commanders while in-
22 specting units in compliance with National Guard Bureau
23 regulations when specifically authorized by the Chief, Na-
24 tional Guard Bureau; supplying and equipping the Army
25 National Guard as authorized by law; and expenses of re-

1 pair; modification, maintenance, and issue of supplies and
 2 equipment (including aircraft), \$4,376,886,000.

3 OPERATION AND MAINTENANCE, AIR NATIONAL GUARD

4 For expenses of training, organizing, and admin-
 5 istering the Air National Guard, including medical and
 6 hospital treatment and related expenses in non-Federal
 7 hospitals; maintenance, operation, and repairs to struc-
 8 tures and facilities; transportation of things, hire of pas-
 9 senger motor vehicles; supplying and equipping the Air
 10 National Guard, as authorized by law; expenses for repair,
 11 modification, maintenance, and issue of supplies and
 12 equipment, including those furnished from stocks under
 13 the control of agencies of the Department of Defense;
 14 travel expenses (other than mileage) on the same basis as
 15 authorized by law for Air National Guard personnel on
 16 active Federal duty, for Air National Guard commanders
 17 while inspecting units in compliance with National Guard
 18 Bureau regulations when specifically authorized by the
 19 Chief, National Guard Bureau, \$4,438,738,000.

20 OVERSEAS CONTINGENCY OPERATIONS TRANSFER

21 ACCOUNT

22 (INCLUDING TRANSFER OF FUNDS)

23 For expenses directly relating to Overseas Contin-
 24 gency Operations by United States military forces,
 25 \$5,000,000, to remain available until expended: *Provided,*

1 That the Secretary of Defense may transfer these funds
2 only to military personnel accounts; operation and mainte-
3 nance accounts within this title; the Defense Health Pro-
4 gram appropriation; procurement accounts; research, de-
5 velopment, test and evaluation accounts; and to working
6 capital funds: *Provided further*, That the funds transferred
7 shall be merged with and shall be available for the same
8 purposes and for the same time period, as the appropria-
9 tion to which transferred: *Provided further*, That upon a
10 determination that all or part of the funds transferred
11 from this appropriation are not necessary for the purposes
12 provided herein, such amounts may be transferred back
13 to this appropriation: *Provided further*, That the transfer
14 authority provided in this paragraph is in addition to any
15 other transfer authority contained elsewhere in this Act.

16 UNITED STATES COURT OF APPEALS FOR THE ARMED
17 FORCES

18 For salaries and expenses necessary for the United
19 States Court of Appeals for the Armed Forces,
20 \$10,825,000, of which not to exceed \$5,000 may be used
21 for official representation purposes.

22 ENVIRONMENTAL RESTORATION, ARMY
23 (INCLUDING TRANSFER OF FUNDS)

24 For the Department of the Army, \$400,948,000, to
25 remain available until transferred: *Provided*, That the Sec-

1 retary of the Army shall, upon determining that such
2 funds are required for environmental restoration, reduc-
3 tion and recycling of hazardous waste, removal of unsafe
4 buildings and debris of the Department of the Army, or
5 for similar purposes, transfer the funds made available by
6 this appropriation to other appropriations made available
7 to the Department of the Army, to be merged with and
8 to be available for the same purposes and for the same
9 time period as the appropriations to which transferred:
10 *Provided further*, That upon a determination that all or
11 part of the funds transferred from this appropriation are
12 not necessary for the purposes provided herein, such
13 amounts may be transferred back to this appropriation.

14 ENVIRONMENTAL RESTORATION, NAVY

15 (INCLUDING TRANSFER OF FUNDS)

16 For the Department of the Navy, \$266,820,000, to
17 remain available until transferred: *Provided*, That the Sec-
18 retary of the Navy shall, upon determining that such
19 funds are required for environmental restoration, reduc-
20 tion and recycling of hazardous waste, removal of unsafe
21 buildings and debris of the Department of the Navy, or
22 for similar purposes, transfer the funds made available by
23 this appropriation to other appropriations made available
24 to the Department of the Navy, to be merged with and
25 to be available for the same purposes and for the same

1 time period as the appropriations to which transferred:
2 *Provided further*, That upon a determination that all or
3 part of the funds transferred from this appropriation are
4 not necessary for the purposes provided herein, such
5 amounts may be transferred back to this appropriation.

6 ENVIRONMENTAL RESTORATION, AIR FORCE

7 (INCLUDING TRANSFER OF FUNDS)

8 For the Department of the Air Force, \$397,368,000,
9 to remain available until transferred: *Provided*, That the
10 Secretary of the Air Force shall, upon determining that
11 such funds are required for environmental restoration, re-
12 duction and recycling of hazardous waste, removal of un-
13 safe buildings and debris of the Department of the Air
14 Force, or for similar purposes, transfer the funds made
15 available by this appropriation to other appropriations
16 made available to the Department of the Air Force, to be
17 merged with and to be available for the same purposes
18 and for the same time period as the appropriations to
19 which transferred: *Provided further*, That upon a deter-
20 mination that all or part of the funds transferred from
21 this appropriation are not necessary for the purposes pro-
22 vided herein, such amounts may be transferred back to
23 this appropriation.

1 ENVIRONMENTAL RESTORATION, DEFENSE-WIDE

2 (INCLUDING TRANSFER OF FUNDS)

3 For the Department of Defense, \$26,684,000, to re-
4 main available until transferred: *Provided*, That the Sec-
5 retary of Defense shall, upon determining that such funds
6 are required for environmental restoration, reduction and
7 recycling of hazardous waste, removal of unsafe buildings
8 and debris of the Department of Defense, or for similar
9 purposes, transfer the funds made available by this appro-
10 priation to other appropriations made available to the De-
11 partment of Defense, to be merged with and to be avail-
12 able for the same purposes and for the same time period
13 as the appropriations to which transferred: *Provided fur-*
14 *ther*, That upon a determination that all or part of the
15 funds transferred from this appropriation are not nec-
16 essary for the purposes provided herein, such amounts
17 may be transferred back to this appropriation.

18 ENVIRONMENTAL RESTORATION, FORMERLY USED

19 DEFENSE SITES

20 (INCLUDING TRANSFER OF FUNDS)

21 For the Department of the Army, \$216,516,000, to
22 remain available until transferred: *Provided*, That the Sec-
23 retary of the Army shall, upon determining that such
24 funds are required for environmental restoration, reduc-
25 tion and recycling of hazardous waste, removal of unsafe

1 buildings and debris at sites formerly used by the Depart-
2 ment of Defense, transfer the funds made available by this
3 appropriation to other appropriations made available to
4 the Department of the Army, to be merged with and to
5 be available for the same purposes and for the same time
6 period as the appropriations to which transferred: *Pro-*
7 *vided further*, That upon a determination that all or part
8 of the funds transferred from this appropriation are not
9 necessary for the purposes provided herein, such amounts
10 may be transferred back to this appropriation.

11 OVERSEAS HUMANITARIAN, DISASTER, AND CIVIC AID

12 For expenses relating to the Overseas Humanitarian,
13 Disaster, and Civic Aid programs of the Department of
14 Defense (consisting of the programs provided under sec-
15 tions 401, 402, 404, 2557, and 2561 of title 10, United
16 States Code), \$59,000,000, to remain available until Sep-
17 tember 30, 2006.

18 FORMER SOVIET UNION THREAT REDUCTION ACCOUNT

19 For assistance to the republics of the former Soviet
20 Union, including assistance provided by contract or by
21 grants, for facilitating the elimination and the safe and
22 secure transportation and storage of nuclear, chemical and
23 other weapons; for establishing programs to prevent the
24 proliferation of weapons, weapons components, and weap-
25 on-related technology and expertise; for programs relating

1 to the training and support of defense and military per-
2 sonnel for demilitarization and protection of weapons,
3 weapons components and weapons technology and exper-
4 tise, and for defense and military contacts, \$409,200,000,
5 to remain available until September 30, 2007.

6 TITLE III

8 AIRCRAFT PROCUREMENT, ARMY

9 For construction, procurement, production, modifica-
10 tion, and modernization of aircraft, equipment, including
11 ordnance, ground handling equipment, spare parts, and
12 accessories therefor; specialized equipment and training
13 devices; expansion of public and private plants, including
14 the land necessary therefor, for the foregoing purposes,
15 and such lands and interests therein, may be acquired,
16 and construction prosecuted thereon prior to approval of
17 title; and procurement and installation of equipment, ap-
18 pliances, and machine tools in public and private plants;
19 reserve plant and Government and contractor-owned
20 equipment layaway; and other expenses necessary for the
21 foregoing purposes, \$3,107,941,000, to remain available
22 for obligation until September 30, 2007, of which
23 \$320,600,000 shall be for the Army National Guard and
24 Army Reserve.

1 MISSILE PROCUREMENT, ARMY

2 For construction, procurement, production, modifica-
3 tion, and modernization of missiles, equipment, including
4 ordnance, ground handling equipment, spare parts, and
5 accessories therefor; specialized equipment and training
6 devices; expansion of public and private plants, including
7 the land necessary therefor, for the foregoing purposes,
8 and such lands and interests therein, may be acquired,
9 and construction prosecuted thereon prior to approval of
10 title; and procurement and installation of equipment, ap-
11 pliances, and machine tools in public and private plants;
12 reserve plant and Government and contractor-owned
13 equipment layaway; and other expenses necessary for the
14 foregoing purposes, \$1,327,000,000, to remain available
15 for obligation until September 30, 2007, of which
16 \$29,400,000 shall be for the Army National Guard and
17 Army Reserve.

18 PROCUREMENT OF WEAPONS AND TRACKED COMBAT

19 VEHICLES, ARMY

20 For construction, procurement, production, and
21 modification of weapons and tracked combat vehicles,
22 equipment, including ordnance, spare parts, and acces-
23 sories therefor; specialized equipment and training devices;
24 expansion of public and private plants, including the land
25 necessary therefor, for the foregoing purposes, and such

1 lands and interests therein, may be acquired, and con-
2 struction prosecuted thereon prior to approval of title; and
3 procurement and installation of equipment, appliances,
4 and machine tools in public and private plants; reserve
5 plant and Government and contractor-owned equipment
6 layaway; and other expenses necessary for the foregoing
7 purposes, \$2,773,695,000, to remain available for obliga-
8 tion until September 30, 2007, of which \$13,700,000 shall
9 be for the Army National Guard and Army Reserve.

10 PROCUREMENT OF AMMUNITION, ARMY

11 For construction, procurement, production, and
12 modification of ammunition, and accessories therefor; spe-
13 cialized equipment and training devices; expansion of pub-

(TRANSFER OF FUNDS)

6 military personnel appropriations shall not be taken into
7 account for purposes of the limitation on the amount of
8 funds that may be transferred under this section.

10 SEC. 8006. During the current fiscal year, cash bal-
11 ances in working capital funds of the Department of De-
12 fense established pursuant to section 2208 of title 10,
13 United States Code, may be maintained in only such
14 amounts as are necessary at any time for cash disburse-
15 ments to be made from such funds: *Provided*, That trans-
16 fers may be made between such funds: *Provided further*,
17 That transfers may be made between working capital
18 funds and the “Foreign Currency Fluctuations, Defense”
19 appropriation and the “Operation and Maintenance” ap-
20 propriation accounts in such amounts as may be deter-
21 mined by the Secretary of Defense, with the approval of
22 the Office of Management and Budget, except that such
23 transfers may not be made unless the Secretary of Defense
24 has notified the Congress of the proposed transfer. Except
25 in amounts equal to the amounts appropriated to working

1 capital funds in this Act, no obligations may be made
2 against a working capital fund to procure or increase the
3 value of war reserve material inventory, unless the Sec-
4 retary of Defense has notified the Congress prior to any
5 such obligation.

6 SEC. 8007. Funds appropriated by this Act may not
7 be used to initiate a special access program without prior
8 notification 30 calendar days in session in advance to the
9 congressional defense committees.

10 SEC. 8008. None of the funds provided in this Act
11 shall be available to initiate: (1) a multiyear contract that
12 employs economic order quantity procurement in excess of
13 \$20,000,000 in any 1 year of the contract or that includes
14 an unfunded contingent liability in excess of \$20,000,000;
15 or (2) a contract for advance procurement leading to a
16 multiyear contract that employs economic order quantity
17 procurement in excess of \$20,000,000 in any 1 year, un-
18 less the congressional defense committees have been noti-
19 fied at least 30 days in advance of the proposed contract
20 award: *Provided*, That no part of any appropriation con-
21 tained in this Act shall be available to initiate a multiyear

10 *Provided further*, That none of the funds provided in this
11 Act may be used for a multiyear contract executed after

13 of any such contract—

14 (1) the Secretary of Defense has submitted to

17 (2) cancellation provisions in the contract do
18 not include consideration of recurring manufacturing

7 SEC. 8009. Within the funds appropriated for the op-
8 eration and maintenance of the Armed Forces, funds are
9 hereby appropriated pursuant to section 401 of title 10,
10 United States Code, for humanitarian and civic assistance
11 costs under chapter 20 of title 10, United States Code.
12 Such funds may also be obligated for humanitarian and
13 civic assistance costs incidental to authorized operations

12 Benefits Fund when time spent as a full-time student is
13 credited toward completion of a service commitment: *Pro-*
14 *vided*, That this subsection shall not apply to those mem-
15 bers who have reenlisted with this option prior to October
16 1, 1987: *Provided further*, That this subsection applies
17 only to active components of the Army.

18 SEC. 8014. (a) LIMITATION ON CONVERSION TO

20 reciprocal defense procurement memorandum of under-
21 standing, between the United States and a foreign country
22 pursuant to which the Secretary of Defense has prospec-
23 tively waived the Buy American Act for certain products
24 in that country.

1 (b) The Secretary of Defense shall submit to the Con-
2 gress a report on the amount of Department of Defense
3 purchases from foreign entities in fiscal year 2005. Such
4 report shall separately indicate the dollar value of items
5 for which the Buy American Act was waived pursuant to
6 any agreement described in subsection (a)(2), the Trade
7 Agreement Act of 1979 (19 U.S.C. 2501 et seq.), or any
8 international agreement to which the United States is a
9 party.

10 (c) For purposes of this section, the term “Buy
11 American Act” means title III of the Act entitled “An Act
12 making appropriations for the Treasury and Post Office
13 Departments for the fiscal year ending June 30, 1934,
14 and for other purposes”, approved March 3, 1933 (41

16 SEC. 8033. Appropriations contained in this Act that

4 be available until expended for the payments specified by
5 section 2921(e)(2) of that Act.

6 SEC. 8038. (a) IN GENERAL.—Notwithstanding any
7 other provision of law, the Secretary of the Air Force may

2 term “Indian tribe” means any recognized Indian tribe in-
3 cluded on the current list published by the Secretary of
4 the Interior under section 104 of the Federally Recognized
5 Indian Tribe Act of 1994 (Public Law 103–454, 108 Stat.
6 4792; 25 U.S.C. 479a–1).

7 SEC. 8039. During the current fiscal year, appropria-
8 tions which are available to the Department of Defense
9 for operation and maintenance may be used to purchase
10 items having an investment item unit cost of not more

12 SEC. 8040. (a) During the current fiscal year, none
13 of the appropriations or funds available to the Department
14 of Defense Working Capital Funds shall be used for the
15 purchase of an investment item for the purpose of acquir-
16 ing a new inventory item for sale or anticipated sale dur-
17 ing the current fiscal year or a subsequent fiscal year to

1 (b) The fiscal year 2006 budget request for the De-

3 and other documentation supporting the fiscal year 2006
4 Department of Defense budget shall be prepared and sub-
5 mitted to the Congress on the basis that any equipment
6 which was classified as an end item and funded in a pro-
7 curement appropriation contained in this Act shall be
8 budgeted for in a proposed fiscal year 2006 procurement
9 appropriation and not in the supply management business

19 tions: *Provided further*, That at Landstuhl Army Regional
20 Medical Center and Ramstein Air Base, furnished heat
21 may be obtained from private, regional or municipal serv-
22 ices, if provisions are included for the consideration of
23 United States coal as an energy source.

24 SEC. 8070. None of the funds appropriated in title
25 IV of this Act may be used to procure end-items for deliv-

1 ery to military forces for operational training, operational
2 use or inventory requirements: *Provided*, That this restric-
3 tion does not apply to end-items used in development,
4 prototyping, and test activities preceding and leading to
5 acceptance for operational use: *Provided further*, That this
6 restriction does not apply to programs funded within the
7 National Foreign Intelligence Program: *Provided further*,
8 That the Secretary of Defense may waive this restriction
9 on a case-by-case basis by certifying in writing to the
10 Committees on Appropriations of the House of Represent-
11 atives and the Senate that it is in the national security
12 interest to do so.

13 SEC. 8071. None of the funds made available in this
14 Act may be used to approve or license the sale of the F-
15 22 advanced tactical fighter to any foreign government.

16 SEC. 8072. (a) The Secretary of Defense may, on a
17 case-by-case basis, waive with respect to a foreign country
18 each limitation on the procurement of defense items from
19 foreign sources provided in law if the Secretary determines
20 that the application of the limitation with respect to that
21 country would invalidate cooperative programs entered
22 into between the Department of Defense and the foreign
23 country, or would invalidate reciprocal trade agreements
24 for the procurement of defense items entered into under
25 section 2531 of title 10, United States Code, and the

1 country does not discriminate against the same or similar
2 defense items produced in the United States for that coun-
3 try.

4 (b) Subsection (a) applies with respect to—

5 (1) contracts and subcontracts entered into on
6 or after the date of the enactment of this Act; and

7 (2) options for the procurement of items that
8 are exercised after such date under contracts that
9 are entered into before such date if the option prices
10 are adjusted for any reason other than the applica-
11 tion of a waiver granted under subsection (a).

12 (c) Subsection (a) does not apply to a limitation re-
13 garding construction of public vessels, ball and roller bear-
14 ings, food, and clothing or textile materials as defined by
15 section 11 (chapters 50–65) of the Harmonized Tariff
16 Schedule and products classified under headings 4010,
17 4202, 4203, 6401 through 6406, 6505, 7019, 7218
18 through 7229, 7304.41 through 7304.49, 7306.40, 7502
19 through 7508, 8105, 8108, 8109, 8211, 8215, and 9404.

20 ~~SEC. 8073.~~ (a) PROHIBITION.—None of the funds
21 made available by this Act may be used to support any
22 training program involving a unit of the security forces
23 of a foreign country if the Secretary of Defense has re-
24 ceived credible information from the Department of State
25 that the unit has committed a gross violation of human

1 rights, unless all necessary corrective steps have been
2 taken.

3 (b) MONITORING.—The Secretary of Defense, in con-
4 sultation with the Secretary of State, shall ensure that
5 prior to a decision to conduct any training program re-
6 ferred to in subsection (a), full consideration is given to
7 all credible information available to the Department of
8 State relating to human rights violations by foreign secu-
9 rity forces.

10 (c) WAIVER.—The Secretary of Defense, after con-
11 sultation with the Secretary of State, may waive the prohi-
12 bition in subsection (a) if he determines that such waiver
13 is required by extraordinary circumstances.

14 (d) REPORT.—Not more than 15 days after the exer-
15 cise of any waiver under subsection (c), the Secretary of
16 Defense shall submit a report to the congressional defense
17 committees describing the extraordinary circumstances,
18 the purpose and duration of the training program, the
19 United States forces and the foreign security forces in-
20 volved in the training program, and the information relat-
21 ing to human rights violations that necessitates the waiv-
22 er.

23 SEC. 8074. The Secretary of Defense, in coordination
24 with the Secretary of Health and Human Services, may
25 carry out a program to distribute surplus dental equip-

1 ment of the Department of Defense, at no cost to the De-
2 partment of Defense, to Indian Health Service facilities
3 and to federally-qualified health centers (within the mean-
4 ing of section 1905(1)(2)(B) of the Social Security Act (42
5 U.S.C. 1396d(1)(2)(B))).

6 SEC. 8075. None of the funds appropriated or made
7 available in this Act to the Department of the Navy shall
8 be used to develop, lease or procure the T-AKE class of
9 ships unless the main propulsion diesel engines and
10 propulsors are manufactured in the United States by a
11 domestically operated entity: *Provided*, That the Secretary
12 of Defense may waive this restriction on a case-by-case
13 basis by certifying in writing to the Committees on Appro-
14 priations of the House of Representatives and the Senate
15 that adequate domestic supplies are not available to meet

1 units that may be used for the purpose of conducting offi-

3 SEC. 8077. Notwithstanding any other provision of
4 law, funds appropriated in this Act under the heading
5 “Research, Development, Test and Evaluation, Defense-
6 Wide” for any advanced concept technology demonstration
7 project may only be obligated 30 days after a report, in-
8 cluding a description of the project, the planned acquisi-
9 tion and transition strategy and its estimated annual and
10 total cost, has been provided in writing to the congress-
11 sional defense committees: *Provided*, That the Secretary
12 of Defense may waive this restriction on a case-by-case
13 basis by certifying to the congressional defense committees
14 that it is in the national interest to do so.

15 SEC. 8078. The Secretary of Defense shall provide
16 a classified quarterly report, beginning December 15,
17 2004, to the House and Senate Appropriations Commit-
18 tees, Subcommittees on Defense on certain matters as di-
19 rected in the classified annex accompanying this Act.

20 SEC. 8079. During the current fiscal year and here-
21 after, refunds attributable to the use of the Government

4 SEC. 8080. (a) REGISTERING FINANCIAL MANAGE-
5 MENT INFORMATION TECHNOLOGY SYSTEMS WITH DOD
6 CHIEF INFORMATION OFFICER.—None of the funds ap-
7 propriated in this Act may be used for a mission critical
8 or mission essential financial management information
9 technology system (including a system funded by the de-
10 fense working capital fund) that is not registered with the
11 Chief Information Officer of the Department of Defense.
12 A system shall be considered to be registered with that
13 officer upon the furnishing to that officer of notice of the
14 system, together with such information concerning the
15 system as the Secretary of Defense may prescribe. A fi-
16 nancial management information technology system shall
17 be considered a mission critical or mission essential infor-

19 retary of Defense (Comptroller).

20 (b) CERTIFICATIONS AS TO COMPLIANCE WITH FI-
21 NANCIAL MANAGEMENT MODERNIZATION PLAN.—

22 (1) During the current fiscal year, a financial
23 management automated information system, a mixed
24 information system supporting financial and non-fi-
25 nancial systems, or a system improvement of more

1 than \$1,000,000 may not receive Milestone A ap-
2 proval, Milestone B approval, or full rate production,
3 or their equivalent, within the Department of De-
4 fense until the Under Secretary of Defense (Comp-
5 troller) certifies, with respect to that milestone, that
6 the system is being developed and managed in ac-
7 cordance with the Department's Financial Manage-
8 ment Modernization Plan. The Under Secretary of
9 Defense (Comptroller) may require additional certifi-
10 cations, as appropriate, with respect to any such sys-
11 tem.

12 (2) The Chief Information Officer shall provide
13 the congressional defense committees timely notifica-
14 tion of certifications under paragraph (1).

15 (c) CERTIFICATIONS AS TO COMPLIANCE WITH
16 CLINGER-COHEN ACT.—

17 (1) During the current fiscal year, a major
18 automated information system may not receive Mile-
19 stone A approval, Milestone B approval, or full rate
20 production approval, or their equivalent, within the
21 Department of Defense until the Chief Information
22 Officer certifies, with respect to that milestone, that
23 the system is being developed in accordance with the
24 Clinger-Cohen Act of 1996 (40 U.S.C. 1401 et seq.).
25 The Chief Information Officer may require addi-

1 tional certifications, as appropriate, with respect to
2 any such system.

3 ~~(2)~~ The Chief Information Officer shall provide
4 the congressional defense committees timely notifica-
5 tion of certifications under paragraph ~~(1)~~. Each
6 such notification shall include, at a minimum, the
7 funding baseline and milestone schedule for each
8 system covered by such a certification and confirma-
9 tion that the following steps have been taken with
10 respect to the system:

19 ~~(d)~~ DEFINITIONS.—For purposes of this section:

24 ~~(2)~~ The term “information technology system”
25 has the meaning given the term “information tech-

1 nology” in section 5002 of the Clinger-Cohen Act of
2 1996 (40 U.S.C. 1401).

3 SEC. 8081. During the current fiscal year, none of
4 the funds available to the Department of Defense may be
5 used to provide support to another department or agency
6 of the United States if such department or agency is more
7 than 90 days in arrears in making payment to the Depart-
8 ment of Defense for goods or services previously provided
9 to such department or agency on a reimbursable basis:
10 *Provided*, That this restriction shall not apply if the de-
11 partment is authorized by law to provide support to such
12 department or agency on a nonreimbursable basis, and is
13 providing the requested support pursuant to such author-
14 ity: *Provided further*, That the Secretary of Defense may
15 waive this restriction on a case-by-case basis by certifying
16 in writing to the Committees on Appropriations of the
17 House of Representatives and the Senate that it is in the
18 national security interest to do so.

19 SEC. 8082. None of the funds provided in this Act
20 may be used to transfer to any nongovernmental entity

24 piercing (AP)”, “armor piercing incendiary (API)”, or
25 “armor-piercing incendiary-tracer (API-T)”, except to an

1 entity performing demilitarization services for the Depart-
2 ment of Defense under a contract that requires the entity

16 period not in excess of 1 year to any organization specified
17 in 32 U.S.C. 508(d), or any other youth, social, or fra-
18 ternal non-profit organization as may be approved by the
19 Chief of the National Guard Bureau, or his designee, on
20 a case-by-case basis.

21 SEC. 8084. None of the funds appropriated by this

25 resale (including such alcoholic beverages sold by the

1 drink) on a military installation located in the United
2 States unless such malt beverages and wine are procured
3 within that State, or in the case of the District of Colum-
4 bia, within the District of Columbia, in which the military
5 installation is located: *Provided*, That in a case in which
6 the military installation is located in more than one State,

10 tions in subsections (a) and (b) of that section: *Provided*,
11 That such payments shall be made from funds available

9 of the funding requested for each contingency operation,
10 for each military service, to include all Active and Reserve
11 components, and for each appropriations account: *Pro-*
12 *vided further*, That these documents shall include esti-
13 mated costs for each element of expense or object class,
14 a reconciliation of increases and decreases for each contin-
15 gency operation, and programmatic data including, but
16 not limited to, troop strength for each Active and Reserve
17 component, and estimates of the major weapons systems
18 deployed in support of each contingency: *Provided further*,
19 That these documents shall include budget exhibits OP-
20 5 and OP-32 (as defined in the Department of Defense
21 Financial Management Regulation) for all contingency op-
22 erations for the budget year and the two preceding fiscal
23 years.

24 SEC. 8105. None of the funds in this Act may be
25 used for research, development, test, evaluation, procure-

1 ment or deployment of nuclear armed interceptors of a
2 missile defense system.

3 SEC. 8106. Of the amounts provided in title II of this
4 Act under the heading, “Operation and Maintenance, De-
5 fense-Wide”, \$20,000,000 is available for the Regional
6 Defense Counter-terrorism Fellowship Program, to fund
7 the education and training of foreign military officers,
8 ministry of defense civilians, and other foreign security of-
9 ficials, to include United States military officers and civil-
10 ian officials whose participation directly contributes to the
11 education and training of these foreign students.

12 SEC. 8107. None of the funds appropriated or made
13 available in this Act shall be used to reduce or disestablish
14 the operation of the 53rd Weather Reconnaissance Squad-
15 ron of the Air Force Reserve, if such action would reduce
16 the WC-130 Weather Reconnaissance mission below the
17 levels funded in this Act: *Provided*, That the Air Force
18 shall allow the 53rd Weather Reconnaissance Squadron to
19 perform other missions in support of national defense re-
20 quirements during the non-hurricane season.

21 SEC. 8108. (a) LAND CONVEYANCES, NORTON AIR
22 FORCE BASE, CALIFORNIA.—(1) FOREST SERVICE CON-
23 VEYANCE.—Subject to paragraph (2), the Secretary of Ag-
24 riculture shall convey to the Inland Valley Development
25 Agency all right, title, and interest of the United States

1 in and to a parcel of real property consisting of approxi-
2 mately 3.74 acres designated as parcel D-1 (including the
3 former Air Force S-2 Headquarters Building) on the
4 former Norton Air Force Base, California.

5 (2) As consideration for the transfer under paragraph
6 (1), the Inland Valley Development Agency shall execute
7 a long-term ground lease with the Secretary of Agri-
8 culture, upon terms acceptable to the Federal Aviation Ad-
9 ministration, to provide the United States Forest Service
10 with a replacement parcel of land of approximately 7.5
11 acres at the San Bernardino International Airport adja-
12 cent to current facilities of the Forest Service to be used
13 for aeronautical purposes in furtherance of wildfire pre-
14 vention and containment.

15 (b) AIR FORCE CONVEYANCE.—(1) Subject to para-
16 graph (2), the Secretary of the Air Force shall convey to
17 the Inland Valley Development Agency all right, title, and
18 interest of the United States in and to certain parcels of
19 real property, including improvements thereon, located on
20 or adjacent to the former Norton Air Force Base, Cali-
21 fornia, that as of the date of the enactment of this Act
22 have been determined through a record of decision to be
23 eligible to be transferred to, or held in trust for, the San
24 Manuel Band of Mission Indians.

1 (2) The Secretary of the Air Force shall make a con-
2 veyance under paragraph (1) with respect to any parcel
3 of real property to which that paragraph applies only upon
4 delivery to the Secretary of an instrument executed by the
5 San Manuel Band of Mission Indians that releases and
6 extinguishes any real property interest of the San Manuel
7 Band of Mission Indians in that parcel of real property.

8 SEC. 8109. (a) The total amount appropriated or oth-
9 erwise made available in titles III and IV of this Act is
10 hereby reduced by \$345,000,000 to reflect savings from
11 revised economic assumptions, to be distributed as follows:

12 “Title III”, \$189,000,000; and

13 “Title IV”, \$156,000,000.

14 (b) The Secretary of Defense shall allocate this re-
15 duction proportionately to each program, project, and ac-
16 tivity within each applicable appropriation account.

17 (INCLUDING TRANSFER OF FUNDS)

18 SEC. 8110. (a) The amount appropriated in title II
19 for “Operation and Maintenance, Air Force” is hereby re-
20 duced by \$967,200,000 to reflect cash balance and rate
21 stabilization adjustments in the Department of Defense
22 Transportation Working Capital Fund.

23 (b) Not later than 120 days after the date of the en-
24 actment of this Act, the Secretary of Defense shall trans-
25 fer \$967,200,000 from the Department of Defense Trans-

1 portation Working Capital Fund to “Operation and Main-
2 tenance, Air Force” to offset the reduction made by sub-
3 section (a). The transfer required by this subsection is in
4 addition to any other transfer authority provided to the
5 Department of Defense.

6 SEC. 8111. None of the funds provided in this Act
7 shall be available for integration of foreign intelligence in-
8 formation unless the information has been lawfully col-
9 lected and processed during the conduct of authorized for-
10 eign intelligence activities: *Provided*, That information
11 pertaining to United States persons shall only be handled
12 in accordance with protections provided in the Fourth
13 Amendment of the United States Constitution as imple-
14 mented through Executive Order No. 12333.

15 SEC. 8112. Section 8149(b) of the Department of De-
16 fense Appropriations Act, 2003 (Public Law 107-248; 10
17 U.S.C. 2784 note), shall remain in effect for fiscal year
18 2005.

19 SEC. 8113. Amounts appropriated in this Act may
20 be used by the Department of Defense for the purchase
21 of heavy and light armored vehicles for force protection
22 purposes, notwithstanding price or other limitations appli-
23 cable to the purchase of passenger carrying vehicles under
24 section 1343 of title 31, United States Code, or any other
25 provision of law: *Provided*, That the Secretary of Defense

1 shall submit a report no later than 30 days after the end
2 of each fiscal quarter notifying the congressional defense
3 committees of any purchase described in this section, in-
4 cluding the cost, purposes, and quantities of vehicles pur-
5 chased.

6 SEC. 8114. Of the amount appropriated under the
7 heading “Operation and Maintenance, Marine Corps” for
8 the Marine Corps Air-Ground Task Force Training Cen-
9 ter, Twenty Nine Palms, California, \$4,500,000 shall be
10 available to the Secretary of the Navy to enter into a con-
11 tract, notwithstanding any other provision of law, for the
12 widening of Adobe Road, which is used by members of
13 the Marine Corps stationed at the installation and their
14 dependents, and for construction of pedestrian and bike
15 lanes for the road, to provide for the safety of the Marines
16 stationed at the installation.

17 SEC. 8115. In addition to amounts appropriated or
18 otherwise made available in this Act, there is hereby ap-
19 propriated \$3,000,000, for “Operation and Maintenance,
20 Marine Corps”: *Provided*, That the Secretary of the Navy
21 shall make a grant in that amount to the “Hi-Desert Me-
22 morial Health Care District”, Joshua Tree, California, for
23 the purposes of providing a capability for non-invasive as-
24 sessment, diagnostic testing and treatment in support of

1 service personnel and their families stationed at the Ma-
2 rine Corps Air-Ground Task Force Training Center.

3 SEC. 8116. (a) LAND CONVEYANCE, ARMY RESERVE
4 TRAINING CENTER, WOOSTER, OHIO.—The Secretary of
5 the Army may convey, without consideration, to the City
6 of Wooster, Ohio, all right, title, and interest of the United
7 States in and to a parcel of real property, including im-
8 provements thereon, that is located at 1676 Portage Road,
9 Wooster, Ohio, and contains a former Army Reserve
10 Training Center.

11 (b) DESCRIPTION OF PROPERTY.—The exact acreage
12 and legal description of the real property to be conveyed
13 under subsection (a) shall be determined by a survey satis-
14 factory to the Secretary. The cost of the survey shall be
15 borne by the City of Wooster, Ohio.

16 (c) ADDITIONAL TERMS AND CONDITIONS.—The
17 Secretary may require such additional terms and condi-
18 tions in connection with the conveyance under subsection
19 (a) as the Secretary considers appropriate to protect the
20 interests of the United States.

21 SEC. 8117. (a) At the time members of reserve com-
22 ponents of the Armed Forces are called or ordered to ac-
23 tive duty under section 12302(a) of title 10, United States
24 Code, each member shall be notified in writing of the ex-
25 pected period during which the member will be mobilized.

1 (b) The Secretary of Defense may waive the require-
 2 ments of subsection (a) in any case in which the Secretary
 3 determines that it is necessary to do so to respond to a
 4 national security emergency or to meet dire operational
 5 requirements of the Armed Forces.

6 (INCLUDING TRANSFER OF FUNDS)

7 SEC. 8118. The Secretary of the Navy may transfer
 8 funds from any available Department of the Navy appro-
 9 priation to any available Navy ship construction appro-
 10 priation for the purpose of liquidating necessary changes
 11 resulting from inflation, market fluctuations, or rate ad-
 12 justments for any ship construction program appropriated
 13 in law: *Provided*, That the Secretary may transfer not to
 14 exceed \$100,000,000 under the authority provided by this
 15 section: *Provided further*, That the funding transferred
 16 shall be available for the same time period as the appro-
 17 priation to which transferred: *Provided further*, That the
 18 Secretary may not transfer any funds until 30 days after
 19 the proposed transfer has been reported to the Committee
 20 on Appropriations of the Senate and the House of Rep-
 21 resentatives, unless sooner notified by the Committees
 22 that there is no objection to the proposed transfer: *Pro-*
 23 *vided further*, That the transfer authority provided by this
 24 section is in addition to any other transfer authority con-
 25 tained elsewhere in this Act.

1 SEC. 8119. The amounts appropriated in title H of
2 this Act are hereby reduced by \$100,000,000 to reflect
3 savings attributable to the offsetting of payments to con-
4 tractors for the collection, pursuant to law, of unpaid taxes
5 owed to the United States, as follows:

6 (1) From “Operation and Maintenance, Army”,
7 \$22,000,000.

8 (2) From “Operation and Maintenance, Navy”,
9 \$26,000,000.

10 (3) From “Operation and Maintenance, Marine
11 Corps”, \$2,000,000.

12 (4) From “Operation and Maintenance, Air
13 Force”, \$50,000,000.

14 SEC. 8120. The total amount appropriated in title IV
15 is hereby reduced by \$685,000,000 to decrease amounts
16 budgeted in anticipation of the application of non-statu-
17 tory funding set asides: *Provided*, That this reduction shall
18 be allocated proportionately to each budgeted program,
19 program element, project, and activity: *Provided further*,
20 That funds made available for programs of the National
21 Foreign Intelligence Program (NFIP) are exempt from
22 the application of this provision.

23 (INCLUDING TRANSFER OF FUNDS)

24 SEC. 8121. TANKER REPLACEMENT TRANSFER
25 FUND.—In addition to funds made available elsewhere in
26 this Act, there is hereby appropriated \$100,000,000, to

1 remain available until transferred: *Provided*, That these
2 funds are appropriated to the “Tanker Replacement
3 Transfer Fund” (referred to as “the Fund” elsewhere in
4 this section), which is hereby established in the Treasury:
5 *Provided further*, That the Secretary of the Air Force may

19 other transfer authority available to the Department of
20 Defense: *Provided further*, That the Secretary of the Air
21 Force shall, not fewer than 15 days prior to making transfers
22 using funds provided in this section, notify the congressional
23 defense committees in writing of the details of
24 any such transfer: *Provided further*, That the Secretary
25 shall submit a report no later than 30 days after the end

1 of each fiscal quarter to the congressional defense commit-
2 tees summarizing the details of the transfer of funds from
3 this appropriation.

4 SEC. 8122. None of the funds appropriated or other-
5 wise made available by this Act may be used to amend
6 or cancel, or implement any amendment or cancellation
7 of, Department of Defense Directive 1344.7, “Personal
8 Commercial Solicitation on DoD Installations”, until after
9 the end of the one-year period beginning on the date on
10 which the report containing the results of the investigation
11 regarding insurance premium allotment processing, which
12 is underway as of the date of the enactment of this Act,
13 is submitted to the congressional defense committees (as
14 defined in section 101(a)(16) of title 10, United States
15 Code), the Committee on Government Reform of the
16 House of Representatives, and the Committee on Govern-
17 mental Affairs of the Senate.

18 SEC. 8123. The Secretary of Defense shall provide
19 a report to the congressional defense committees not later
20 than July 30, 2004, that addresses how the Department
21 of Defense (DoD) is improving the dud rate of cluster mu-
22 nitions to meet existing DoD policies. This report shall
23 address: (1) the types and quantities of munitions systems
24 that employ cluster munitions presently in DoD’s inven-
25 tory that do and do not meet the 1-percent dud rate policy;

1 (2) DoD efforts to ensure the development of cluster mu-
 2 nitions that meet the 1-percent dud rate policy, including
 3 a list of programs funded in fiscal year 2005; and (3) a
 4 schedule describing the DoD cluster munitions inventory
 5 profile from the present until the time this inventory will
 6 meet the 1-percent dud rate policy.

17 *That businesses certified as 8(a) by the Small Business Ad-*

24 *SEC. 8022. None of the funds appropriated by this Act*
25 *shall be available to perform any cost study pursuant to*

1 *the provisions of OMB Circular A-76 if the study being*
2 *performed exceeds a period of 24 months after initiation*
3 *of such study with respect to a single function activity or*
4 *30 months after initiation of such study for a multi-func-*
5 *tion activity.*

6 *SEC. 8023. Funds appropriated by this Act for the*
7 *American Forces Information Service shall not be used for*
8 *any national or international political or psychological ac-*
9 *tivities.*

10 *SEC. 8024. Notwithstanding any other provision of*
11 *law or regulation, the Secretary of Defense may adjust wage*
12 *rates for civilian employees hired for certain health care*
13 *occupations as authorized for the Secretary of Veterans Af-*
14 *fairs by section 7455 of title 38, United States Code.*

15 *SEC. 8025. In addition to the amounts appropriated*
16 *or otherwise made available in this Act, \$33,000,000 is*
17 *hereby appropriated to the Department of Defense: Pro-*
18 *vided, That the Secretary of Defense shall make grants in*

3 *(INCLUDING TRANSFER OF FUNDS)*

4 *SEC. 8038. During the current fiscal year, amounts*
5 *contained in the Department of Defense Overseas Military*
6 *Facility Investment Recovery Account established by section*
7 *2921(c)(1) of the National Defense Authorization Act of*
8 *1991 (Public Law 101–510; 10 U.S.C. 2687 note) shall be*
9 *available until expended for the payments specified by sec-*
10 *tion 2921(c)(2) of that Act.*

11 *SEC. 8039. (a) IN GENERAL.—Notwithstanding any*
12 *other provision of law, the Secretary of the Air Force may*
13 *convey at no cost to the Air Force, without consideration,*
14 *to Indian tribes located in the States of North Dakota,*

12 *tems for the Services, the Unified and Specified Commands,*

24 *be used to reduce the authorized positions for military (ci-*

26 *National Guard, Army Reserve and Air Force Reserve for*

1 *the purpose of applying any administratively imposed ci-*
2 *vilian personnel ceiling, freeze, or reduction on military (ci-*
3 *vilian) technicians, unless such reductions are a direct re-*
4 *sult of a reduction in military force structure.*

5 *SEC. 8051. None of the funds appropriated or other-*
6 *wise made available in this Act may be obligated or ex-*
7 *pended for assistance to the Democratic People's Republic*
8 *of North Korea unless specifically appropriated for that*
9 *purpose.*

10 *SEC. 8052. During the current fiscal year, funds ap-*
11 *propriated in this Act are available to compensate members*

17 (e) *DURATION OF CERTIFICATION REQUIREMENT.*—
18 *The requirement to make an annual certification under*
19 *subsection (a) shall apply until the Secretary certifies to*
20 *Congress that the renovation of the Pentagon Reservation*
21 *is completed.*

22 *SEC. 8056. Notwithstanding any other provision of*
23 *law, that not more than 35 percent of funds provided in*
24 *this Act for environmental remediation may be obligated*

1 *under indefinite delivery/indefinite quantity contracts with*
2 *a total contract value of \$130,000,000 or higher.*

3 *SEC. 8057. (a) None of the funds available to the De-*
4 *partment of Defense for any fiscal year for drug interdic-*
5 *tion or counter-drug activities may be transferred to any*
6 *other department or agency of the United States except as*
7 *specifically provided in an appropriations law.*

8 *(b) None of the funds available to the Central Intel-*
9 *ligence Agency for any fiscal year for drug interdiction and*
10 *counter-drug activities may be transferred to any other de-*
11 *partment or agency of the United States except as specifi-*
12 *cally provided in an appropriations law.*

13 *(TRANSFER OF FUNDS)*

14 *SEC. 8058. Appropriations available in this Act under*
15 *the heading “Operation and Maintenance, Defense-Wide”*
16 *for increasing energy and water efficiency in Federal build-*
17 *ings may, during their period of availability, be transferred*
18 *to other appropriations or funds of the Department of De-*

4 *of chapter 148 of title 10, United States Code, the Secretary*
5 *of Defense may issue loan guarantees in support of United*
6 *States defense exports not otherwise provided for: Provided,*
7 *That the total contingent liability of the United States for*
8 *guarantees issued under the authority of this section may*
9 *not exceed \$15,000,000,000: Provided further, That the ex-*
10 *posure fees charged and collected by the Secretary for each*
11 *guarantee shall be paid by the country involved and shall*
12 *not be financed as part of a loan guaranteed by the United*

6 (1) *such costs are for a bonus or otherwise in ex-*
7 *cess of the normal salary paid by the contractor to the*

9 (2) *such bonus is part of restructuring costs asso-*
10 *ciated with a business combination.*

11 *SEC. 8068. Notwithstanding any other provision of*

16 SEC. 8077. (a) *PROHIBITION.*—*None of the funds made*

20 *formation from the Department of State that the unit has*
21 *committed a gross violation of human rights, unless all nec-*

9 *are manufactured in the United States by a domestically*
10 *operated entity: Provided, That the Secretary of Defense*
11 *may waive this restriction on a case-by-case basis by certi-*

1 *be used for the purpose of conducting official Department*
2 *of Defense business.*

3 *SEC. 8081. Notwithstanding any other provision of*
4 *law, funds appropriated in this Act under the heading “Re-*
5 *search, Development, Test and Evaluation, Defense-Wide”*
6 *for any advanced concept technology demonstration project*
7 *may only be obligated 30 days after a report, including a*
8 *description of the project, the planned acquisition and tran-*
9 *sition strategy and its estimated annual and total cost, has*
10 *been provided in writing to the congressional defense com-*
11 *mittees: Provided, That the Secretary of Defense may waive*

10 *the furnishing to that officer of notice of the system, together*
11 *with such information concerning the system as the Sec-*

13 *information technology system shall be considered a mission*
14 *critical or mission essential information technology system*

16 *(b) CERTIFICATIONS AS TO COMPLIANCE WITH FINAN-*
17 *CIAL MANAGEMENT MODERNIZATION PLAN.—*

20 *information system supporting financial and non-fi-*
21 *nancial systems, or a system improvement of more*

10 (c) CERTIFICATIONS AS TO COMPLIANCE WITH

13 mated information system may not receive Milestone

17 cer certifies, with respect to that milestone, that the
18 system is being developed in accordance with the
19 Clinger-Cohen Act of 1996 (40 U.S.C. 1401 et seq.).
20 The Chief Information Officer may require additional
21 certifications, as appropriate, with respect to any
22 such system.

23 (2) The Chief Information Officer shall provide
24 the congressional defense committees timely notifica-
25 tion of certifications under paragraph (1). Each such

1 notification shall include, at a minimum, the funding
2 baseline and milestone schedule for each system cov-
3 ered by such a certification and confirmation that the
4 following steps have been taken with respect to the
5 system:

6 (A) Business process reengineering.

7 (B) An analysis of alternatives.

8 (C) An economic analysis that includes a
9 calculation of the return on investment.

10 (D) Performance measures.

11 (E) An information assurance strategy con-
12 sistent with the Department's Global Informa-
13 tion Grid.

14 (d) DEFINITIONS.—For purposes of this section:

15 (1) The term “Chief Information Officer” means
16 the senior official of the Department of Defense des-
17 ignated by the Secretary of Defense pursuant to sec-
18 tion 3506 of title 44, United States Code.

19 (2) The term “information technology system”
20 has the meaning given the term “information tech-
21 nology” in section 5002 of the Clinger-Cohen Act of
22 1996 (40 U.S.C. 1401).

23 SEC. 8085. During the current fiscal year, none of the
24 funds available to the Department of Defense may be used
25 to provide support to another department or agency of the

4 *classified Military Articles issued by the Department of*
5 *State.*

6 *SEC. 8087. Notwithstanding any other provision of*
7 *law, the Chief of the National Guard Bureau, or his des-*
8 *ignee, may waive payment of all or part of the consider-*
9 *ation that otherwise would be required under 10 U.S.C.*
10 *2667, in the case of a lease of personal property for a period*
11 *not in excess of 1 year to any organization specified in 32*
12 *U.S.C. 508(d), or any other youth, social, or fraternal non-*
13 *profit organization as may be approved by the Chief of the*
