The committee directs the Secretary of Defense to provide a report to the House Committee Armed Services, not later than September 30, 2018, and again 180 days thereafter, on the U.S. casualty estimates for likely scenarios of an armed conflict with North Korea. The reports should be unclassified, but each may contain a classified annex.
