In June, Congress passed H.R. 338, the Promote a 21st Century Energy and Manufacturing Workforce Future Act. Our office has worked on this legislation for several years and was one of the primary sponsors of this bill that will prioritize education and training programs in the energy and manufacturing sectors for underrepresented Americans, including women, veterans, and minorities, as well as displaced and unemployed energy and manufacturing workers.

This legislation will help build public-private partnerships between private industry, colleges and universities, and workforce organizations, to development and improve training programs, and identify candidates from underrepresented and unemployed communities to enroll into training and apprenticeship programs.

Healthcare is an issue that I've worked tirelessly to improve since I've been your Representative. Too many families in our district still lack access to quality care, and I'm afraid healthcare will cost more for hard-working families if the Affordable Care Act (ACA) is repealed. # **Affordable Care Act Repeal**

The American Health Care Act (H.R. 1628) is the House Republican plan to repeal the Affordable Care Act (ACA) and replace it with the House Majority's bill. According to the nonpartisan, independent Congressional Budget Office (CBO), it will force 23 million Americans to lose their health insurance. Deductibles and out-of-pocket costs will also greatly increase, leaving sick people unable to afford the care they need. Under the ACA, low and middle-income families received financial assistance based on age, income, and where you live. Under the House Republican leadership bill, I believe the subsidies will be slashed, saddling working families with massive health costs. According to the Congressional Budget Office analysis, insurers will be able to charge older Americans, particulartly those aged 50 and older, five times higher than what others pay for health coverage, a policy that will devastate poorer, sicker Americans.

H.R. 1628 puts Medicare at risk by shortening the life of the Trust Fund in order to give tax breaks to the wealthy. It ends the Medicaid expansion under ACA, which extended coverage to more than 11 million low-income people as of March 2016, according to The Kaiser Family Foundation. If Texas would expand Medicaid, more than 46,000 of our neighbors would be eligible for Medicaid. The bill cuts \$834 billion from Medicaid and fundamentally restructures the way the entire Medicaid program is financed to shift costs to states. This puts the future of Medicaid in jeopardy and will lead to a reduction in benefits and the rationing of care among beneficiaries – seniors in nursing homes, children, pregnant women and people with disabilities. The bill allows states to waive the Essential Health Benefit requirements, meaning there is no guarantee whether insurance actually would cover the benefits patients need like prescription drugs, emergency care, hospitalization, pregnancy, and mental health and substance abuse services.

As premiums soar and quality coverage is priced out of reach, families will be left with plans that cost more, offer worse coverage, and fewer protections. There are certainly ways the current law can be improved, like strengthening the risk pool, promoting competition among insurers, and requiring states to expand their Medicaid program so that almost 50,000 individuals in our district and millions of lower-income Americans across the country could get insurance. I hope to work with my colleagues to build on the ACA and improve the law.

# Children's Health Insurance Program & Federally Qualified Health Centers

The Children's Health Insurance Program (CHIP) was created to build on the Medicaid program, providing financing support for states to expand coverage to uninsured children in families that make too much to qualify for Medicaid, but not enough to afford the out of pocket costs associated with private coverage. As of FY 2016, there were 37.1 million children enrolled in Medicaid, 8.9 million children enrolled through CHIP, and 1.1 million children with Marketplace coverage. Funding for CHIP is scheduled to run out on September 30, 2017. I will continue to advocate for the program and urge my colleagues to fully extend funding for five years.

The Affordable Care Act (ACA) created the Community Health Center Fund (CHCF), which provided \$11 billion in mandatory funding through FY 2015 to the Health Center Program for health center construction and renovation. The Medicare Access and CHIP Reauthorization Act of 2015 (MACRA) reauthorized the CHCF by directly appropriating \$3.6 billion for each of fiscal years 2016 and 2017. Without an extension of CHCF funding, the Health Center Program would be decimated. Seeing that we have many quality community health centers in our district, this would be especially harmful for us.

# **Workforce**

Increasing federal investment in workforce training opportunities for our community is one of our office's biggest priorities in Congress. High-quality workforce training programs need to be readily available throughout Houston and Harris County for ambitious high school and college students, as well as more experienced workers, who are looking to obtain the skills and credentials necessary to find a well-paying job with good benefits.

In May, our office introduced the Domestic Maritime Centers of Excellence Act, H.R. 2286. This legislation will authorize the U.S. Department of Transportation to designate maritime workforce training programs at community colleges, like the program at San Jacinto College, as a "Center of Excellence." Centers of Excellence under our bill will qualify for federal assistance to help support maritime workforce training, including technical assistance, surplus equipment, and funding. The bill has already been attached to larger pieces of legislation in the House and Senate, and we expect it will become law in the coming months.

The U.S. House of Representatives passed the Strengthening Career and Technical Education for the 21st Century Act in June with our office's support. This legislation will increase federal funding for career and technical education (CTE) programs at high schools, community colleges, and trade schools, and provide greater flexibility for states to customize programs for the needs of their communities.
