Mr. RATCLIFFE. Together, we have accomplished much these past three years for our communities and constituents. I will be forever grateful for her service in my office and to our constituents and communities, and for the lives we have been able to touch and change along the way. I am particularly grateful for her help in building and leading our process for identifying and selecting deserving students to receive nominations to our nation's service academies. During the three years under her leadership, I am proud to say that we have been able to offer more than 75 nominations to incredible young women and men across the 4th District of Texas. As a result of Lorie's dedication to this mission, I know that our country will be better served by the many outstanding future leaders who have accepted appointments to our nation's service academies.

Again, I express my sincere gratitude to Lorie Grinnan and to her family for the sacrifices they have made over these past two decades to support her dedicated career of public service. She then moved to Michigan in the 1970s to live closer to family and settled in Ypsilanti, Michigan where she would live for the rest of her life.

After moving to Michigan, Mrs. Wilson became involved with her local ministry, Brown Chapel AME Church. Church members remember her as an active volunteer with a heart for giving and a permanent smile on her face. This past November, those close to Mrs. Wilson hosted a surprise 106th birthday for her at the senior living community where she had been a resident since 1989. Friends and family shared stories of the kindness, leadership, and positivity that Dorothy will be remembered for. On her 106th birthday, Dorothy told her guests that kindness and giving back to others are the two keys to a fulfilled life. She lived her life following these two principles and leaves behind a bright legacy and loving family and friends.
