

He served as Hesperia's mayor in 2012 and in 2018.

With Russ's passing, Hesperia has lost a titan who helped build the city into what it is today. Russ was known for his faith, integrity, and incredible work ethic, and will be missed by all who knew him. And let me add that the Philadelphia Orchestra should be noted for the diversity of its musicians and staff orchestra's diversity complements.

As a country bordering both Russia and Iran, Azerbaijan's membership in NATO's Partnership for Peace program is particularly important. Azerbaijan has emerged as a crucially important transportation route for supplying U.S. operations, and I want to recognize Azerbaijan for providing troops to the U.S.-led mission in Afghanistan and for allowing NATO planes to use Azerbaijani airspace.

As a modern, secular Muslim country, Azerbaijan shares these values and stands out among its neighbors in the region for the strength and durability of this bond with Israel.
