AN ACT

To provide for reconciliation pursuant to section 2002 of the concurrent resolution on the budget for fiscal year 2016.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*



1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) **SHORT TITLE.**—This Act may be cited as the
 3 “Restoring Americans’ Healthcare Freedom Reconcili-
 4 ation Act of 2015”.

5 (b) **TABLE OF CONTENTS.**—The table of contents of

7 **TITLE I—COMMITTEE ON**
 8 **ENERGY AND COMMERCE**

9 **SEC. 101. REPEAL OF THE PREVENTION AND PUBLIC**
 10 **HEALTH FUND.**

11 (a) **IN GENERAL.**—Section 4002 of the Patient Pro-
 12 tection and Affordable Care Act (42 U.S.C. 300u–11) is
 13 repealed.

14 (b) **RESCISSION OF UNOBLIGATED FUNDS.**—Of the
 15 funds made available by such section 4002, the unobli-
 16 gated balance is rescinded.

17 **SEC. 102. FEDERAL PAYMENT TO STATES.**

18 (a) **IN GENERAL.**—Notwithstanding section 504(a),
 19 1902(a)(23), 2002, 2005(a)(4), 2102(a)(7), or 2105(a)(1)

1 of the Social Security Act (42 U.S.C. 704(a),
2 1396b(a)(23), 1397a, 1397d(a)(4), 1397bb(a)(2),
3 1397ee(a)(1)), or the terms of any Medicaid waiver in ef-
4 fect on the date of enactment of this Act that is approved
5 under section 1115 or 1915 of the Social Security Act (42
6 U.S.C. 1315, 1396n), for the 1-year period beginning on
7 the date of the enactment of this Act no Federal funds
8 may be made available to a State for payments to a pro-
9 hibited entity, whether made directly to the prohibited en-
10 tity or through a managed care organization under con-
11 tract with the State.

12 (b) DEFINITION OF PROHIBITED ENTITY.—In this
13 section, the term “prohibited entity” means an entity, in-
14 cluding its affiliates, subsidiaries, successors, and clinics—

15 (1) that, as of the date of enactment of this
16 Act—

17 (A) is an organization described in section
18 501(c)(3) of the Internal Revenue Code of 1986
19 and exempt from tax under section 501(a) of
20 such Code;

21 (B) is an essential community provider de-
22 scribed in section 156.235 of title 45, Code of
23 Federal Regulations, that is primarily engaged
24 in family planning services, reproductive health,
25 and related medical care; and

1 (C) provides for abortions, other than an
2 abortion—

3 (i) if the pregnancy is the result of an
4 act of rape or incest; or

5 (ii) in the case where a woman suffers
6 from a physical disorder, physical injury,
7 or physical illness that would, as certified
8 by a physician, place the woman in danger
9 of death unless an abortion is performed,
10 including a life-endangering physical condi-
11 tion caused by or arising from the preg-
12 nancy itself; and

13 (2) for which the total amount of Federal and
14 State expenditures under the Medicaid program
15 under title XIX of the Social Security Act in fiscal
16 year 2014 made directly to the entity and to any af-
17 filiates, subsidiaries, successors, or clinics of the en-
18 tity, or made to the entity and to any affiliates, sub-
19 sidiaries, successors, or clinics of the entity as part
20 of a nationwide health care provider network, ex-
21 ceeded \$350,000,000.

22 **SEC. 103. FUNDING FOR COMMUNITY HEALTH CENTER**
23 **PROGRAM.**

24 Effective as if included in the enactment of the Medi-
25 care Access and CHIP Reauthorization Act of 2015 (Pub-

1 lie Law 114–10, 129 Stat. 87), paragraph (1) of section
2 221(a) of such Act is amended by inserting after “Section
3 10503(b)(1)(E) of the Patient Protection and Affordable
4 Care Act (42 U.S.C. 254b–2(b)(1)(E)) is amended” the
5 following: “by striking ‘\$3,600,000,000’ and inserting
6 ‘\$3,835,000,000’ and”.

7 **TITLE II—COMMITTEE ON WAYS** 8 **AND MEANS**

9 **SEC. 201. REPEAL OF INDIVIDUAL MANDATE.**

10 (a) IN GENERAL.—Section 5000A of the Internal
11 Revenue Code of 1986 is amended by adding at the end
12 the following:

13 “(h) TERMINATION.—This section shall not apply
14 with respect to any month beginning after December 31,
15 2014.”.

16 (b) CONFORMING AMENDMENTS.—

17 (1) Section 5000A(c) of such Code is amend-
18 ed—

19 (A) in paragraph (2)(B) by striking
20 clauses (ii) and (iii),

21 (B) in paragraph (3)(B) by striking
22 “2014” and all that follows and inserting
23 “2014.”, and

24 (C) in paragraph (3) by striking subpara-
25 graph (D).

1 (2) Section 5000A(e)(1) of such Code is amend-
2 ed by striking subparagraph (D).

3 (c) EFFECTIVE DATE.—The amendments made by
4 this section shall apply to months beginning after Decem-
5 ber 31, 2014.

6 **SEC. 202. REPEAL OF EMPLOYER MANDATE.**

7 (a) IN GENERAL.—Section 4980H of the Internal
8 Revenue Code of 1986 is amended by adding at the end
9 the following:

10 “(e) TERMINATION.—This section shall not apply
11 with respect to any month beginning after December 31,
12 2014.”.

13 (b) CONFORMING AMENDMENT.—Section 4980H(c)
14 of such Code is amended by striking paragraph (5).

15 (c) EFFECTIVE DATE.—The amendments made by
16 this section shall apply to months beginning after Decem-
17 ber 31, 2014.

18 **SEC. 203. REPEAL OF MEDICAL DEVICE EXCISE TAX.**

19 (a) IN GENERAL.—Chapter 32 of the Internal Rev-
20 enue Code of 1986 is amended by striking subchapter E.

21 (b) CONFORMING AMENDMENTS.—

22 (1) Subsection (a) of section 4221 of such Code
23 is amended by striking the last sentence.

24 (2) Paragraph (2) of section 6416(b) of such
25 Code is amended by striking the last sentence.

1 (c) CLERICAL AMENDMENT.—The table of sub-
2 chapters for chapter 32 of such Code is amended by strik-
3 ing the item relating to subchapter E.

4 (d) EFFECTIVE DATE.—The amendments made by
5 this section shall apply to sales in calendar quarters begin-
6 ning after the date of the enactment of this Act.

7 **SEC. 204. REPEAL OF THE TAX ON EMPLOYEE HEALTH IN-**
8 **SURANCE PREMIUMS AND HEALTH PLAN**
9 **BENEFITS AND RELATED REPORTING RE-**
10 **QUIREMENTS.**

11 (a) EXCISE TAX.—Chapter 43 of the Internal Rev-
12 enue Code of 1986 is amended by striking section 4980I.

13 (b) REPORTING REQUIREMENT.—Section 6051(a) of
14 such Code is amended by inserting “and” at the end of
15 paragraph (12), by striking “, and” at the end of para-
16 graph (13) and inserting a period, and by striking para-
17 graph (14).

18 (c) CLERICAL AMENDMENT.—The table of sections
19 for chapter 43 of such Code is amended by striking the
20 item relating to section 4980I.

21 (d) EFFECTIVE DATES.—

22 (1) IN GENERAL.—Except as provided by para-
23 graph (2), the amendments made by this section
24 shall apply to taxable years beginning after Decem-
25 ber 31, 2017.

1 (2) REPORTING REQUIREMENT.—The amend-
2 ment made by subsection (b) shall apply to calendar
3 years beginning after December 31, 2014.
