2 SECTION 1. PEER SUPPORT COUNSELING PROGRAM FOR 2 WOMEN VETERANS. 3 (a) In General.—Section 1720F(j) of title 38, United States Code, is amended by adding at the end the 4 5 following new paragraph: 6 "(4)(A) As part of the counseling program under this 7 subsection, the Secretary shall emphasize appointing peer 8 support counselors for women veterans. To the degree 9 practicable, the Secretary shall seek to recruit women peer support counselors with expertise in— 10 11 "(i) female gender-specific issues and services; 12 "(ii) the provision of information about services 13 and benefits provided under laws administered by 14 the Secretary; or 15 "(iii) employment mentoring. 16 "(B) To the degree practicable, the Secretary shall 17 emphasize facilitating peer support counseling for women veterans who are eligible for counseling and services under 18

- 6 tions as the Secretary considers appropriate.
- 7 "(E) In carrying out this paragraph, the Secretary
- 8 shall provide adequate training for peer support coun-
- 9 selors, including training carried out under the national
- 10 program of training required by section 304(c) of the
- 11 Caregivers and Veterans Omnibus Health Services Act of
- 12 2010 (38 U.S.C. 1712A note).".
- 13 (b) Funding.—The Secretary of Veterans Affairs
- 14 shall carry out paragraph (4) of section 1720F(j) of title
- 15 38, United States Code, as added by subsection (a), using
- 16 funds otherwise made available to the Secretary. No addi-
- 17 tional funds are authorized to be appropriated by reason
- 18 of such paragraph.
- 19 (c) Report to Congress.—Not later than 2 years
- 20 after the date of the enactment of this Act, the Secretary
- 21 of Veterans Affairs shall submit to the Committees on
- 22 Veterans' Affairs of the Senate and House of Representa-
- 23 tives a report on the peer support counseling program
- 24 under section 1720F(j) of title 38, United States Code,
- 25 as amended by this section. Such report shall include—
