

#### **Ensuring Equal Pay for Equal Work**

Women's History Month is an appropriate time to help raise awareness about pay inequality for all women. Accordingly, Congresswoman Beatty signed on as an original cosponsor of the Paycheck Fairness Act, H.R. 7, on January 30, 2019.

Women today earn 20 percent less than their male peers for doing the same work, according to a 2017 report by the American Association of University Women (AAUW). The Paycheck Fairness Act, if passed, would build upon the Lilly Ledbetter Fair Pay Act (Pub.L. 111-2) to provide more remedies to victims of paycheck discrimination on the basis of sex, end the practice of pay secrecy, and hold employers accountable for discriminatory practices.

"It is shameful that women today earn only 80 cents for every dollar earned by their male counterparts preforming the exact same job. That is why Congress has a responsibility to make pay equality a reality by passing the Paycheck Fairness Act. When women are given a level playing field, companies benefit, families prosper, communities grow, and our economy is stronger. When women succeed, America succeeds!"

#### **Beatty Reintroduces Three Bipartisan Bills**

This quarter, Congresswoman Beatty is championing and reintroducing three bipartisan bills aimed at providing greater assistance to veterans and victims of human trafficking. The bills are: the Housing Our Military Servicemembers (HOMES) Act, H.R. 715; the Homeless Veterans Legal Services Act, H.R. 716; and the Trafficking Victims Housing Act, H.R. 508.

The HOMES Act, if enacted, would add 'former servicemembers' on the Department of Housing and Urban Development's list of subpopulations eligible for homeless assistance, giving community organizations and local government agencies access to additional funds to address veteran homelessness. The Homeless Veterans Legal Services Act would allow the VA to partner with public and private entities to increase legal services for homeless veterans and those at risk of homelessness.

"Ensuring that veterans are able to access the services they need to move out of homelessness is a small piece of the larger commitment we must make to those who served our country," Beatty said. "My bills reaffirm that promise to those brave men and women who answered the call to serve in our Armed Forces, and I am proud to lead this bipartisan effort in Congress."

The Trafficking Victims Housing Act would require a federal study be conducted to assess the availability and accessibility of housing and related services for victims of trafficking who are experiencing homelessness and those at risk.

"Human trafficking is a scourge on our nation and our world. That is why we as a nation must continue working together to provide justice and greater support for victims and their families." Beatty continued, "Significant progress has been made in the fight to combat human trafficking, but the bipartisan effort to ultimately end it continues."
