# **Veterans Benefits**

Both the Illinois and U.S. Departments of Veterans Affairs provide a wide range of compensation, pensions, and bonuses. ## **Compensation**

### **Disability Compensation**

Disability compensation is a monthly tax-free benefit paid to Veterans who are at least 10% disabled due to injuries or diseases incurred during active duty, active duty for training, or inactive duty training. It is also available to those who are disabled from VA health care.

- You may be eligible if you have a service-related disability and are discharged not under dishonorable conditions.

### **Dependency and Indemnity Compensation**

Dependency and indemnity compensation is for service-connected deaths. This is a monthly benefit paid to survivors of veterans who died in the line of duty or whose death resulted from a service-related injury or disease.

- You may be eligible if you are a survivor of a service member who died while on active duty, active duty for training, or inactive duty training; who died from service-related injury or disease; who died from a non-service-related injury or disease and was receiving or entitled to receive VA compensation for a service-related disability that was rated as totally disabling for at least ten years prior to death or since released from active duty and for at least five years prior to death, AND the surviving spouse was married to the veteran for those same 8 years.

### **Line of Duty Compensation**

Line of Duty Compensation is administered by the Illinois Court of Claims. If a State employee gave their life in the line of duty after 1995, a surviving spouse or dependent is entitled to the entire sum of \$100,000.

### **Combat Related Special Compensation**

Combat Related Special Compensation is for retired members of the military who have served at least 20 years of service. Disability retirees with less than 20 years of service will be automatically limited to a retroactive date of January 1, 2008 as required by legislation passed by Congress effective 2008. This is payable for combat related disabilities rated at least 10%. Qualified Reservists will not receive this until they begin to receive military retired pay at the age of 60. You must apply with your branch of service to participate in this program.



## **Vietnam Exposed to Agent Orange Compensation**

The VA offers compensation to veterans who may have been exposed to the harmful chemical Agent Orange, or other potentially harmful herbicides. You may be eligible if you served in Vietnam anytime between January 9, 1962 and May 7, 1975, including brief visits ashore or service aboard a ship that operated on the inland waterways of Vietnam; or if you served in or near the Korean demilitarized zone anytime between April 1, 1968 and August 31, 1971

## **Global War on Terrorism Survivors Compensation**

You may be eligible for compensation if you are a survivor of someone killed by terrorist acts or hostile activities performing military services in periods not recognized as wartime by the United States campaign or service medals.

## **POW Compensation**

You may be eligible for POW compensation if you were active duty with the Armed Forces or employed by the United States Government on or after January 1, 1961, were a resident of Illinois 12 months prior to entry, and was taken and held prisoner by forces in South East Asia.

# **Pensions**

## **Disability Pension**

Disability Pension is a tax free benefit paid to wartime veterans with limited or no income who are permanently and 100% disabled.

- You may be eligible if you are discharged from service under non-dishonorable conditions, served 90 days or more of active duty with at least one day during war time, family income is below the yearly limit set by law, 100% or permanently disabled, and are 65 years of age or older.

## **Death Pension**

Death pension is a benefit for dependents of deceased wartime veterans.

- You may be eligible if the deceased veteran was discharged from service under non-dishonorable conditions, served 90 days or more of active duty with at least one day during wartime, surviving spouse or unmarried child, and income falls below the yearly income limit.

# **Additional Benefits**

## **Aid and Attendance**

Aid and attendance is a benefit along with monthly pension. This may not be paid without eligibility to pension.

- You may be eligible if you require aid of another person in order to perform personal functions for everyday living, adjusting to devices or protection, bedridden, in a nursing home, or is blind or nearly blind.

## **Housebound**

This increased amount may be added to your monthly pension when you are substantially confined to your immediate premises because of permanent disability.

**NOTE: You cannot receive Aid and Attendance and Housebound benefits at the same time.**

## **Concurrent Retirement/Disability Payments**

Concurrent Retirement/Disability Payments restore some or all military retired pay that was deducted due to VA service connected disability compensation.

- You are eligible if you are a member of the military who has served at least 20 years of creditable service and be 50% or more disabled. The disabilities do not have to be combat related. Enrollment is automatic.

# **Bonuses**

You may be eligible for monetary bonuses for war time service. To find more information about any of these bonuses or to download a copy of the bonus application that applies to you, please visit:

## **World War II Bonus**

You are eligible for this bonus—\$10 per month for domestic service and \$15 per month for foreign service—if you served at least 60 days of active duty between September 16, 1940 and September 3, 1945, were an Illinois resident at the time of service, and received an honorable discharge. If you are a survivor of a veteran who died in service during World War II within the specified period you are entitled to a benefit of \$1,000.

## **Korean War Bonus**

You are eligible for this \$100 bonus if you served between June 27, 1950 and July 27, 1953, received the Korean Service Medal, were a resident of Illinois 12 months prior to entering service, and were honorably discharged.

## **Vietnam War Bonus**

You are eligible for this \$100 bonus if you served in Vietnam between January 1, 1961 and March 28, 1973 or in Operation Frequent Wind Vietnam between April 29 and April 30 of 1975, received the Vietnam Service Medal or the Armed Forces Expeditionary Medal for Vietnam, were a resident of Illinois 12 months prior to entering service, and were honorably discharged. Survivors of a veteran whose death was classified as service-related by the U.S. Department of Veterans' Affairs are entitled to a \$1,000 benefit.

## **Persian Gulf War Bonus**

You are eligible for this \$100 bonus if you served between August 2, 1990 and November 30, 1995, received the Southwest Asia Service Medal, were honorably discharged, and lived in

Illinois for at least 12 months prior to service. Individuals currently on active duty who served in the Persian Gulf may apply prior to discharge by also including the Armed Forces Certificate.

### **Global War on Terrorism**

You are eligible for this \$100 bonus if you served on or after September 11, 2001, received the Global War on Terrorism Expeditionary Medal, Global War on Terrorism Service Medal, Afghanistan Campaign Medal, or the Iraq Campaign Medal, served at least 30 consecutive or 60 nonconsecutive days of foreign or sea service, lived in Illinois for at least 12 months prior to entering the service, and were honorably discharged. Individuals who are currently on active duty in the Global War on Terrorism can apply prior to discharge by also including the Armed Forces Certificate.

### **POW Compensation**

You are eligible for \$50 compensation for each month of captivity if you are on active duty with the Armed Forces of the United States or employed by the United States Government on or after January 1, 1961, lived in Illinois for at least 12 months prior to entry, and who were taken and held by hostile forces in Southeast Asia \$50 for each month held captive.

# Education and Training

## Financial Benefits

### Montgomery GI Bill

The MGIB-Selected Reserve program provides educational benefits to members of the Selected Reserve. Veterans can receive up to 36 months of education benefits in pursuit of, among other things, college degrees, certificate programs, technical or vocational training, apprenticeships, on-the-job training, and certain entrance examinations. Eligibility for the program typically ends the day you leave Selected Reserve but there are exceptions if you are currently mobilized. To qualify you must have a six-year obligation to serve in the Selected Reserve signed after June 30, 1985, have completed your initial active duty for training, meet the requirement to receive a high school diploma or equivalency certificate, and remain in good standing while serving in an active Selected Reserve unit. If you are an officer, you must have agreed to serve six years in addition to your original obligation.

The Montgomery GI Bill may also be available for active duty service members. The MGIB program provides up to 36 months of education benefits to eligible servicemen. To qualify you must have been honorably discharged, have a high school diploma or GED, and fall into one of four categories that can be found on the VA website ([www.benefits.va.gov/gibill/mgib\\_ad.asp](http://www.benefits.va.gov/gibill/mgib_ad.asp)). Generally, benefits are payable for 10 years following your release from active duty. This program is also commonly known as Chapter 30. For an additional \$600 contribution to the GI Bill, you may receive up to \$5400 in increased monthly benefits.

### Veterans Educational Assistance Program (VEAP)

The Veterans Educational Assistance Program provides educational benefits for veterans who entered service for the first time between January 1, 1977, and June 30, 1985; opened a contribution account before April 1, 1987; voluntarily contributed from \$25 to \$2700; completed their first period of service; and were discharged or released from service under conditions other than dishonorable. If you are currently on active duty and wish to receive VEAP benefits, you must have at least 3 months of contributions available.

## Vet Success

VA helps Veterans with service-connected disabilities to prepare for, obtain, and maintain suitable employment the Vocational Rehabilitation and Employment Vet Success program. Vet Success provides vocational counseling, job search assistance, and a variety of other educational and training services.

VetSuccess on Campus (VSOC) aims to help veterans, service members, and their qualified dependents complete their education and transition into the work field by providing on-campus benefits assistance and counseling. Each VSOC school has a VA Vocational Rehabilitation counselor and a VA Vet Center Outreach Coordinator to provide peer-to-peer counseling and referral services. ## Post 9/11 GI Bill

This is a new education program for those who served on active duty on or after September 11, 2001.

To be eligible you must have served at least 90 aggregate days on active duty after September 10, 2001 and remain on active duty or have been honorably discharged from active duty for a service-connected disability after serving 30 continuous days following September 10, 2001. Children of Service Member who died in the line of duty on or after September 11, 2011 may be eligible for Post-9/11 GI Bill benefits as well.

Service members or Veterans may receive up to 36 months of benefits. Eligibility generally expires 15 years after release from a period of active duty of at least 90 consecutive days. If released for a service-connected disability after at least 30 days of continuous service, eligibility ends 15 years from when the member is released for the service-connected disability.

Based on length of service, participants are entitled to cost of tuition and fees, a monthly housing allowance, and a yearly stipend of up to \$1000 for books and supplies.

## Yellow Ribbon GI Education Enhancement Program

The Yellow Ribbon GI Education Enhancement Program covers all in-state tuition and fees for a public school and at least part of the cost for private schools or out-of-state tuition. You may be eligible for this program if you served an aggregate period of at least 36 months of active duty

after September 10, 2001; you were honorably discharged from active duty for a service-connected disability and served 30 continuous days after September 10, 2001; or are a dependent who received benefits transferred from an eligible Service member. To apply you must contact your School Certifying Official.

### **Work Study Program**

Veterans who are full-time or  $\frac{3}{4}$ -time students in a college degree, vocational, or professional program can receive a VA work study allowance for a number of programs that can be found at <http://www.benefits.va.gov/gibill/workstudy.asp>.

The Illinois Department of Veterans' Affairs provides VA work-study opportunities at its numerous offices throughout Illinois. The federal VA work-study program provides part-time employment to students receiving VA education benefits who attend school three-quarter time or more. Work-study students are paid either the State or Federal minimum wage, whichever is greater.

**Please note:** Effective June 30, 2013 some work-study activities authorized by Congress expired. VA can no longer pay for certain work-study activities. These include:

- Outreach services to service-members and veterans furnished under the supervision of a State approving agency employee
- Hospital and domiciliary care and medical treatment to veterans in a State home when VA pays an allowance to the State for such care
- Any activity relating to the administration of a national cemetery or a State Veterans' cemetery

## **Teaching**

### **The Troops to Teaching Program**

The Troops to Teaching Program can help veterans with at least 3 years of honorable service and a bachelor's degree transition from the military to K-12 public school teaching. The program can also provide financial assistance of \$5,000 to those who enrolled in a certification program or a bonus of up to \$10,000 for teachers who serve a three -year commitment in any high needs school across the state.

# Grants

## Illinois Veteran Grant

The Illinois Veteran Grant Program pays tuition and certain fees at all Illinois state-supported colleges, universities and community colleges for eligible Illinois veterans. To be eligible, an individual must have resided in Illinois six months before entering service, have at least one full year of active duty military service from the State of Illinois, and have returned to Illinois within 6 months following honorable discharge.

## Illinois National Guard Grant

Illinois National Guard Grant provides enlisted persons with at least one year of service in the Illinois National Guard and who are enrolled in an Illinois public 2 or 4 year college with acceptable GPAs to apply.

# Scholarships

## Illinois Specific Scholarships

### Bright Start Fallen Heroes Scholarship

The State deposits \$2,500 in a Bright Start account for each child of a fallen service member who served in Operation Iraqi Freedom or Enduring Freedom upon the request of a surviving family member.

### Educational Aid for Children 10-18 years old

Aid available annually for children between the ages of 10 and 18 years of a Veteran who died or became totally disabled as a result of service in the Armed Forces during World War I or II, the Korean and Vietnam Conflicts, the Gulf War, and Operation Enduring Freedom or Operation Iraqi Freedom. The financial aid applies to a state educational institution of elementary grade, high school or vocational training school.

### **MIA/POW Scholarship**

This scholarship is open to dependents of veterans who have been declared by the Department of Defense or U.S. Department of Veterans Affairs to be a Prisoner of War or Missing In Action or who died on active duty or became 100% disabled from service-connected disabilities. The beneficiary must be a U.S. citizen under the age of 30 years old. Applicants must also be the survivor of a Veteran who was an Illinois residents at the time of entering their service, within 3 months after entering their service, or until July 1, 2014, became an Illinois resident within 6 months after leaving the service and can establish at least 30 years of continuous residency in Illinois. This scholarship can be used at public colleges in Illinois.

## Specially Adapted Housing Grant

The Specially Adapted Housing Grant is a federal benefit available to Veterans or service members who are entitled to compensation for permanent and total service-connected disability.

The Specially Adapted Housing benefit amount is set by law, but may be adjusted upward annually based on a cost-of-construction index. The maximum dollar amount allowable for Specially Adapted Housing grants in fiscal year 2013 is \$64,960. No individual may use the grant benefit more than three times up to the maximum dollar amount allowable.

## Specially Adapted Housing Tax Exemption

The specially adapted housing tax exemption is a state exemption allowed on the assessed value of real property for which federal funds have been used for the purchase or construction of specially adapted housing for as long as the Veteran, spouse, or unmarried surviving spouses reside on the property.

## Disabled Veterans' Tax Exemption for Mobile Homes

The disabled veterans' tax exemption for mobile homes applies to the tax imposed by the Mobile Home Local Services Tax Act when that property is owned and used exclusively by a disabled veteran, spouse, or unmarried surviving spouse as a home. Veteran must first receive authorization of the Specially Adapted Housing Grant by the USDVA. Applicant must be a permanent resident of the State of Illinois on January 1 of the tax year for which the exemption is

being claimed. Disabled veterans that now live in a mobile home and never received the Specially Adapted Housing Grant are not eligible.

### **Returning Veterans' Homestead Exemption**

The returning veterans' homestead exemption is a one-time \$5,000 reduction in EAV on the principal residence of a veteran upon returning from active duty in an armed conflict involving the armed forces of the United States. Although the exemption is only for a single year, a qualifying veteran can receive the exemption for another tax year in which he or she returns from active duty. Applicants must file Form PTAX-341, Application for Returning Veterans' Homestead Exemption, with the chief county assessment office.

### **Disabled Veterans' Standard Homestead Exemption**

The disabled veterans' standard homestead exemption is an annual reduction in EAV on the primary residence occupied by a qualified disabled veteran. The disabled veteran must own or lease a single family residence and be liable for the payment of the property taxes. The amount of the exemption depends on the percentage of the service-connected disability as certified by the U. S. Dept. of Veterans' Affairs. A qualified disabled veteran with a disability of at least 50% but less than 70% will receive a \$2,500 reduction in EAV, and a disabled veteran with a disability of at least 70% will receive a \$5,000 reduction in EAV.

The initial application Form PTAX-342 Application for Disabled Veterans' Standard Homestead Exemption must be filed with the chief county assessment office. The Form PTAX-342-R, Annual Verification of Eligibility for Disabled Veterans' Standard Homestead Exemption must be filed each year to continue to receive the exemption. For a single tax year, the property cannot receive this exemption and the Disabled Persons' Homestead Exemption or Disabled Veterans' Homestead Exemption.
