Dear Directors Haspel and Wray,

Over the past few months, localized misinformation about apparently nonexistent Antifa gatherings and "invasions" has proliferated in communities throughout the United States, sowing social and political division. The undersigned are inquiring about any definitive evidence gathered, or ongoing investigations, by federal authorities regarding the identities or nationalities of individuals originating and promoting these falsely advertised Antifa gatherings.

To date, the misinformation about Antifa gatherings has spread through Facebook, Twitter, Craigslist, and NextDoor.² These posts usually cite text messages – which appear to be variations of template messages – claiming active duty military personnel or members of local police departments provided the information. State and local authorities in the majority of these communities deny any involvement on the part of their department.³

In most cases, no individuals identifying as Antifa arrive at the locations identified in social media posts or template text messages; however, heavily armed counter protestors have arrived on several occasions. The apparent similarities in the dissemination methods to previously identified disinformation campaigns from foreign nationals and designated hate groups merit further investigation.


Below are exhibits of social media posts and template text messages regarding falsely advertised Antifa gatherings in Payette County, Idaho, and Fayetteville, North Carolina. In the instances of misinformation that spread through both Payette County and Fayetteville, the primary source of



the information is difficult to identify. The only identities of primary sourcing were supposed "friends" and "coworkers" with connections to police departments and the U.S. military.



Payette County, Idaho: The left image is from the Payette County Sheriff's Facebook page, containing a quoted template message about Antifa arriving in the Idaho by the "plane load." This message was shared widely over social media and direct text messaging platforms. [Left Exhibit Index⁴] The right image is from a redacted individual user sharing a template message warning about "attacks" being imminent in Boise, Idaho. The template post is recommending individuals maintain the possession of firearms, and around 40 to 50 armed individuals subsequently arrived in downtown Boise on June 1, 2020. No individuals identifying as Antifa were on scene. [Right Exhibit Index⁵]



Fayetteville, North Carolina: The left image is a message sent on Facebook messenger containing falsified rumors about the Greenville Police Department requesting support from surrounding agencies to deal with an influx of

individuals identifying as Antifa. Greenville PD denied any such request.⁶ [Left Exhibit Index⁷] The right image is a text message falsely stating that individuals identifying as Antifa were heading to "wealthy neighborhoods" in Fayetteville, North Carolina. [Right Exhibit Index⁸]

Unlike the misinformation shared in Payette County and Fayetteville, a supposed Antifa gathering in Gettysburg, Pennsylvania, that was set to occur on July 4, 2020, had an identifiable source on Facebook and Twitter. The social media accounts for "Left Behind USA," purporting to be representative of Antifa, posted explicit details of a flag-burning event at Gettysburg National Cemetery. When the identity of the administrator for the "Left Behind USA" accounts was inquired on by a national media outlet, the name "Alan Jeffs" was provided. According to the media outlet, there no known public records for this individual in the United States. 9

Antifa operatives did not show up on July 4, 2020, to Gettysburg National Cemetery, but hundreds of heavily armed counter protesters did arrive at the scene. At one point, the armed counter protestors surrounded and aggressively questioning a man in a "Black Lives Matter" shirt visiting an ancestor's grave. On several occasions, falsely advertised Antifa gatherings have been strategically placed at the same time and location as Black Lives Matter protests. Documented instances of armed individuals counter protesting a falsely advertised Antifa gathering but then encountering individuals peacefully protesting at Black Lives Matter include occurrences in Michigan¹¹, Montana, and Oregon¹³.

Gettysburg, Pennsylvania: The above images are Facebook and Twitter posts by the account "Left Behind USA" advertising a false Antifa sponsored flag burning event on July 4th, 2020. The account has been suspended on both platforms and the name of the individual supposedly administrating both accounts is not available in public records. The proliferation methods of misinformation on Antifa activities in June and July of 2020 are similarly structured to the disinformation deployed in the United States during the early stages of the COVID-19 pandemic. In both cases, template messages and social media posts were being sent under the false pretext of government, military, and local police authorities sharing this information with the sender or poster. In April 2020, several template messages and social media posts started to circulate regarding a false rumor that the federal government would invoke the Stafford Act in a given time frame, thus implementing a national "mandatory quarantine." Below are exhibit template text messages that were shared widely in April 2020.

From a friend of mine:

So.... military staff just got out of a 2-hour meeting....in 48-72 hours the President will issue a nation-wide 2 week mandatory quarantine under the Stafford Act. Make sure we have 2 weeks of necessities on hand.

You guys stay safe and pray!!!

Task Force just announced that advanced guidelines will go out to the public tomorrow.

Is this friend of yours in the military?

My client....
Within 48 to 72 Hours the president will evoke what is called the Stafford act. Just got off the phone with some of my military friends in DC who had a two hour briefing. The president will order a two week mandatory quarantine for the nation. Stock up on whatever you guys need to make sure you have a two week supply of everything.

COVID-19 Stafford Act Hoaxes: The above images are examples of template text messages shared during the early stages of the COVID-19 pandemic and warn of a pending lockdown to be enforced by the federal government. Both cite a military source, state that the Stafford Act will be invoked, and give the 48 to 72 hours timeline. [Exhibit Left Index¹⁸] [Right Exhibit Index¹⁹]

Twitter Inc. has stated that white supremacist groups have contributing to some of the localized disinformation campaigns around Antifa gatherings²⁰; however, U.S. intelligence officials reportedly determined that Chinese operatives carried out the misinformation campaigns around COVID-19 lockdowns.²¹ The practice of foreign nationals falsely advertising events to stoke political and social division between different groups in the United States is a procedure identified by the Federal Bureau of Investigations²², the Office of Special Counsel Robert Mueller²³, the Senate Permanent Select Committee on Intelligence²⁴, and the House Permanent Select Committee on Intelligence²⁵.

Congressional authorities are requesting the following information from the Federal Bureau of Investigations and the Central Intelligence Agency:

- 1.) Does the FBI or the CIA have any information regarding foreign nationals managing Antifa misinformation campaigns within the United States?
- 2.) Does the FBI or the CIA have knowledge of active duty military officials or state and local police officers that are sharing misinformation on falsely advertised Antifa events?
- 3.) Are federal authorities investigating the identity of the Facebook account "Left Behind USA" that promoted a flag burning event in Gettysburg, Pennsylvania, where an armed militia arrived on July 4, 2020?
 - a. Are federal authorities investigating the veracity of the identity for the individual, Alan Jeffs, who claimed to be managing the "Left Behind USA" social media page but has no known publicly available records in the United States?
 - b. Are federal authorities investigating the sophisticated cross-posting by Left Behind USA on Twitter, Facebook, and Change.org?
- 4.) Are federal authorities investigating the actions of the white supremacist groups Identity Evropa and American Guard, that both Twitter and Facebook claim to include the creation of multiple social media accounts posing as part of the Antifa movement?
- 5.) Do federal authorities have the identities of the individuals, organizations, or groups that promoted the Antifa gatherings in the following locations:
 - a. Toms River, New Jersey.
 - b. Sioux Falls, South Dakota.
 - c. Payette County, Idaho.
 - d. Klamath, Oregon.
 - e. Milan, Michigan.
 - f. Yucaipa, California.
 - g. Locust, North Carolina.
 - h. Forks, Washington.
 - i. Snohomish, Washington.
 - j. Sparta, Illinois

Congressman Raja Krishnamoorthi and Congressman Peter Welch, members of the House Permanent Select Committee on Intelligence, request answers to the above questions by July 22, 2020, and thank you both for your attention to this important matter.
