11	(a) Authorization.—Notwithstanding any other
12	provision of law and subject to subsection (b), the Sec-
13	retary of the Interior (acting through the Commissioner
14	of Reclamation) shall continue to treat the irrigation
15	pumping units known as the "Kinsey Irrigation Com-
16	pany" in Custer County, Montana and the "Sidney Water
17	Users Irrigation District" in Richland County, Montana,
18	or any successor to the Kinsey Irrigation Company or Sid-
19	ney Water Users Irrigation District, as irrigation pumping
20	units of the Pick-Sloan Missouri Basin Program for the
21	purposes of wheeling, administration, and payment of
22	project use power, including the applicability of provisions
23	relating to the treatment of costs beyond the ability to
24	pay under section 9 of the Act of December 22, 1944

- 3 (b) Limitation.—The quantity of power to be pro-
- 4 vided to the Kinsey Irrigation Company and the Sidney

- 6 to the Kinsey Irrigation Company or the Sidney Water
- 7 Users Irrigation District) under subsection (a) may not
- 8 exceed the maximum quantity of power provided to the
- 9 Kinsey Irrigation Company and the Sidney Water Users
- 10 Irrigation District under the applicable contract for elec-
- 11 tric service in effect on the date of enactment of this Act.
