# **A BILL**

To direct the Secretary of the Interior to conduct a special resource study of portions of the Los Angeles coastal area in the State of California to evaluate alternatives for protecting the resources of the coastal area, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Santa Monica Moun-*  
5 *tains National Recreation Area Boundary Adjustment*  
6 *Study Act”.*

7 **SEC. 2. RESOURCE STUDY OF THE LOS ANGELES COASTAL**  
8 **AREA, CALIFORNIA.**

9        (a) *DEFINITION OF STUDY AREA.*—*In this section, the*  
10 *term “study area” means the coastline and adjacent areas*  
11 *to the Santa Monica Bay from Will Rogers State Beach*  
12 *to Torrance Beach, including the areas in and around*  
13 *Ballona Creek and the Baldwin Hills and the San Pedro*  
14 *section of the City of Los Angeles, excluding the Port of Los*  
15 *Angeles north of Crescent Avenue.*

16        (b) *SPECIAL RESOURCE STUDY.*—

17            (1) *STUDY.*—*The Secretary shall conduct a spe-*  
18 *cial resource study of the study area.*

19            (2) *CONTENTS.*—*In conducting the study under*  
20 *paragraph (1), the Secretary shall—*

21                    (A) *evaluate the national significance of the*  
22 *study area;*

23                    (B) *determine the suitability and feasibility*  
24 *of designating the study area as a unit of the*  
25 *National Park System;*

1           (C) consider other alternatives for preserva-  
2           tion, protection, and interpretation of the study  
3           area by the Federal Government, State or local  
4           government entities, or private and nonprofit or-  
5           ganizations;

6           (D) consult with interested Federal agen-  
7           cies, State or local governmental entities, private  
8           and nonprofit organizations, or any other inter-  
9           ested individuals; and

10          (E) identify cost estimates for any Federal  
11          acquisition, development, interpretation, oper-  
12          ation, and maintenance associated with the al-  
13          ternatives.

14          (3) *APPLICABLE LAW.*—The study required  
15          under paragraph (1) shall be conducted in accordance  
16          with section 100507 of title 54, United States Code.

17          (4) *REPORT.*—Not later than 3 years after the  
18          date on which funds are first made available for the  
19          study under paragraph (1), the Secretary shall sub-  
20          mit to the Committee on Natural Resources of the  
21          House of Representatives and the Committee on En-  
22          ergy and Natural Resources of the Senate a report  
23          that describes—

24                 (A) the results of the study; and

1                    *(B) any conclusions and recommendations*  
2                    *of the Secretary.*
