

Manchester – 117th Federal Funding Snapshot

Topline Numbers:

- \$40.4 million in direct American Rescue Plan Act funding
- \$8 million in Federal grant funding
- 2 million in Infrastructure Investment and Jobs Act funding

American Rescue Plan Act (ARP) Funding:

- The Town of Manchester has received more than **\$40.4 million** in **ARP** funding:
 - \$13.8 million in Local Aid
 - \$11.8 million in County Aid
 - \$15.4 million in Educational Aid
- The Town of Manchester as so far allocated a portion of its ARP funding toward to following:
 - \$150,000 in rental payment assistance for eligible residents
 - A new social worker with the Manchester Police Department
 - A homelessness outreach by the Manchester Area Conference of Churches (MACC)

Federal Grants:

- **\$1.1 million** Emergency Connectivity Fund (ECF) to purchase laptops and internet equipment for students
- **\$120,000** Shuttered Venue Operators Grant (SVOG) for the Little Theatre of Manchester
- **\$227,415** Shuttered Venue Operators Grant (SVOG) for Parkade Cinemas
- **\$59,844** Shuttered Venue Operators Grant (SVOG) for CAST Inc.

- **\$100,000** Assistance to Firefighters grant (AFG) for the Manchester Fire Department for operations and safety training
- **\$2.2 million** Head Start grant for the Manchester Board of Education
- **\$145,258** for Humanities Initiatives at Community Colleges for Manchester Community College
- **\$14,447** in Emergency Head Start funding for Prospect Manchester Hospital
- **\$125,000** from the Community Development Financial Institutions Fund for Northeast Federal Credit Union
- **\$4 million** in Restaurant Revitalization Fund (RRF) grants for **19** Manchester restaurants:
 - **\$827,271** for Lucky Taco
 - **\$666,543** for Crab du Jour
 - **\$312,901** for Main Pub
 - **\$295,151** for Urban Lodge Brewing Company
 - **\$268,533** for Sarku Japan
