The entity to receive funding for this project is the University of California, Davis, located at One Shields Avenue, Davis, California, 95616.

This project entails the acquisition of a Gas Chromatography Triple Quadrupole Mass Spectrometer (GC-MS/MS) and an Ultra High-Pressure Liquid Chromatography Time-of-Flight Mass Spectrometer (UPLC-QTOF-MS) which are essential analytical equipment for grape smoke exposure research. The new research equipment will also support undergraduate and graduate training and curriculum development; and research outcomes will be extended to stakeholders and the wider community to increase understanding of wildfire smoke impact and best management practices. Researchers at the Department of Viticulture and Enology at the University of California, Davis have responded to its stakeholder needs with critical research needed to guide decision-making during smoke events as well as limit the impact thereof. However, as research is expanding, the rate of discovery and application development is dependent on the availability of advanced analytical equipment. Existing assessable analytical equipment cannot adequately support the essential research needed and currently undertaken at the department.
