To amend the Neotropical Migratory Bird Conservation Act to make improvements to that Act, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Neotropical Migratory

5 Bird Conservation Enhancements Act of 2022".

6 SEC. 2. NEOTROPICAL MIGRATORY BIRD CONSERVATION 7 ACT AMENDMENTS.

8 (a) FEDERAL SHARE.—Section 5(e)(1) of the9 Neotropical Migratory Bird Conservation Act (16 U.S.C.

1 6104(e)(1)) is amended by striking "25 percent" and in2 serting "50 percent".

3 (b) COOPERATION.—Section 7 of the Neotropical Mi4 gratory Bird Conservation Act (16 U.S.C. 6106) is
5 amended by adding at the end the following:

6 "(c) REPORT TO CONGRESS.—Not later than 180 7 days after the date of enactment of the Neotropical Migra-8 tory Bird Conservation Enhancements Act of 2022, the 9 Secretary shall submit to the Committee on Environment 10 and Public Works of the Senate and the Committee on Natural Resources of the House of Representatives a re-11 port describing the implementation of subsection (b) by 12 13 the Secretary, which shall include, if applicable, a description of the composition of the advisory group convened 14 15 under paragraph (1) of that subsection.".

(c) NEOTROPICAL MIGRATORY BIRD CONSERVATION
FUND ADMINISTRATIVE EXPENSES.—Section 9(c)(2) of
the Neotropical Migratory Bird Conservation Act (16
U.S.C. 6108(c)(2)) is amended by striking "3 percent or
up to \$100,000" and inserting "5 percent or up to
\$300,000".

(d) AUTHORIZATION OF APPROPRIATIONS.—Section
10 of the Neotropical Migratory Bird Conservation Act
(16 U.S.C. 6109) is amended by striking subsection (a)
and inserting the following:

2	propriated to carry out this Act—
3	"(1) for fiscal year 2023, \$20,000,000;
4	"(2) for fiscal year 2024, \$21,250,000;
5	"(3) for fiscal year 2025, \$22,500,000;
6	"(4) for fiscal year 2026, \$23,750,000; and
7	"(5) for fiscal year 2027, \$25,000,000.".
8	(e) Technical Corrections.—
9	(1) Section 4 of the Neotropical Migratory Bird
10	Conservation Act (16 U.S.C. 6103) is amended—
11	(A) by striking paragraph (1); and
12	(B) by redesignating paragraphs (2)
13	through (5) as paragraphs (1) through (4) , re-
14	spectively.
15	(2) Section $7(b)(1)$ of the Neotropical Migra-
16	tory Bird Conservation Act $(16 \text{ U.S.C. } 6106(b)(1))$
17	is amended, in the second sentence, by adding a pe-
18	riod at the end.
