Florida	Florida Department of Law Enforcement (FDLE) for all firearms, except licensees may contact the FBI for certain pawn transactions
Indiana	Indiana State Police for handguns; FBI for long guns
Iowa	Permit POC for handguns; FBI for long guns
Maryland	Maryland State Police for handguns; FBI for long guns and pawn redemptions
Michigan	Permit POC for handguns; FBI for long guns
Nebraska	Permit POC for handguns; FBI for long guns
New Hampshire	New Hampshire Department of Public Safety for handguns; FBI for long guns
North Carolina	Permit POC for handguns; FBI for long guns and pawn redemptions
Oregon	Oregon State Police for handguns; FBI for long guns
Washington	Chief Law Enforcement Officer for handguns; FBI for long guns and pawn redemptions
Wisconsin	Wisconsin Department of Justice for handguns; FBI for long guns

Delaware	* Concealed weapons permits issued after 05/16/96 and prior to 11/30/98
D.C.	* Firearms Purchase certificates issued prior to 11/30/98
Florida	* Concealed weapons permit issued prior to 11/30/98
Georgia	Concealed weapons permit
Guam	* Firearms Identification card issued prior to 11/30/98
Hawaii	Permits to acquire and licenses to carry
Idaho	Concealed weapons permit
Illinois	Firearm Owners ID Card ( <b>NOTE:</b> under State law, licensees still need to do a background check through FTIP)
Indiana	Personal protection and hunting and target permits
Iowa	Permit to purchase a handgun and concealed weapons permit
Kentucky	* Concealed weapons permits issued after 07/15/98 and prior to 11/30/98
Louisiana	* Concealed weapons permits issued prior to 11/30/98
Maryland	* Concealed weapons permits issued prior to 11/30/98
Massachusetts	* License to carry issued prior to 11/30/98
Michigan	Permit to purchase a handgun ( <b>NOTE:</b> concealed weapons permit does <b>not</b> qualify )
Minnesota	* Permit to acquire and permit to carry issued prior to 11/30/98
Mississippi	Concealed weapons permit issued to individuals - ( <b>NOTE:</b> the permit issued to security guards does <b>not</b> qualify)
Missouri	* Permit to acquire a concealable firearm issued prior to 11/30/98
Montana	Concealed weapons permit
Nebraska	Handgun purchase certificate
Nevada	Concealed weapons permit
New York	Licenses to carry and possess handguns
North Carolina	Permit to purchase a handgun Concealed handgun permit

STATE LAWS AND PUBLISHED ORDINANCES - FIREARMS (22<sup>ND</sup> EDITION)

North Dakota	Concealed weapons permits issued prior to 11/29/98, and concealed weapons permits issued on or after 12/01/99. <b>Permits issued beginning 11/30/98 through 11/30/99 do not qualify.</b>
Oklahoma	* Concealed weapons permits issued after 5/16/96 and prior to 11/30/98
Oregon	* Concealed weapons permits issued prior to 11/30/98
Pennsylvania	* Licenses to carry issued prior to 11/30/98. ( <b>NOTE:</b> State background check is still required with grandfathered permits)
South Carolina	Concealed weapons permits
South Dakota	* Concealed weapons permits issued prior to 11/30/98
Texas	Concealed weapons permit ( <b>NOTE:</b> Texas Peace Officer license, TCLEOSE Card, is <b>grandfathered only</b> )
U.S. Virgin Islands	All permits
Utah	Concealed weapons permit
Washington	* Concealed weapons permits issued after 07/01/96 and prior to 11/30/98
Wyoming	Concealed weapons permits
