

This reference sets out information concerning plans of Commissioner Eugene "Bull" Conner and Chief of Police T. A. Riley, of, Birmingham, to form a Birmingham Police Department Crime Laboratory (80-606-54). Connor and Riley requested help of the Bureau in setting up such a laboratory.

This information was submitted by Birmingham letter dated 12/26/37.

This reference, in the file captioned "Law Enforcement Officers Contacts by SAC" (66-3579), set out information concerning Bureau contacts with the Birmingham, Alabama PD and with Eugene Connor, Commissioner of Public Safety, during April 1939. On 4/12/39 Connor addressed the Police School graduation banquet held by the Birmingham PD, and referred to Er. Hoover and the FBI in the highest terms.

The following references contain information concerning an ordinance drafted in 1940 by Police Commissioner Eugene "Bull" Connor, Birmingham PD, to require the fingerprinting of all aliens in Birmingham. This ordinance had other clauses which were aimed directly at prosecution of any person engaged in any un-American activity whatsoever. Connor submitted a copy of this ordinance to the Bureau and requested any comment, approval, or disapproval of such ordinance. Connor was advised that the Bureau had no jurisdiction to make any comment on this matter.

An unidentified newspaper clipping in the files of the CONE Birmingham Office revealed that Laurent Frantz was subpoensed before the Dies Committee in Washington, D.C. in April 1940 for questioning concerning his activities in the CP. Frantz denied that he was a CP member and said that his arrest by the Birmingham PD was a violation of his civil rights. Eugene Connor of Birmingham upheld the arrest of Frantz and branded him as a communist.

This reference is an undated six-page document captioned "Press Digest On Sabotage, Espionage, and Related Matters" (65-18237), time-stamped in the Bureau on 7/8/40. Under the heading "Civil Liberties" it was stated that Commissioner Eugene Connor of Birmingham, Alabama had granted Jehovah's Witnesses their right under the law to circulate a petition but refused to guarantee immunity from arrest in case a householder should want to charge "trespass." The Judge ruled that it was contempt when on 10/26/40, police seized a print of a controversial motion picture film "French Girl's Club", several hours after an injunction had been issued to prevent interference with exhibition of the film.







Burnham, executive secretary of the SNYC was taken by detectives of the Birmingham Police Department on different occasions to City Commissioner Eugene Connor who warned Burnham that their "mixed meetings" were illegal in Birmingham.

The Justice Department further advised that in connection with events which took place in Birmingham before and after the meeting in question, it appeared that wilful violations of the civil rights statutes may have been committed by Commissioner Connor and the detectives involved, and it was requested by the Justice Department that Connor be interviewed to determine his version of all events in question, his understanding of the legal basis for the arrests, and if advisable, his motives and intentions in the matter.







This article stated that the mayors and police chiefs of fifty southern cities met in Jacksonville, Florida in early 1958 in an effort to halt the wave of dynamitings, and that this group invited the Anti-Defamation League (ADL) to furnish a list of known anti-Semites who would be suspected of this type of activity. One of the names furnished the group by the ADL was that of Commissioner Eugene "Bull" Connor of Birmingham, who was in attendance at the meeting, ostensibly to seek an end to these crimes.



The 9/12/58 issue of the "Birmingham News" carried an article entitled "Connor Slams Door in Face of Rights Probers." This article stated that Commissioner Eugene Connor on that date closed the doors of the Birmingham city jail and refused police cooperation with any federal civil rights investigators or U.S. marshals involved in integration incidents.

The 9/13/58 issue of the "Mobile Press," Nobile, Alabama, carried an article entitled "Paterson Says Alabama's Schools Will Not Be Mixed" which quoted Birmingham Police Commissioner Eugene Connor as stating that the Supreme Court's school integration order could trigger a season of violence in the South. He stated further that "It means that blood of both races will run in the streets."

On 10/28/58, Wilson White\* advised that the Chief of Police at Birmingham, "Bull" Connor, had been involved in a flagrant situation which he, White, had just discussed with the US Attorney in Birmingham. White stated that the Reverend Shuttlesworth had gotten on a bus in Birmingham the previous week and had failed to observe the Jim Crow regulations and was thereupon arrested by the police. The Reverend Martin Luther King sent a committee of three to visit Shuttlesworth. While these individuals were at Shuttlesworth's home on 10/27/58 they were arrested at about 11:00 a.m. by the police and held without charges until later in the day when they were released.

White believed that a preliminary inquiry into a violation of Civil Rights should be made.


The 10/30/58 issue of the "Mobile Register," Mobile, Alabama, reported that on 10/26/58, three Negro ministers were arrested in Birmingham on vagrancy charges and were held for several hours before they were released and the charges dropped. According to this article the Justice Department, Washington, D.C. disclosed that it was investigating the arrest of these individuals to determine whether their civil rights had been violated.

According to this article Police Commissioner Eugene Connor stated that Birmingham "does not need any outside agitators coming into our city and dabbling into our affairs."

This article stated that on11/13/58, Attorney General Rogers asked for an immediate Grand Jury probe after Commissioner Eugene Connor ordered the police officers of the Birmingham Police Department not to give information to the FBI about the arrest of three Negro ministers on 10/27/58. Hanibal Hillmon Hubbard (44-13806) was one of these ministers. Judge Seybourn Lynne refused to recall the Grand Jury before 2/10/59.

Connor was very complimentary to the Laboratory, and it is felt that he is, although rather slowly, yet surely, becoming more of a friend of the Bureau each day. Evidence of this was his statement made before several people, 'Anybody who won't cooperate with the FBI ain't honest'."

The 10/24/59 issue of the "Birmingham Post-Herald", in an article captioned "Connor Says He'11 Run for Committee," reported that on 10/23/59 Eugene Connor stated that he intended to run for Democratic National Committeeman from Alabama. Connor was a delegate to the national convention in 1948 and was among the "walk-out" delegates who protested the strong civil rights platform of the Democratic Party.

The following references are newspaper clippings which appear in the file captioned "Segregation" and contain information concerning the efforts of Commissioner Eugene Connor to maintain segregation. Connor asked Pastor F. L. Shuttlesworth to take a lie test concerning the bombing of his church and home in Birmingham on 12/25/56. Shuttlesworth stated that he would submit to such a test if Connor would submit to a lie test concerning his MGC sympathies, graft and corruption in the Birmingham PD, Connor's participation in bombings, and whether Connor encouraged police brutality. Connor did not submit to such a test.

Connor, in campaigning for the position of delegate to the Democratic National Convention, wrote to President Kennedy to determine Kennedy's position on civil rights.







The Birmingham Office fowarded a copy of a letter addressed to Eugene (Bull) Connor, Police Commissioner, Birmingham, Alabama, which had been received by the "Birmingham News." This letter, signed "An organization dedicated to freedom" was postmarked at Washington, D.C. on 5/16/61 and accused Connor of failure to enforce the law with equality toward all races. This letter was critical of Connor concerning a racial incident which happened on 5/14/61.

The Birmingham Office recommended that no investigation be conducted.

The following references contain information concerning the arrival of members of the Congress of Racial Equality (CORE) at the Birmingham Bus Station on 5/14/61. Information was set out concerning the activities of Police Commissioner Eugene Connor in handling matters pertaining to this group, also known as Freedom Riders.

Connor was alleged to have encouraged members of the KKK to use violence against the Negroes when they arrived at the bus station, and he was reported to have stated that if a Klansman were arrested for so doing he would receive a light sentence.

On the morning of 5/14/41, a telegram was sent to Connor demanding protection for riders of the Greyhound Bus due to arrive in Birmingham at 11:00 A.M. that day. Later in the day the bus was burned at Anniston, Alabama before it reached Birmingham. Connor was reported to have remained at City Hall in Birmingham all day on 5/14/61.

Many of these individuals, also known as the "Freedom Riders," were arrested after their arrival at the Greyhound bus station and placed in the Birmingham jail. Information was set out concerning the activities of Eugene "Bull" Connor, as Police Commissioner, in handling this situation.

It was reported that at about midnight or early morning of 5/19/61, Connor released these individuals from jail and had them transported to the Alabama State line.

On 5/24/61, the Justice Department petitioned the U.S. District Court, Middle District of Alabama to include Connor and other Alabama public officials as defendants in a temporary injunction, previously obtained, which restrained certain organizations from interfering with the "Freedom Riders." Connor was charged with failing to provide police protection for persons traveling in interstate commerce through Birmingham, Alabama. At hearing held in the above court at Montgomery, Alabama, on 5/29/61-6/2/61, Connor was released from the injunction on termination of government testimony.

The "Post Herald" article reported that Connor said "that as long as Robert Kennedy is using the FBI to prosecute the peace officers of the city of Eirmingham...they need not expect the PD of Birmingham to continue our policy of cooperation and assistance to them. If they have no confidence in us, it is just human nature that we have no confidence in them."

The Birmingham Office noted that the Birmingham PD had been cooperative with that office in the past, and that it was not known whether the statement made by Connor was a new policy. It was further noted that since the above mentioned speech, contact had been made with the Birmingham FD with respect to investigations in certain cases and that no indication was given that they would not cooperate with the Bureau.

On 12/17/62, the SAC of the Birmingham Office met with Public Safety Commissioner Eugene "Bull" Connor and his top ranking officers concerning the progress in the case of the bombing of Bethel Baptist Church, Birmingham, on 12/14/62 (157-762). Connor stated that he wanted to do everything possible to solve this case and had ordered a sweeping inquiry to include both white and Negro suspects. He ordered his officers to fully explore the possibility that any individuals known to have been active in "RAK matters" might have had anything to do with the bombing.

Page 5 of the 3/19/62 issue of the "South" published at Auburn, Alabama by the Alabama News Magazine, Incorporated, carried an article entitled "Gubernatorial Openers Mild But Promise Slugging Later". This article stated that during the previous week Eugene "Bull" Connor, candidate for governor of Alabama, spoke at a rally held in a down-town theater in Birmingham. In this speech, Connor promised to "sic the Highway Patrol on any and all federal marshalls sent into Alabama in connection with racial matters." Connor spoke favorably in regard to old-age pensions and the advancement of education.

Publications-Alphabetical Section, "South" 3/19/62, p. 5,6 (2,22)

This reference is a press release by the Washington Capital News Service dated 1/17/62 which stated that Police Commissioner Eugene "Bull" Connor announced that day that he would run for Governor of Alabama in the 5/1/62 Democratic primary. He indicated that the race issue would be in the fore of his campaign. Connor, a strong segregationist, said in a statement that Alabama "needs a governor in the coming four years whom the people can trust completely on this (race) issue. One who they know will do everything that can be done to stop the slaughter of the rights of the states to make and enforce their own laws on local issues."

A "Washington Capital News Service" release, issued on 12/9/61, stated that on 12/8/61, a suit was filed in Circuit Court, Birmingham by Eugene Connor against the Columbia Broadcasting System, for libel over a race relations telecast. This television program, broadcast on 5/18/61, dealt with race relations in Birmingham. Connor asked for \$500,000 for alleged defamation which he had suffered as a result of the program.

The following references in the file captioned "Testing of Bus Facilities Subsequent to 11/1/61" (157-452) contain information concerning the arrest of Ralph R. Sizemore, manager of the lunch room of the Greyhound Bus Station, Birmingham, on 11/3/61.

Sizemore was arrested on orders of Police Commissioner Eugene "Bull" Connor for allowing whites and Negroes to eat together in the lunch room in violation of a Birmingham segregation ordinance.

On 12/14/61, the U.S. Attorney filed a petition in US District Court naming the City of Birmingham together with Connor and other officials as defendants and enjoined them to cease from making further arrests in such cases.

On 12/20/61, Connor gave a release to the newspapers stating the text of a letter he had written to President Kennedy requesting an interview. According to the news release the President ignored Connor's letter.

"Bull" Connor had directed that such information or the Police Department
files not be furnished to Bureau Agents in Civil Rights matters on a
general basis. Explained that this policy had been brought about
due to the fact that an increasing number of this type of case had arisen,
and that it was the opinion of Connor that in practically all of these
cases the complaints had been determined through investigation by the
PD to be without foundation. Explaints had been instigated by Negro organizations
such as the NAACP or the group led by Reverend Fred Shuttlesworth.


On 10/14/61, Connor visited the Birmingham Office to offer assistance in a bank robbery investigation being conducted by the Birmingham Office. It was well known, however, that Connor was most outspoken against integration of the races.

It was noted by I gents in recent interviews with in connection with Civil Rights matters that he had made statements indicating that Commissioner Conner had become more pronounced in his criticism of the FBI and the Justice Department in conducting Civil Rights investigations. It appeared that Connor's attitude may have resulted from injunction proceedings brought by the Justice Department against the Birmingham PD in connection with the "Freedom Riders" incident in Alabama.

The 11/17/61 issue of the "Birmingham News" carried an article captioned "Connor Proposes Dixie 'Manifesto'".
