Date 4/27/81

Re: ATKID

By attached teletype, Atlanta advises that the body of Joseph Bell was discovered on 4/19/81 in the South River in DeKalb County.

The body of Michael McIntosh was discovered on 4/20/81 in the Chattahoochee River in Atlanta. McIntosh, a 23 year old black male, had not been reported missing, but due to the circumstances surrounding his death and discovery of his body, he was added to the list of missing and murdered children.

On 4/22/81, Roy Innis, a member and possible official of the Congress of Racial Equality (CORE), arrived in Atlanta with a "secret witness" who claimed to know the ATKID killer. Innis gave authorities 72 hours to apprehend his suspect or threatened his group would apprehend the suspect.

On 4/27/81, Atlanta will institute surveillances of 14 selected bridges which could be possible dumping sites over the Chattahoochee River.

a very few seconds, so the victim would not even have a chance to struggle inside, thus leaving no marks on the body.

I think it is a mistake to only follow the reasoning that the killer has it in for black children, and therefore chooses only them as his victims. I think he chooses children because they are small enough to fit into his decompression chamber, not because his hatred is aimed at them in particular. I think he chooses children and mentally-slow people, in addition, because of their gullibility. I think he chooses to concentrate his efforts in poor, black neighborhoods because he subscribes to the myth that blacks are born hustlers and will not hesitate when quick money is offered.

The killer might even be a dog pound employee, and is using equipment located at the City Pound. However, I think that few children would be so naive not to suspect something under these conditions. Another plausible solution would be that he is a well-known local businessman, who owns a construction or concrete prefabrication type business. Disguising the device as a cement-mixer or other type of industrial equipment, he asks children at shopping centers if they want to make some easy money working for him. Since the victim knows and trusts him, he doesn't think to be afraid.

One way to try to uncover clues would be to question people at area kennels, dog pounds and humane societies if they know of any decompression equipment that was sold or junked at about the time the murders started, and where and to whom the equipment was transferred. I think people who are involved in ASPCA and other area animal husbandry activities are the people you should be talking to now. You might find someone who remembers where an old decompression unit changed hands awhile ago.

I think the animal decompression chamber theory is a solid one because it alone accounts for the evidential facts of small sized ^{VICTIMS} and no marks on the body. If the killer made his own decompression chamber, he probably wouldn't make it so small so as to create a size restriction for his victims. And the design specifications of humane society units insure a quick, humane death without struggle.

I hope this information is a help to you. I hope your investigations are successful very soon.

Attached teletype sets forth a summary of investigation conducted during the week of 5/10 - 15/81 concerning captioned matter.

A background investigation is being conducted on homicide victim number 27, William Barrett, whose body was discovered on 5/12/81. Victim's death resulted from ligature strangulation.

A surveillance of fourteen bridges in the metropolitan area of Atlanta, Georgia, is currently being conducted in an attempt to apprehend the unsub while disposing of the body of one of his victims. The surveillances are being conducted every night from dusk until dawn. Fourteen Special Agents (SAs) from other FBI Divisions have been temporarily assigned to assist in this project for a two-week period that will be discontinued on 5/22/81.

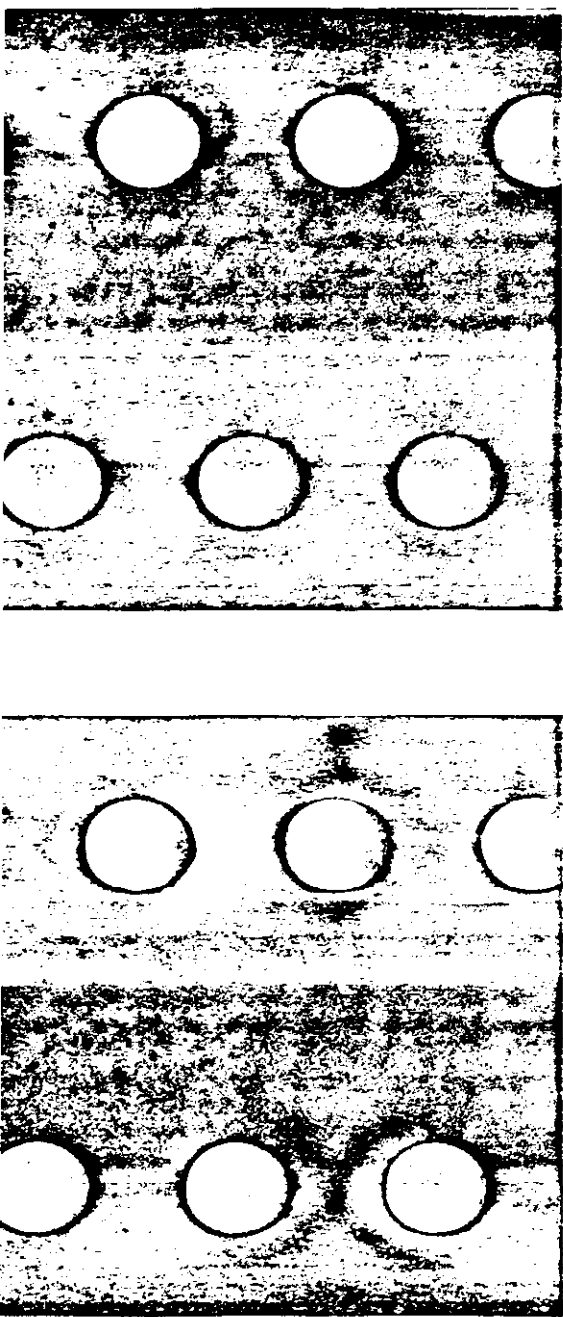

Victim was identified through fingerprint comparisons at the Atlanta Police Department (APD). The records of the APD revealed that victim has used alias of Nathaniel Carter and was further described as follows: DOB 5/29/53; height, five feet eleven inches; weight, 146 pounds; FBI # 784 476 J3.

An autopsy performed by the Fulton County Medical Examiner on 5/25/81, determined cause of death was ligature strangulation. No missing person report had been received by the APD prior to recovery of the body.

Cater has been added to the Task Force list of murdered and/or missing residents of the City of Atlanta, Georgia. The names of the victims on the list presently total 29.

Douglas Officials Checking Alibi Of 'Suspect' In Duncan's Death

By Ken Willis

An out-of-state man being questioned in one of the 27 cases of Atlanta's slain children and young adults provided Douglas County authorities an alibi that was being checked by investigators Friday.

"When we were looking for this man and thinking of him as a suspect, we first thought he was a 10," said one source familiar with the investigation. "Now we think he's a three as a possible suspect," he said.

Douglas County Sheriff Earl Lee disclosed earlier this week that his investigators had located a man who resembled the person last seen with 21-year-old Eddie "Bubba" Duncan. The young black male's decomposed body was pulled from the Chattahoochee River on March 31.

He had disappeared from the Techwood Homes housing

project in Atlanta, where he lived, on March 20.

Some of his friends said Duncan had told them that he was going to help somebody move to North Carolina or South Carolina.

Several weeks ago, Douglas County investigators developed a composite drawing of the man last seen with Duncan — a black male with short hair. Douglas, FBI and Atlanta authorities circulated the composite around various Atlanta communities and learned the identity of the out-of-state person, the source said.

But that person told investigators that he had not been in Atlanta recently, and the investigators were checking Friday to see if he had been where he claimed, according to the source.

Meanwhile Friday, State Crime Lab Director Larry Howard confirmed that an FBI specialist has reviewed the physical evidence found in the cases of Atlanta's slain

children and has agreed with Howard that fibers found on some of the bodies "are important in linkage" of some of the cases.

The crime lab has found similar fibers — such as those that come from carpets or blankets — on the bodies of many of the victims and has contended that they are evidence that at least some of the children have been slain by the same killer or killers.

However, a number of metropolitan Atlanta lawmen have grown skeptical about that theory, contending that the fiber evidence is too vague. Some of the lawmen requested that the FBI take a look and render an opinion.

In another development, Atlanta police issued a general-alarm lookout for Ronald Crawford, a 22-year-old black man — described as slightly mentally disturbed —

who disappeared from his southeast Atlanta home on Monday. Crawford's mother reported him missing on Wednesday night. He was described as 6 feet, 1 inch tall and weighing 140 pounds.

Police said another youth who had been reported missing, 20-year-old Bobby Lee Thomas, was found alive Friday.

ACTION MEMORANDUM

The Federal Bureau of Investigation (FBI) was authorized and requested by former Attorney General Benjamin R. Civiletti, on November 6, 1980, to initiate an immediate preliminary investigation to determine whether the missing black children in the Atlanta, Georgia, area were being held in violation of the Federal Kidnaping Law, Title 18, United States Code (USC), Section 1201. On November 17, 1980, the Atlanta Office of the FBI commenced a Major Case investigation into the murdered/missing children.

One recent investigative technique utilized by the Atlanta Office of the FBI has been instituting a surveillance of various bridges which cross both the Chattahoochee River and the South River. As a result of these surveillances, on May 22, 1981, an individual was observed crossing over the Chattahoochee River at 2:52 a.m. At the time this vehicle was crossing the bridge, a loud splash was heard in the river by the bridge surveillance teams. Based on a reasonable suspicion, the suspect's vehicle was stopped and identifying data obtained. The suspect, Wayne Bertram Williams, denied stopping on the bridge or discarding any debris into the river.

On May 26, 1981, the body of victim Nathaniel Cater was found approximately one-half mile downstream from the bridge upon which the suspect Williams was traveling. Entertainment Corporation, distributing brochures to youths age eleven through twenty-one years in an attempt to solicit talent prospects in that age group, Williams is considered, at this time, a prime suspect.

The Atlanta Office of the FBI, in conjunction with the U. S. Attorney's Office and the Attorney General's Office for the State of Georgia, are pursuing installation of a beeper tracking system on the suspect Williams' car and installation of a microphone in the suspect's car. Provisions of the State of Georgia Code Annotated provide for electronic surveillance under Section 26-3001, Et Seq, for peace officers to install and monitor electronic surveillances with the FBI being considered as peace officers under the definition, Section 26-401, and specific exception for law enforcement under Section 26-2004 of the State of Georgia Code Annotated.

On May 27, 1981, an affidavit was being drafted by both the U. S. Attorney's Office, Atlanta, Georgia, and the Attorney General's Office, State of Georgia, for authorization to place the automobile beeper tracking system on suspect Williams' car. In anticipation of the imminent drafting of an affidavit for a State of Georgia electronic surveillance, a microphone in suspect Williams' car, a request has been made by the State of Georgia through the Attorney General's Office for the FBI to participate in monitoring this surveillance and to install the microphone. U. S. Department of Justice Order #890-80, dated April 29, 1980, entitled "Delegation to the Assistant Attorney General, Criminal Division, of the Authority to Lend Electronic Surveillance Equipment," specifically states in Section (g), "No FBI personnel may be used to install the equipment or participate in the surveillance. This does not prohibit maintenance and repair of the equipment when not installed."

Due to the sensitivity both of the investigation and the suspect developed, as well as the sophisticated nature and complexity of the contemplated microphone equipment to be used, it is specifically requested that for this instance an exception be made to Departmental Order #890-80, Section (g), to allow the FBI to participate to the maximum extent possible with State authorities in both the installation and monitoring of this State of Georgia electronic surveillance. The nature of this equipment is such that an experienced individual is required to insure adequate installation and efficient functioning. The FBI possesses both the equipment and expertise needed.

Williams' vehicle a 1970, white Chevrolet station wagon, was stopped and identifying data concerning suspect obtained. He denied stopping on the bridge or discarding any debris into the river.

The Atlanta Division has determined that Williams is the Vice President of the Nova Entertainment Corporation; and in that capacity distributes brochures to youths aged 11 - 21 years in an attempt to solicit talent prospects in that age group. Williams resides with his parents in a black neighborhood on Penelope Street, N. W., Atlanta, Georgia, and apparently is an intelligent individual since at the age of 12, he began a small business. He was arrested in Atlanta, Georgia, on 5/17/76 for impersonating a police officer and unauthorized use of a vehicle. Williams had utilized a blue police light in his vehicle to simulate a law enforcement officer. Further details regarding the arrest were not available.

An attempt is being made to obtain a fixed surveillance site near his home in a rental house or an apartment for the purpose of establishing a discrete observation area.

A photographic spread is being prepared to exhibit to employees of the "Cameo" bar where victim Cater was seen on the evening of 5/21/81.

In response to SAC, Atlanta's request concerning surveillance manpower and equipment the Administrative Services Division and Technical Services Division has directed the Chicago and Philadelphia Divisions to furnish three surveillance SAs and one SA pilot, each for this matter. The Chicago Division will furnish a fixed wing aircraft.

The Identification Division, Latent Fingerprint Section, has been requested to compare the latents in this case to the fingerprints of Williams under FBI # 847-900 P9. It was determined that Williams' employment on the arrest in 1976 was listed as a news reporter for WBIE Radio in Marietta, Georgia.

An Assistant U. S. Attorney in Atlanta, Georgia, is preparing a court order for the use of an electronic tracking device to be placed on Williams' vehicle as required by state law in Georgia. In addition, the AUSA is preparing an affidavit in support of an application for a state authorized oral interception of communications, without consent, to be placed in suspects vehicle. The affiant will be the Attorney General of the State of Georgia. Five selected bridges are currently under surveillance from dusk until dawn.

It should be noted that select officers from the task force will be assigned to each surveillance vehicle to assist in this joint effort.

ACTION MEMORANDUM

The Federal Bureau of Investigation (FBI) was authorized and requested by former Attorney General Benjamin R. Civiletti, on November 6, 1980, to initiate an immediate preliminary investigation to determine whether the missing black children in the Atlanta, Georgia, area were being held in violation of the Federal Kidnaping Law, Title 18, United States Code (USC), Section 1201. On November 17, 1980, the Atlanta Office of the FBI commenced a Major Case investigation into the murdered/missing children.

One recent investigative technique utilized by the Atlanta Office of the FBI has been instituting a surveillance of various bridges which cross both the Chattahoochee River and the South River. As a result of these surveillances, on May 22, 1981, an individual was observed crossing over the Chattahoochee river at 2:52 a.m. At the time this vehicle was crossing the bridge, a loud splash was heard in the river by the bridge surveillance teams. Based on a reasonable suspicion, the suspect's vehicle was stopped and identifying data obtained. The suspect, Wayne Bertram Williams, denied stopping on the bridge or discarding any debris into the river.

On May 26, 1981, the body of victim Nathaniel Cater was found approximately one-half mile downstream from the bridge upon which the suspect Williams was traveling. Based on background information developed, to include the reason provided by suspect Williams for being at the particular bridge on May 22, 1981, which did not check out, the fact that suspect Williams has a previous arrest in Atlanta for impersonating a police officer with a blue light on his automobile, and the fact that Williams is employed as Vice-President, NOVA

Entertainment Corporation, distributing brochures to youths age eleven through twenty-one years in an attempt to solicit talent prospects in that age group, Williams is considered, at this time, a prime suspect.

The Atlanta Office of the FBI, in conjunction with the U. S. Attorney's Office and the Attorney General's Office for the State of Georgia, are pursuing installation of a beeper tracking system on the suspect Williams' car and installation of a microphone in the suspect's car. Provisions of the State of Georgia Code Annotated provide for electronic surveillance under Section 26-3001, Et Seq, for peace officers to install and monitor electronic surveillances with the FBI being considered as peace officers under the definition, Section 26-401, and specific exception for law enforcement under Section 26-2004 of the State of Georgia Code Annotated.

On May 27, 1981, an affidavit was being drafted by both the U. S. Attorney's Office, Atlanta, Georgia, and the Attorney General's Office, State of Georgia, for authorization to place the automobile beeper tracking system on suspect Williams' car. In anticipation of the imminent drafting of an affidavit for a State of Georgia electronic surveillance, a microphone in suspect Williams' car, a request has been made by the State of Georgia through the Attorney General's Office for the FBI to participate in monitoring this surveillance and to install the microphone. U. S. Department of Justice Order #890-80, dated April 29, 1980, entitled "Delegation to the Assistant Attorney General, Criminal Division, of the Authority to Lend Electronic Surveillance Equipment," specifically states in Section (g), "No FBI personnel may be used to install the equipment or participate in the surveillance. This does not prohibit maintenance and repair of the equipment when not installed."

Due to the sensitivity both of the investigation and the suspect developed, as well as the sophisticated nature and complexity of the contemplated microphone equipment to be used, it is specifically requested that for this instance an exception be made to Departmental Order #890-80, Section (g), to allow the FBI to participate to the maximum extent possible with State authorities in both the installation and monitoring of this State of Georgia electronic surveillance. The nature of this equipment is such that an experienced individual is required to insure adequate installation and efficient functioning. The FBI possesses both the equipment and expertise needed.

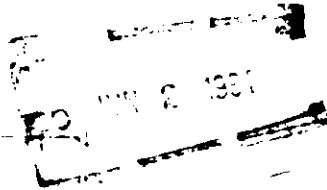

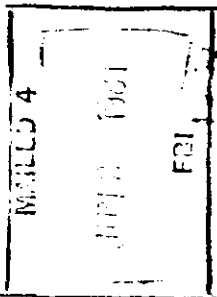

By attached teletype, the Atlanta Division advises that a synopsis of investigation conducted during the week of 5/24-28/81 is as follows:

The body of Nathaniel Cater was found floating face down in the Chattahoochee River on Sunday, 5/24/81, after he was last seen at 8:30 pm, Thursday, 5/21/81, at a bar in downtown Atlanta.

During the early morning hours of Friday, 5/22/81, a surveillance of the bridge located at the James-Jackson Parkway and Chattahoochee River resulted in an individual being stopped after having dropped an object from the bridge. This individual was subsequently identified as Wayne Bertram Williams.

A photo spread, including a photo of Wayne Bertram Williams, displayed in bars victim frequented has failed to produce any positive results. A photo spread, which contained a photo of Williams, was displayed to [redacted] who was kidnapped by an unknown subject in 2/81, and [redacted] advised that the photo of Williams strongly resembles the individual who kidnapped him.

Atlanta is currently in the process of instituting a 24-hour physical and electronic surveillance of Williams and plans to continue this surveillance for approximately two weeks.

CHILD DEATHS (TOPS NO45)

RINKEVICH NOTIFIED OFFICIALS IN ATLANTA, FULTON AND DEKALB COUNTIES OF THE ALLOCATION AFTER HE RECEIVED WORD FROM VICE PRESIDENT GEORGE BUSH LATE THIS MORNING.

"THEY (MAYOR MAYNARD JACKSON AND COUNTY OFFICIALS) SEEMED APPRECIATIVE," RINKEVICH SAID.

THE MONEY COMES FROM THE JUSTICE DEPARTMENT'S OFFICE OF JUVENILE JUSTICE AND DELINQUENCY PREVENTION, THE COMMUNITY SERVICES ADMINISTRATION AND THE DEPARTMENTS OF LABOR AND HEALTH AND HUMAN SERVICES, RINKEVICH SAID.

"WE THANK GOD FOR OUR CHILDREN, EVEN AS THEY CRY OUT FROM THE GRAVE," HE SAID. THE CROWD RESPONDED, CHANTING, "SAVE THE CHILDREN. SAVE THE CHILDREN."

POLICE ESTIMATED THE CROWD AT ABOUT 5,000, AND IT CONTINUED TO GROW THROUGHOUT THE PROCEEDINGS.

A 29-YEAR-OLD CARPENTER NAMED GEORGE YOUNG CARRIED A SIGN READING: "WILL THERE BE 28 MORE? PRAY FOR THE CHILDREN."

WILLIE MAE MATHIS, WHOSE SON JEFFREY WAS AN ATLANTA VICTIM, AND CAMILLE BELL, WHOSE SON YUSEF ALSO WAS KILLED, WERE AMONG THOSE PRESENT.

A MENTALLY RETARDED BLACK MAN WHO HAD BEEN MISSING SINCE MAY 15 -- RONALD CRAWFORD, 22 -- BRIEFLY BECAME THE 30TH NAME ON THE TASK FORCE LIST MONDAY, BUT CALLED HIS FAMILY AFTER HEARING NEWS REPORTS, POLICE SAID EARLY TODAY.

"HE TOLD HIS MOTHER THAT HE WAS PICKING PEACHES, SOMEWHERE IN THE AUGUSTA AREA," A POLICE SPOKESMAN SAID.

POLICE SAID THEY EXPECTED TO WITHHOLD UNTIL TODAY THE NAME OF THE LATEST VICTIM, IDENTIFIED SUNDAY THROUGH FINGERPRINTS AND MEDICAL RECORDS, TO GIVE THEM TIME TO FURTHER INVESTIGATE THE CASE. SOURCES TOLD UPI YESTERDAY THE LATEST VICTIM WAS 29 AND WAS IN CONTACT WITH FAMILY MEMBERS LAST WEEK.

By attached teletype, the Atlanta Division advises that on 5/22/81 a bridge surveillance team, including one SA, was in place at the James-Jackson Parkway and Chattahoochee River. At approximately 2:52 am, a loud splash was heard in the river under the bridge, and thereafter an automobile was observed on the bridge apparently immediately above where the sound of the splash originated.

A vehicle was thereafter observed slowly accelerating across the bridge, and after turning around in a parking lot, it was observed proceeding back across the bridge. A moving surveillance instituted by a police officer and the SA culminated when the vehicle was stopped after entering a major thoroughfare.

The driver of the vehicle, a 1970 white Chevrolet stationwagon, was identified as Wayne Bertram Williams. Williams advised that he was a talent scout and had a 6 am appointment in the area of the James-Jackson Parkway. He denied stopping on the bridge or discarding debris into the river. Williams consented to a search of his vehicle and was thereafter allowed to proceed for lack of probable cause to detain him any further.

On 5/22/81 and 5/23/81, the Chattahoochee River in the vicinity of the James-Jackson Bridge was dragged and the roadway thoroughly

searched. Additionally, on 5/22/81, Williams was interviewed at his residence where he resides with his parents.

On 5/24/81, the body of victim Nathaniel Cater was found approximately one-half mile downstream from the James-Jackson Bridge. On 5/26/81, Fulton County Medical Examiner advised that Cater died from asphyxiation.

Atlanta has determined that the reason provided by Williams for being at the James-Jackson Bridge on 5/22/81 is not credible. Williams is described as a Black male, DOB 5/27/58, 5'7", 155 lbs., with a previous arrest in Atlanta for impersonating a police officer with a blue light in an automobile.

Atlanta desires to institute a 24-hour surveillance of Williams effective 5/29/81 and is currently developing logistics, including request for additional SAs, Bureau vehicles and aircraft.
