

THE INDOCHINA WAR IS NOT OVER

THE POST-WAR WAR slide show tells how American involvement in Vietnam has changed since January 27, 1973 when the Peace Agreement was signed. American military personnel were required to leave Vietnam, but American equipment and civilian advisers are still there.

Our government continues to pour billions of our tax dollars into South Vietnam. This year the Administration has requested over \$2 billion. This money enables General Thieu's army to go on fighting and his massive police and prison system to go on jailing those who complain. Independent groups estimate 200,000 political prisoners are scattered throughout South Vietnam's 600 jails. The communiqué signed by Kissinger in June 1973 calls for their release, but only 1300 have been freed. Others have been reclassified as common criminals, and torture continues.

"Maybe the American people don't have to know about troop movements or the location of nuclear weapons, but by God they sure as hell can decide whether they want to support torture or not." --Senator James Abourezk

The POST-WAR WAR slide show is designed for use in schools, community groups, churches and on television. It contains 160 slides with accompanying script and runs 35-40 minutes. A pamphlet with complete documentation for slides and script is provided. For use in classrooms and on television, a 25-minute version of the slideshow is available. The cost of slides, script and accompanying materials is \$50.

PURPOSE:

To advise Director relative to letter of *No Loc.* [redacted] which alleges surveillance by the FBI of members of the American Friends Service Committee (AFSC) and obtain approval for attached acknowledgement.

BACKGROUND:

[redacted] mentions watching a special telecast on "surveillance" which program shows Philadelphia as representing a typical American city. The AFSC is located in Philadelphia. [redacted] alleges that AFSC had been under surveillance and expressed shock that such surveillance was so prevalent and felt that this is injurious to the freedom of Americans. She urged the Director to give the matter serious consideration.

As a result of the break in of the Media, Pennsylvania Resident Agency 3/8-9/71, an investigation was launched to determine the perpetrators of the burglary and who was distributing the stolen documents to the press. Many individuals, some of whom were members of the AFSC, were contacted for interview during the course of this investigation.

AFSC, a Quaker-Pacifist organization, has been active in draft resistance, the antiwar movement, and has made substantial financial contributions to major antiwar groups and demonstrations. They have held many antiwar demonstrations in Washington and throughout the U.S. No active investigation has been conducted by the FBI on the AFSC. The activities regarding demonstrations have been followed [redacted]

The recent TV Program to which [redacted] refers is an apparent rerun of a 60-minute program produced by CBS Reports captioned "Under Surveillance," originally broadcast on 12/23/71. This program focuses on the City of Philadelphia and studies the various forms of surveillance by law enforcement, government and private agencies, such as wire taps, stake outs, photographing and tape recording suspect persons, monitoring the mails and investigations by credit companies. The FBI cases mentioned in this program were a rehash of cases brought to public light as a result of the surfacing of stolen FBI documents from the Media Resident Agency burglary.

The AFSC are plaintiffs in a civil action filed in July, 1971, in the United States District Court, Philadelphia, in which the Attorney General, the former Director and others are named as defendants. In addition to the AFSC, the Philadelphia Resistance and eighteen individuals are plaintiffs. The complaint alleges that the defendants through harassment, intimidation and surveillance have unlawfully intruded on plaintiffs' right to privacy and free speech. The matter is pending and the pretrial proceedings have not yet been completed. There were no illegal surveillances of any kind concerning AFSC.

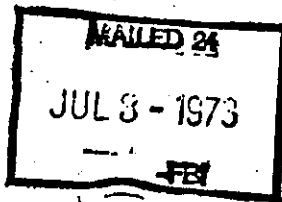

The AFSC was one of the leading forces in protesting the war in Vietnam and the expenditure of funds for military forces at the expense of utilizing the funds for human sources.

There is no indication the organization is in any way subversive and it is interested in promoting non-violence.

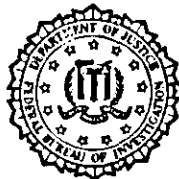



The Committee to Defend the Minnesota 8 is comprised of approximately 25 persons, including the eight individuals who were arrested in connection with the break-in of three Selective Service boards in the State of Minnesota on the night of July 11, 1970. Meetings are held weekly on Wednesday nights at various locations wherein plans, demonstrations, and political philosophy are discussed. Most of the people who attend these meetings are members of Students for a Democratic Society (SDS) and persons sympathetic with the cause of those individuals who were arrested.

SDS was founded during June, 1962, at Port Huron, Michigan, and in the 1960s functioned as the leading New Left campus-based student organization in the United States. From an initial posture of "participatory democracy," SDS moved to a radical-revolutionary position, with debate centering on how best to create a revolutionary youth movement. Internal factionalism produced a split during the SDS National Convention in June, 1969, which resulted in the following three factions: Weatherman; Worker Student Alliance (WSA); and Revolutionary Youth Movement (RYM). The Weatherman and RYM are no longer affiliated with SDS. The WSA continues to use the name SDS and maintains its national headquarters in Boston, Massachusetts.

Weatherman, formerly a faction of SDS, controlled the SDS National Office from June, 1969, until its closing in February, 1970. Weatherman then entered an underground status and adopted a tactic of "strategic sabotage," with police and military installations designated as primary targets.

WSA, a faction of SDS, was expelled from SDS in June, 1969, by the then dominant Weatherman faction but continued to use the name SDS and opened an office in Cambridge, Massachusetts. WSA aligned ideologically with the Progressive Labor Party (PLP) and, in February, 1971, moved to Chicago, Illinois, where it opened the SDS National Office at 1225 South Wabash Street.

RYM, a pro-Communist revolutionary youth organization, was organized in 1969, first as a faction within the SDS, then as a separate group with headquarters in Atlanta, Georgia. RYM was unsuccessful in attracting support, and by mid-1970, it was practically defunct.

The PLP was founded in 1962 by individuals expelled from the Communist Party, USA, for following the Chinese communist line. Its objective is the establishment of a militant working-class movement based on Marxism-Leninism and MAO Tse-tung thought.

The Minnesotans United to Free Angela Davis, organized approximately January, 1971, and controlled and dominated by the Communist Party, USA - Minnesota-Dakotas District, is no longer a functioning organization subsequent to the acquittal of Angela Davis in June, 1972, on the charges of kidnaping and murder.

The PBC is an ad hoc group reportedly comprised of members in the American Friends Service Committee (AFSC), Minnesota Clergy and Laymen Concerned (MCALC), Honeywell Project, and Vietnam Veterans Against the War (VVAW).

The AFSC is a pacifist anti-war organization.

The MCALC was incorporated in February of 1968 in the State of Minnesota. Its purpose is to promote responsible action of clergymen and lay citizens directed to bringing the Vietnam War to a sane and peaceful end and toward the eradication of those conditions which obstruct world peace. Its local office, a branch of the National Organization, Clergy and Laymen Concerned About Vietnam, is located in Room 320 of the Minnesota Church Center, 122 West Franklin, Minneapolis, Minnesota.

The MCLC maintains a staff of approximately four half-time workers and a corps of about twenty volunteer workers. Main activities include providing speakers, movies, and literature; publicizing the organization's anti-war position through news releases, media advertising, peace walks, demonstrations, and communications with state legislators and U.S. Congressmen.

The Honeywell Project is a name given to a Minneapolis group of individuals who have in the past demonstrated against the Honeywell Corporation, Minneapolis, for allegedly aiding United States war effort in Vietnam.

VVAW is an anti-war organization organized in 1967 with headquarters in New York City. Its first published objective is "To demand an immediate secession of fighting and the withdrawal of all American troops from Indochina."



NOTE:

The People's Blockade Committee is attempting to prevent the free flow of war materiel from points within the United States for export to our forces overseas. Neidlinger has attempted to have postal authorities prevent the captioned organization from mailing its material to him. Receiving no cooperation he referred the matter to the Attorney General claiming harassment by use of the mail. Assistant Attorney General A. William Olson of the Internal Security Division advised on 10/25/72 this matter was originally referred to the FBI for information only, without a request for investigation. Upon review of the Department's letter to Neidlinger Mr. Olson noted it could be construed by the recipient that the FBI was going to actively investigate the matter. He suggested the above contact with Neidlinger to put this situation in proper perspective and to preclude further correspondence.

Dear Mr. Secretary;

The enclosed mailing should be self explanatory.

Today's experience is a farce. I called the Postal Inspector's number for my area. That is discontinued. I called the Post Office in the area where this number formerly applied for a separate office. They gave me the new location AND THE TOTALLY WRONG NUMBER(which turned out to be the H.U.

I then got the Service Operator of Ma Bell and told her to make this a personal call and find me the Government Postal Official responsible enough to give me information on this offensive mail. She called, She got a number in New Brunswick and an Inspector on vacation. His secretary had no answer. Then to Newark Postal Inspector in Charge, He was not available, so another man was connected.

So, from a long and solicitous phone conversation I learned that no investigation for any violations of the Government Mails would be pursued upon receipt of copies of mailings being protested.

And then after these months of due processes under the Postal Laws accomplished, the Attorney General would be called upon to present the data.

We have been harrassed for months. And the continued harassment has destroyed our feeling of security for our homes, our safety in the area where live ammunition is nightly trans-shipment to the pier and loading on ships: These hard core activities in constant agitation in person, by phone calls and by this aggravation by mail.

What we want from the top level of Government is a combination of action. The Post Office, The United States Navy, and The Department of Justice should all be involved in this matter. Surely, if 200 people would circulate petitions for relief from this matter it is not a small matter. That is what we were asked to do as a means of gain relief from the harrassments. There are over 500 concerned residents in this community.

In the early 1940's there were a few instances of Europeans going down on railroad tracks to prevent Jews from being taken to concentration camps. We can only imagine what impact there would have been if thousands of people had taken such action instead of just a few dozen.

Actions like this are already taking place. At the Naval Ammunition Depot in Leonardo, N. J., people have begun a sustained campaign to blockade munition shipments leaving for Vietnam. On several occasions a flotilla of canoes, sailboats, and small motor boats attempted to blockade ships; and others were arrested while holding a work stoppage on the railroad tracks which carry the munitions to the coast. In Bangor, Washington, people have attempted similar sea blockades of munitions ships loaded with bombs for B-52s. And in Norfolk a few weeks ago, people attempted a sea blockade of the 5000-ton aircraft carrier, USS America, which was to join 7 other carriers in the huge naval armada off the coast of Vietnam.

The war in Indochina has been "wound up" rather than "wound down" as claimed by the Administration. Compared with the so-called "height" of the war in '68-69, there are three times as many aircraft carriers raining death on the Indochinese, more daily air sorties over North Vietnam, more destroyers pounding Vietnam from the sea, three times as many B-52s . . . and Haiphong has been mined. In a word, there is more killing, more destruction.

This massive escalation of the war was ordered to obscure the failure of Nixon's Vietnamization policies. And by continuing its support for Thieu's military clique and by sabotaging the Paris Peace Talks, the U.S. shows its commitment to a military solution which will only prolong the misery of the Vietnamese people indefinitely.

Although the war has been escalated tremendously, the war has become an invisible war, a forgotten war. It is fought with highly sophisticated electronic equipment; it is fought from high in the sky with push buttons and IBM computers. The casualties are Indochinese and American. Yet every day from ports, train and truck depots, bases across the country, the bombs and munitions are being sent to Indochina secretly and anonymously. This expert of death in Indochina must be made VISIBLE and PUBLIC. People must be made aware of the crimes of war in which we Americans are deeply involved.

The next five months are a most critical time for the Vietnamese people. If Nixon or another candidate committed to a Thieu-type government in Saigon is elected in November, the people of Indochina face another four years of bombs and napalm. The war must be made visible to the American public in order to save the innocent and American morality!!

The PEOPLES BLOCKADE is a nationwide effort to blockade bomb and munitions shipments bound for Indochina.

The PEOPLES BLOCKADE is nonviolent direct action against the government. It is our bodies between the bombs and the Indochinese people.

The PEOPLES BLOCKADE allows all of us who are torn and frustrated by our government's war crimes against some of the gentlest people on the face of the earth to prevent those crimes through a clear act of conscience.

The PEOPLES BLOCKADE says NO to our government; it says NO to war against humanity; and it says that we will continue to act through nonviolent direct action until the war ends.

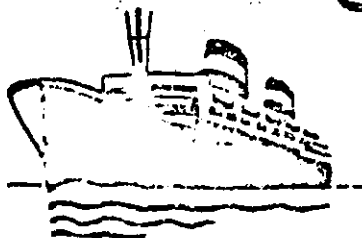
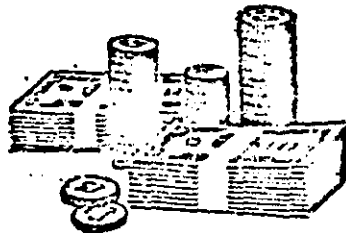
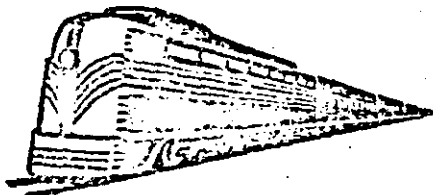
Dear citizens and Friends,

our flag that we honor on June 14th. The flag Betsy Ross designed was to national ensign for a new and promising nation, free of religious and political persecution. In the years following the American Revolution, parts of which fought in our community, this flag represented freedom from tyranny and the beginnings of a democratic society unequalled in history.

Today, some of us are beginning to fear a new tyranny that hides behind the flag designed 200 years ago. Greed for wealth, power and control seem to be the motivation for fighting new wars. In the name of bringing "PEACE" and "FREEDOM" to Vietnam, the lives of 50,000 American men have been lost. Over THREE MILLION Indochinese have been killed, wounded or made refugees, 3,000 TONS of bombs are dropped each day. In one week 24,000 TONS of bombs are dropped creating an additional 10,000 killed or wounded Vietnamese people! This weekly average is equivalent to the blast at Hiroshima; every minute an average of two tons of bombs are dropped. These actions have brought neither peace nor freedom. The government supported by the U.S. in Southern Vietnam remains corrupt and has suspended most of the civil liberties of the people ruled by Nguyen Van Thi

In this country more than 73% of the people want an immediate end to this wasteful war, yet the President still increases the bombings. Promising a "Generation of Peace" and economic stability, he has only made the economy dependent on the war which increases the cost of living and increases devastation in Southeast Asia. Because of the government's priority of spending on the war; health care, child care, and environmental projects go unfunded or are drastically slashed. Many of us in this community are forced, by economic necessity to work at war related jobs (no other ones are available). Although we are against the war, we are tied to it. This is the new tyranny--a denial of freedom of choice!

Statement from Bronson P. Clark, Executive Secretary

Two representatives of the American Friends Service Committee have just returned from Hanoi where they delivered a humanitarian shipment of heart surgery equipment. They are Dr. George Perera, former associate dean of the Columbia University College of Physicians and Surgeons and a recognized expert on hypertension, and John A. Sullivan, Associate Executive Secretary of AFSC.

Our representatives brought home personal and photographic evidence of what some of the American bombs are now doing: wrecked hospitals, schools, homes and cultural buildings. They stood on and photographed a primary and a secondary dike at Nam Dinh which had been bombed with no visible military target nearby. Whether the bombing of civilian institutions, the maiming and killing of civilians and the damage and weakening of dikes is intentional or accidental is academic. The critical question is whether these things are happening, and the direct, first-hand evidence of AFSC observers is that they are.

U.S. bombardment and naval shelling of North Vietnam must be terminated. For a technologically superior country like ours to be raining sophisticated destruction on a relatively defenseless, essentially peasant people who are completely without the means of the slightest attack on our country brings dishonor to American ideals. Our representatives found in all their conversations and observations that the North Vietnamese people, far from being driven to defeat, are uniting more strongly under the pressure and putting their ability to adapt and survive to work to outlast and endure the bombing.

In the name of all that is holy, in the name of spiritual values, in the very name of America, this loathsome bombing and shelling must stop.

4 August 1972

Hostile planes knife through cold and silent sky.
Hearse loudspeakers signal the approach:
The sirens that I heard in London —
Another land, another time, another pang of history —
I hear again.
Theirs is the raucous call known well to ears that have heard war before.

I sit in concrete shelter rooms
and talk of war.
With a Vietnamese surgeon whom war has forced
To new techniques of saving lives.
An Indian of supreme dignity who
Presides over the international group
named to control the agreement of men who
Decided 18 years ago to supervise a peace that hasn't come.
An actress who knows the studios of
Paris, London, Hollywood,
Now to find, falling asleep at night,
That her pillow is wet from tears
Brought forth by sights of war and thoughts of men
Her country has sent to ride the skies on tubes of death.

Oh, Vietnam, Vietnam.
I know your gentle, slow and graceful people in the south,
And now I see here, in Hanoi, the same soft sweetness,

Oh, Vietnam.
In the enveloping heat of July, another flush comes to my face.

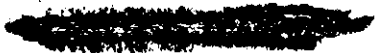
