Surveillances conducted in the vicinity of the Crystal Barber Shop, 1605 Centre Ave., on July 10, 1964, and July 22, 1964, disclosed no activity of interest to this investigation.

[redacted] advised that the records of the Bureau of Motor Vehicles, Harrisburg, Pa., reflect that 1964 Pennsylvania license number OC6396 is issued for a Cadillac coupe, the property of ROBERTO CLEMENTE, whose address is listed as Forbes Field Baseball Club, Pittsburgh 13, Pa.

ROBERTO CLEMENTE is a nationally known baseball player, and is presently playing as a right fielder for the Pittsburgh Pirates Baseball Team, Forbes Field, Pittsburgh, in the National League.

An item appeared in the "Pittsburgh Post-Gazette," a daily Pittsburgh newspaper, on July 11, 1964, reflecting that the mother, sister, and fiancée of ROBERTO CLEMENTE were visiting in Pittsburgh over the weekend.

letter was processed presumably as normal fan mail and did not come to [REDACTED] attention until 11/1/72. [REDACTED] advised that the game referred to in the letter was in fact played on 9/29/72, without incident. [REDACTED] further advised that ROBERTO CLEMENTE is currently in Puerto Rico.

On 11/7/72, the facts of this case were discussed with AUSA JAY WALDMAN at Pittsburgh, Pa. Mr. WALDMAN advised that inasmuch as the date of the threat against the life of ROBERTO CLEMENTE was passed, and since there were no follow up threats nor any clue as to possible suspects, the matter did not merit further investigation.

The FBI Laboratory is requested to copy enclosed letter for inclusion in anonymous letter file and return to Pittsburgh.

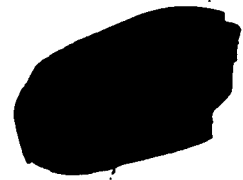

Result of examination:

Specimens Q1 and Q2 were searched through the appropriate sections of the Anonymous Letter File without effecting an identification. Photographs will be added to the file for future reference.

No indented writing or watermarks were found in Q1 and Q2.

An eight-cent U. S. postage stamp, which came from a coil of stamps, is attached to Q1.

The questioned typewriting on specimen Q2 is too limited to specifically classify, however, it most closely resembles the standard for Smith-Corona pica style of type, having a horizontal spacing of ten letters per inch.

Specimens Q1 and Q2 are returned herewith. Photographs are retained.
