A review of the available newsletters circulated by the Southern Area Council covering Los Angeles and vicinity reflects the following activity of the Mattachine Society and the Mattachine Society, Inc. and its chapters:

Newsletter 1/1/54 reflects that the California State Dept. of Health made an inquiry of the Society for assistance in curbing venereal disease among sexual variants. It also reflects that a research project was being conducted by Research Chapter #104 entitled, "Lesbian Research Program," wherein it was announced that this program was being conducted in cooperation with volunteer psychologists, and that the Society was assisting in every way possible. Also announced was a blood bank party which was organized by the Southern Area Council for the purpose of donating blood to the hemophilic fund. The balance of the letter contains notes concerning the activities of the various chapters in the Los Angeles area; a reprint from an article in "Time Magazine" of 12/28/53 captioned, "The Hidden Problem" which dealt with the murder of his parents by a homosexual; and a book review of the book, "The Heart in Exile." This letter also notes attention being given to the problem of homosexuals in London, England, and some discussions which have occurred in the English Parliament.

Newsletter 3/1/54 announces that the Mattachine Society was supporting a legal case involving a technical point of law and appeals for funds. It also contains an article on who must register under the state or city law requiring the registration of sexual deviates, plus general notes concerning the activities of chapters and the Area Councils.

Newsletter 4/1/54 notes that funds were needed to prepare transcripts on the "Slade Case" which was being tested in the courts and which the Mattachine Society, Inc. was supporting. It also notes that Dr. ~~WARDELL POMEROY~~, assistant to Dr. ~~ALFRED KINSEY~~, was in Los Angeles and had been in consultation with representatives of the Mattachine Society in connection with a survey being made by Dr. KINSEY to be published under the title, "The Sex Offender and the Law."

Reference is made to the Director's expressed interest in the security aspects of funds and foundations.

History Set Forth

Attached herewith is a blind memorandum setting forth the results of a pilot research study conducted into those funds and foundations having an actual--or potential--influence upon the internal security of the United States and the foreign policies of our Government. It includes a brief history of the development of charitable foundations as they exist today, an analysis of their wealth and influence, and the subversive or questionable causes in which a number of them have invested their tax-exempt funds.

Salient Features

Following are a few of the more interesting and impressive facts drawn from the attached study:

1. Foundations have a tremendous influence on Americans today if only from the sheer number of organizations involved and the colossal accumulations of wealth at their disposal. The Department of Commerce estimates, for example, that there is a minimum of 7, 300 charitable bodies operating in the United States at the present time and, of these, the Ford Foundation alone is estimated to be worth approximately \$2, 500, 000, 000.

As if this stranglehold on the training ground of youth were not enough, a council to finance higher education was created by officials of the Ford, Rockefeller, Carnegie, and Alfred P. Sloan foundations, each of which contributes \$60,000 annually to its upkeep. The money, strangely enough, goes not to direct support of higher education, but to pay a staff which advises corporations on how to spend their money, and colleges and universities on how to get it. (24)

Sex Studies Financed

Alfred C. Kinsey USA
No better instance of a reputable name being lent to enhance an unsavory cause can be found than that offered by the Rockefeller Foundation's support of the Kinsey sex studies. Between 1941 and 1949, the foundation poured approximately \$414,000 into the controversial researches of Dr. Alfred Kinsey and his intrepid band of assistants. (26) As a result of these subsidized studies, Dr. Kinsey's book, Sexual Behavior in the Human Female, was able to stun the American public with some highly startling "revelations." A few of these include the theories that: (1) sexual relations between preadolescent children and adults (rape not being excluded) may have "contributed favorably to

their (the children's) later socio-sexual development" (27); (2) "...pre-marital socio-sexual experience...should contribute to this development of emotional capacities. In this, as in other areas, learning at an early age may be more effective than learning at any later age after marriage" (28); and (3) premarital sexual experience "provides an opportunity for the female to adjust emotionally to various types of males....we have seen many hundreds of marriages ruined by the failure of the partners to learn before marriage that they could not adjust emotionally or sexually to each other." (29)

Proxy Reputation

So contrary to accepted codes of morality and behavior were these theories and observations, that an article in Harper's Magazine exclaimed "they would be unbelievable but for the impressive weight of scientific agencies backing the survey." (30) Among the agencies so listed by the writer of the article were the Rockefeller Foundation's Medical Science Division and the University of Indiana.

"Unofficial" State Department

If anyone maintains that the money and influence behind some of the major foundations dealing in foreign relations could not affect the decisions of certain government officials in the performance of their duties, then he is not facing facts. As far back as a quarter of a century ago, the Carnegie Endowment for International Peace was boasting that it had become "an unofficial instrument of international policy, taking up here and there the ends and threads of international problems and questions which the governments find it difficult to handle, and through private initiative reaching conclusions which are not of a formal nature but which unofficially find their way into the policies of governments." (31) Nor was this boast an empty or meaningless one. An individual who has made a study of the activities of the Rockefeller Foundation, for instance, has credited it with exerting the pressure that led to the recognition of Soviet Russia by the United States during the 1930s. His reason for the pressure? Standard Oil's desire to negotiate oil contracts with the Soviet leaders. (32) As will be brought out later, under the individual organizations, wholesale lots of officials or trustees of various foundations have been--or are--employed by the United States Department of State.

Dr. ALFRED C. KINSEY, Professor, Zoology Department, Indiana State University, was contacted on April 23, 1945, at Philadelphia, Pa.

Dr. KINSEY stated that he had never heard of THE YOUTH WELFARE AND SERVICE CLUB. He also did not know, or had never heard of subject.

Dr. KINSEY stated that he had no knowledge of anyone's ever attempting to use the manual entitled, "THE YOUTH WELFARE AND SERVICE CLUB" at Indiana State University.

Dr. KINSEY advised that in addition to his duties as a professor of Zoology, at Indiana State University, for the past seven years he has been engaged in research throughout the United States. This research involves the compiling of facts of sex practices throughout the country. The project is sponsored and supported by Indiana University, as well as by the Medical Division of the Rockefeller Foundation. The latter foundation is administrator for the Medical Division of the National Research Council, Washington, D. C.

Dr. KINSEY stated that in the course of his research, he discusses matters pertaining to sex with numerous and various persons in all walks of life. During these discussions, he believed that he would have heard of THE YOUTH WELFARE AND SERVICE CLUB, in the event its activities were of any large scope. He said not only had he not heard of the club, but he never heard of any club of the type indicated by the description of subject organization, as set out in reference report. It was Dr. KINSEY's opinion that the name and description of the club set out in the manual was merely subterfuge and that possibly the organization was solely a group commercializing on pornographic literature..

It should be noted that Dr. KINSEY stated that he wished to frankly admit that the entire success of the research he was doing, depended on his maintaining information he maintained in absolute confidence. He indicated, however, that in the case of subject organization and subjects, he was frankly stating that he had never heard of them and was not attempting to withhold confidences.

When I was at the barber's recently a man came into the store, introduced himself politely, and asked those present for permission to ask them questions. He asked about all sorts of things. He wanted to know how often and how much meat was eaten, how much one's weekly salary amounted to, whether one shaved every day, when and against whom a new war was to be expected, whether women teachers should remain single, who had the greatest prospects of being elected President, and a great many other things.

The interrogator was a man who was employed by a concern which is doing research on the attitude of the people and preparing statistics on this. The value of these official inquiries may be overestimated or underestimated, but it is certain that the results of such a poll of private citizens have gained an important place in the life of America.

Politicians especially lend an attentive ear to the voice of the people. Hence election years are good times for institutes for research on public opinion. Many Congressmen even—by paying for it, naturally—ascertain their election prospects themselves. If the results are unfavorable, then naturally they will not be published. The average limit of mistakes in predicting election results amounted to only 4%. It will, therefore, be quite interesting to follow the vacillations of popular opinion this year in the newspapers according to the figures.

The number of agents which the firms are using for listening to the population often amounts into the hundreds. Often, too, advertising businesses took part in the mass interviews. All classes of the population are questioned so that the answers coming from 3,000 to 50,000 persons represent a miniature picture of America. The two best-known experts in the field of the voting are Messrs. ~~Gallup and Roper~~.

✓ Science too makes use of the methods of mass interrogation for its purposes. Prof. ~~Kinsey~~ and his co-workers recently published a book on the sexual life of the American man, which is based on the answers of 12,000 persons. As experts assure us, the important and sensational results of this work of research could scarcely have been achieved in any other way. (

In the periodical ~~"Fortune"~~, figures were published a few months ago which are to be reproduced partly here. The poll was concerned with the following three questions:
