

# Tulsa's 'Spawn of Hell' Wiped Ou

Echoes of the many gun battles fought by notorious members of the Barker gang" resounded in Tulsa today after news was received from Denver that the last of the Oklahoma outlaw band had been killed

Denver police have charged Lloyd's death to his wife, Jean, 37, who they say cut down the last of the Barker boys as he attempted to unlock the door of their home. She told officers she feared her husband would kill her and her children. She pleaded in-neent by reason of insanity.

The Barker clan launched their careers as juvenile delinquents in Tulsa in the early 1920's. All were reported, at one time or another, to have been members of the notorious "Central park mob, which at one time had 22 hijackers, bandits and other thugs enlisted in its ranks.

Lloyd, according to FBI records, was not a member of "Ma" Barker's gang at the height of his operations. At that time he was serving 25 years in the federal penitentiary at Leavenworth for mail robbery.

The Barkers moved to Tulsa in 1910 from Webb City, Mo., after Herman had been arrested there

for highway robbery.

In Tulsa, the Barker shack became an underworld postoffice and meeting place. "Ma" ruled the roost with an iron hand and "took nothing off of nobody."



SUBJECT: LLOYD BARKER, aka "Red" RESEARCH

Reference is made to Bureau letter dated April 15, 1949, requesting that appropriate inquiry be conducted to determine the outcome of charges against MRS. BARKER for killing her husband LLOYD BARKER. It is also requested that the facts concerning BARKER's life in Denver subsequent to his release from prison be secured.

The following information was obtained by SA JAMES W. LAIL from SHERIFF HOMER MAYBERRY and DEPUTY DISTRICT ATTORNEY GEORGE FISCHER at Brighton, Colorado:

JENNIE BARKER shot and killed her husband LLOYD "RED" BARKER at their home, 3426 W. 73rd Avenue, Westminister, Colorado, on March 18, 1949. She was arrested the same date and placed in the Adams County Jail at Brighton, Colorado, where she readily confessed to the shooting, claiming she was afraid of him, he having threatened her life on numerous occasions. On March 21, 1949, she was tried by Jury in the District Court at Brighton and entered a plea of "not guilty by reason of insanity at the time and since. Upon the testimony of two competent doctors she was sentenced to life in the Colorado State Insane Asylum at Pueblo, Colorado, where she was confined on April 9, 1949.

The only background information concerning BARKER as known to MAYBERRY and FISCHER is that he has been employed for several years at the DENARGO GRILL at the DENARGO MARKET, Denver, and was, at the time of his death the assistant manager of the Grill. He has reportedly been living with JENNIE as a common-law wife for approximately seven or eight years, having two children by her. He was legally married to her at Brighton, Colorado, in February 1949. JENNIE had two children by a previous marriage.

JENNIE is described as born February 20, 1912, at New York City, U.S., 5 ft. 2 inches, 92 pounds, blue eyes, brown hair, fair complexion.

No further inquiries have been made in this matter in view of the Bureau instructions that the inquiries should be made through local authorities and in such a mammer as not to elicit press inquiries. If the Bureau should desire that additional information regarding BARKER's life be obtained this information could probably be secured through local newspaper contacts.

Deputy District Attorney GEORGE FISCHER, Brighton, Colorado, also advised that JEFNIE BARKER's lawyer, L. E. F. TALKINGTON, Denver, Colorado, told him

he has been well acquainted with LLOYD BARKER for many years. TALKINGTON is the individual who originally advised the Adams County authorities in Brighton that LLOYD "RED" BARKER was one of the notorious "Barker Boys," and son of "MA" BARKER. MR. TALKINGTON is supposedly aware of the activities of BARKER since his release from prison. He is not being contacted at this time, however, in view of the Bureau instructions contained in the reference letter.

On September 5, 1957, SA ARTHUR S. REEDER, Denver Office, was conducting official business with Undersheriff G. V. BARSTOW of the Adams County Sheriff's Office, Brighton, Colorado. Mr. BARSTOW stated he had some photographs of LLOYD BARKER, the last-known-living member of the family, i.e., BARKER-KARPIS Gang.

Enclosed herewith are three photographs showing the body of LLOYD BARKER. He was killed by his wife, JENNIE BARKER, thirty-seven years of age, at 3426 West 73rd Avenue, their residence. LLOYD at that time was the then Assistant Manager of the Denargo Market, Denver. JENNIE was tried for the murder, was declared criminally insane, and is possibly still an inmate of the Colorado State Hospital, Pueblo, Colorado.

It occurred to SA REEDER that the Bureau may like these copies to complete the file on the BARKER family. They need not be returned.
