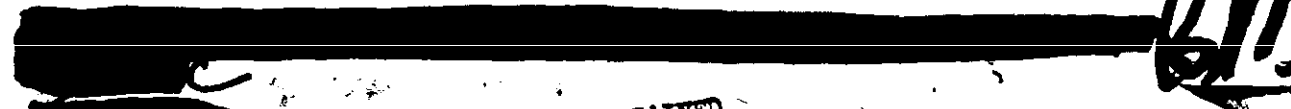

[REDACTED] With his assistance it proposed to develop a highly confidential informant re the ELF. [REDACTED] a source can furnish full info. re the ELF executive and membership all ELF correspondence since the group was formed, produce all of cancelled checks for examination, produce other financial records, furnish some books and pamphlets of value in the general CP field.

DECLASSIFIED BY SP4 [REDACTED] ON 9-27-81

The building at 160 5th Ave., per [REDACTED] is securely locked at 10:00 PM each night and no one has access to it after that hour. [REDACTED] is on duty after that hour. Source will provide access to the building for the informant as well as access to the ELF. He will advise [REDACTED] that work is being performed for him in his office which is directly across the hall from the ELF and that the persons therein should be completely undisturbed until they require aid in leaving the building. The [REDACTED] ordinarily remains on the first floor and he will be instructed to do so and to guard the entrance and admit no one. [REDACTED]

[REDACTED] regularly occupy the ELF office. They will be surveilled away from the office and kept under surveillance until it is obvious that they do not contemplate return to it. It is felt that the above described measures will provide complete security to the informant. u

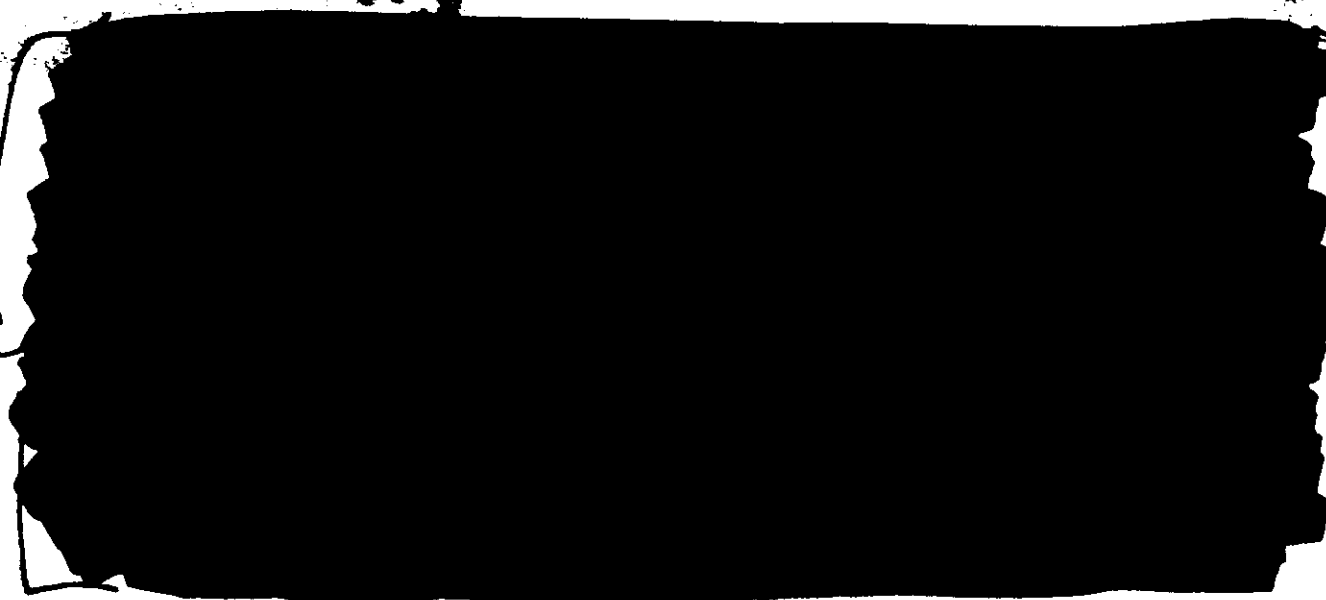

For your information, following several conferences, the Bureau has been contacted with respect to a problem which has arisen concerning the handling of June matters. (u)

Up to the present time, each time that material is utilized in a letter or in a report, which material emanated from a highly confidential source, it has been necessary for the Agent preparing the communication to also prepare a memo for the June file setting forth that he has utilized this information and the identity of the file in which the data was utilized. (u)

Inasmuch as numerous names and other data are developed from confidential sources, a high volume of these JUNE memoranda have been routed into the June file. (u)

The Bureau has instructed that it is appropriate for us to assign a permanent symbol number when a highly confidential source will be used as the basis for information being set forth in our reports. [redacted] c

The Bureau has been advised that this procedure will be followed and that the symbol numbers will be designated as [redacted] for those pertaining to security matters and [redacted] for those pertaining to criminal matters. (u)

A survey of confidential anonymous investigations reveals that these investigation are handled in three phases: (1) the survey which includes file reviews, indices checks and background investigation; (2) the actual assignment, and (3) processing information obtained on the assignment. (u)

[I. SURVEY] (u)

The survey entails file reviews and indices checks on occupants of the apartment or office involved. In cases wherein there has been a previous investigation, this phase of the confidential assignment is limited to the review of the files pertaining to the subject. However, where there is no file on the subject, considerable background information has to be developed as well as an exhaustive indices search. (u)

In each case it is necessary to develop confidential sources at the apartment or building involved. In the average case this requires developing the superintendent and/or some other occupant of the building who is in proximity to the subject's apartment. Following the development of a source at the residence, the next problem is to set up a plant or cover apartment where photographic equipment can be operated and where possible movements of the subject can be physically observed. (u)

The manpower required in the survey, the initial phase of the confidential assignment, on the average requires two agents to conduct the necessary file reviews, indices checks and to develop the sources and establish plant or cover apartment. The two agents take on the average of from one to three days on this phase of the assignment. (u)

Once the cover apartment or plant has been established it is necessary to conduct a physical surveillance prior to the actual assignment to determine the activities and movements of the subject and other occupants in the office or apartment which he is located. The manpower to be expended is dependent upon the number of persons involved in the subject apartment or office and the size of the building in question. The average assignment requires four agents and a period of from three to five days.

[II. ACTUAL ASSIGNMENT]

Following the preliminary survey and the establishing of a plant and prior to the actual assignment itself, a conference is called to brief all agents assigned. Specific assignments are made and instructions given. In the average case, three to four agents are on the actual assignment. One of the men assigned, a supervisor, mans the handy-talkie, which is in direct contact with agents on surveillance covering the immediate apartment. Depending on the size of the assignment, two to three agents make the actual search. Two agents are assigned to the cover apartment; one agent is in charge of photographing material, the other agent assists in assuring that material to be photographed is not misplaced from its original location.

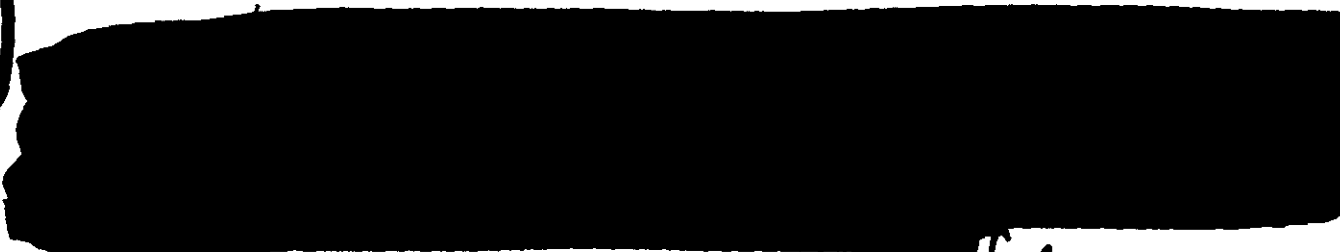
Depending on the building involved, the number of offices or apartments and the number of exits involved, additional agents are needed to assure the security of the agents on the assignment. It is also necessary to have the subject and the other occupants of the apartment or office located and under surveillance. The average number of agents assigned to surveillance in connection with the assignment is approximately eight to ten men.

[III. PROCESSING INFORMATION RECEIVED]

In the average assignment approximately 500 separate photographs or exposures are realized. These are developed by the office laboratory.

The first review of the material obtained is made by the two agents who conducted the initial file review for the assignment. The purpose of this first review is to check address and appointment books for any obvious "meets" or immediate leads requiring prompt action.

BOARDMAN telephonically contacted the writer today at 12:30 p.m. and stated that some Agent in Washington in a classroom made the remark that bag jobs were unconstitutional. This information was immediately brought to the attention of Mr. TOLSON and Mr. BOARDMAN and he stated that in view of this situation, hereafter no bag jobs would be authorized unless there were present exceedingly unusual circumstances with a guarantee of results and that none would be authorized without the exact specific recommendation of the SAC, who was to make his recommendation to Mr. BOARDMAN. He reiterated there must be very unusual circumstances. He pointed out that the Bureau has lost confidence in New York. (u)

I asked Mr. BOARDMAN whether this Agent is a New York Agent who made the remark because if it was a New York Agent, I would take immediate steps to determine how friendly he was with other Agents on that squad and to determine whether or not he had ever worked such a technique, the thought being that his mental outlook might be present among other members of that squad. Mr. BOARDMAN stated he would attempt to find out and let me know. (u)

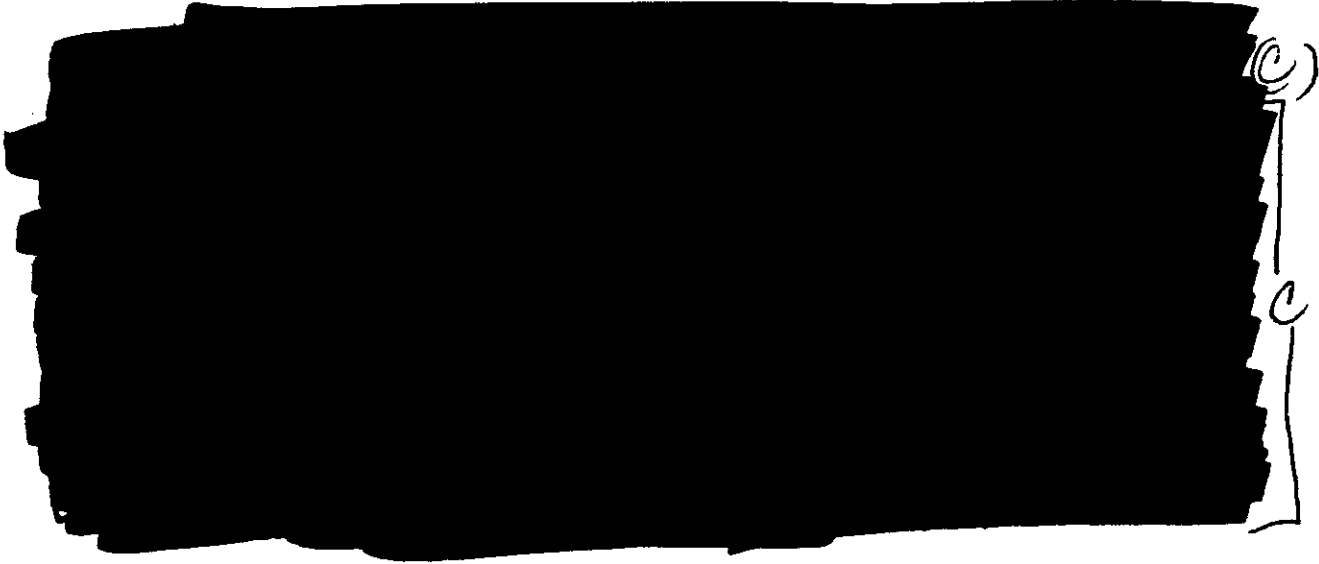

It should also be noted that none of the clothing she maintains at her apartment has any identifying labels or other indications as to her true identity or past whereabouts. In order to have uniformity in the memoranda prepared with reference to the development of highly confidential sources, it is requested that the memos contain the following information in the form set out hereinafter: (U)

The title of the case under which the source is being developed should be in the title of the memorandum. There should be a sub title listing the name of the person on which a highly confidential source is being developed, together with the character, the Bureau file number and the New York file number. Under the file number should be listed whether or not subject is an S.I. subject. This, of course, should be a "June" memorandum.

The balance of the memorandum should be broken down under sub headings as follows: (U)

Time: Under this sub heading should be a statement as to when it is anticipated the source will be developed.

Residence: This should set out the address and the apartment number where the source is to be developed. Also the identity of anyone else who may be living with the subject.

Employment: Under this heading should be listed the employment of the subject, as well as that of the spouse.

Reason for Developing Source: Under this sub heading should be stated briefly why we are developing this source and what is expected to be gained.

The second paragraph should list the names and positions of those persons cooperating with us to effectuate the development of the source. Included in this paragraph should be listed specifically the investigation conducted and the results thereof of these individuals. Miscellaneous: Under this heading should be set out the name of the agent to whom the case is assigned; the name of the agent responsible for the development of this source and the name of the agent and/or Supervisor who will be on the job having immediate responsibilities for its operation.

With reference to the remainder of the personnel actually assigned on the job, it will not be necessary to set this out in the above memorandum but they should be listed in the next memorandum prepared setting out the results. Prior to securing Bureau authority for development of such a source, the SAC must approve and the Bureau be advised. (S) (U)

INTERNAL SECURITY - C.

In connection with the development of highly confidential and anonymous sources, there has been utilized successfully by the New York Office a new and practical investigative technique, which may prove of value to other offices in the development of these sources in their territory. (S)(U)

The technique involves the use of "booties", which is a type of shoe cover commonly used by window dressers in their trade. These "booties" are used by window dressers in order to allow them to walk around a display window without leaving shoe or dirt marks on the floors, rugs or other material used in the display. The "booties" are slipped on over their shoes and obviates the necessity of removing their shoes. (S)(U)

It should be noted that the "booties" are comparatively small in bulk and can easily be folded to handkerchief size and carried in the pocket of the user. The very practical and advantage use of the "booties" in connection with the development of highly confidential and anonymous sources is realized on snowy and rainy days when shoes become wet or muddy. On such days, these "booties" can be easily and quickly slipped over the wet shoes just prior to entering the particular apartment, office, etc. and will allow movement within the premises without leaving "telltale" stains or smears. Upon exit they can be removed just as easily and placed in the user's pocket thus affording a higher degree of security and a greater degree of movement while in the premises. (S)(U)

It was ascertained too, during this operation, that the use of the "Booties" also cut down considerably the amount of usual and ordinary floor noises made by walking on floor boards, linoleum, etc. and permitted a much quieter movement within the premises. This indicates a definite additional advantageous use of the "Booties" even on dry days where silent movement is of the essence in maintaining a high degree of security. (S) u

The New York Office has purchased a half dozen of these "Booties", which are currently being used by the agents engaged in this activity, and one pair is being forwarded to the Bureau with this letter for examination and by way of explanation. (S) u

The "Booties" were purchased in New York from a shoe supply wholesale house at a cost of 25¢ per pair. They also can be purchased through any retail shoe store at probably a slightly higher cost and should be accessible through these outlets to any of the Bureau offices. (S) u

In many instances, this procedure resulted in non-compliance with the five-day transcription rule. The LA office, in justifying this procedure, has advanced the following reasons: QU

1. The stenos handling this work exclusively become familiar with names, locations, etc. and can handle more work.
2. The material itself is highly confidential and for security reasons it is better that the dictation be limited to the selected stenos.

[redacted] requested that NY advise as to its procedure and requested that he be telephonically recontacted as soon as possible.

After discussing this matter with Supervisor [redacted] who was acting for ASAC MacLennan, Supervisor [redacted] who was acting for ASAC Moore, and ASAC Simon, the writer advised [redacted] that in the NYO when the material is obtained from a highly confidential source and the symbol number is identified with the location, the material is dictated only to the secretaries of the supervisors.
