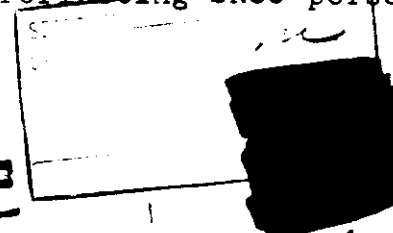

**Explanation of why original list was destroyed:**

As set out above, the lists were destroyed by SA [REDACTED] who has since resigned. The supervisor of the Section handling the matter at that time was former SA [REDACTED] although there is no indication in the file that any SA other than [REDACTED] took part in the decision to destroy the exhibit.

The reason for destruction of the exhibit cannot be determined without consulting former SA [REDACTED] or possibly former SA [REDACTED] who might recall issuing instructions relative to the destruction of exhibits at the time. 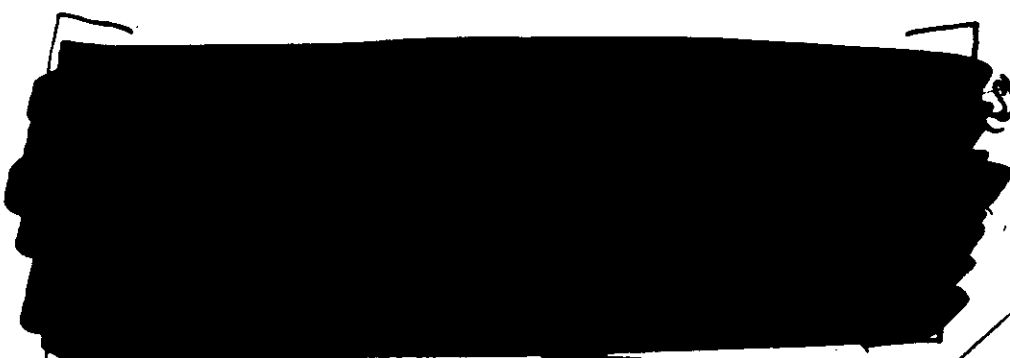
