





THIS SERIAL SHOULD BE MAINTAINED AS TOP SERIAL IN THIS FILE.

On 1/28/76, a comprehensive review of the material contained in this volume was conducted by me. There is no question in my mind that each and every item, with the exception of the top serial which is a memorandum from dated 7/14/72 which should remain unclassified, contained in this volume requires classification of at least "Confidential", exemption category 2000 (intelligence sources and methods) with an indefinite declassification.

Departmental attorneys assigned to the Civil Rights Division who recently conducted investigation in the NYO, had access to this volume and made xerox copies of six memoranda covering the period from 4/3/70 to 7/14/72. Five of these memoranda, in my opinion, warrant classification of "Confidential", have been individually so stamped, and the Bureau will be requested by teletype to handle appropriate classification at the Department.

The classifying officer is myself, #6392, and the date of the classification affixed as \$/28/76.

In connection with keys maintained in NYO which pertain to confiden techniques employed, the following procedure is recommended.

[1] They obtained for the purpose of carrying out confidential techniques will be maintained under the control, supervision, and custody of the ASAC of the Division handling the pases to which they pertain. They will be maintained in a locked Tel-Rec cabinet at all times. The Tel-Rec cabinet will be maintained in The Tel-Kee cabinet will be maintained in the office of the ASAC. The keys will be released to investigative personnel by the interested ASAC only.

Upon receipt of a key pertaining to a confidential technique by an investigative Agent, a memorandum will be prepared by him for the subfile of the June file. This is File No. 66-6182-A. This memo, prepared by the investigative Agent, will describe the premises to which the key pertains and any other dates believed essential, describing the premises and the utilization of the key. This memo should also include a comment as to the probable duration for which the key should be retained.

All ASACs maintaining Tel-Kee cabinets with keys pertaining to confidential techniques contained therein, will maintain an administrative tickler on each key in order that he may assure himself periodically whether or not further retention of the key is necessary. If it is ascertained that the key is no longer necessary, appropriate action should be taken to so record this fact in MY File 66-6182-A, and to appropriately dispose of the key.

This memo will be the basis for opening a subfile of the June File --66-6182 and will be designated as 66-6182-A.
