Q. Where do you get "science" in the Moorish Science?

A. We make all members take a physical examination and blood test, married or single, twice a year.

Q. Where do you get the name Bey or El? A. That is the tribal name.

Q. How do you know whether you descended from the Bey tribe or El tribe?

A. There were only two tribes brought to this country, they have to be one or the other, we give them their choice of which tribe name they want.

Note: Joe B. Axar, badge #13-06-025, employee of Buick Motor Div., who speaks and understands the Arabic language was brought into the room and was unable to hold an intelligent conversation with subject in the Arabic language.

Q. Do your people consider themselves Asiatics?

A. No, they are taught they are Moorish-Americans.

Q. What date do you celebrate Christmas? A. The 6th of January.

Q. Why do you pick this date? A. It is an old Moslem custom.

Q. What is your holy day? A. Friday.

Q. Why Friday? A. Mohammedan sabbath is always Friday.

Q. What does a figure 7 with a circle around it signify?

A. It is a tribe number, which is the Moabite tribe.

Q. Do you teach that there are seven days in a year?

A. We do not teach this, but according to science there are 7 days in a year, nothing can go above the figure seven.

Q. What about the number eleven on the dice?

A. Number eleven is two one's put together.

Q. What is the strength of your organization in the United States?

A. About 30,000 members in good standing. About 11,000 in Chicago.

Q. How do you finance this organization?

A. By dues and voluntary donations.

Q. What is the financial status of the organization at this time?

A. About \$400.

Q. Do you receive a salary from this organization?

A. No, not a penny, not even traveling expenses.

Q. How do you live and how do you pay your expense in traveling?

A. By my own support, I pay my own expenses.

A. There have been statements in the paper, and I've always recognized them as a potential enemy of the United States.

Q. What else have you heard their leaders say?

I heard it said that the Japanese are good fighters, that they have superior equipment, that they would most likely win the war, that the people along the Temple would, or rather the whole race, would fare better if the Japanese would win the war. I have heard that the sky would be dark with airplanes and it would be at night, that it would be dark with airplanes of our brothers. That there would be a safety zone when the war would come for the Moorish and their families. I have heard them say, if you wear your fez, they would recognize you as their friends. I heard it said that there would be no need of our people fighting.

Q. Do you believe these things what you just told us?

A. I feel that the Japanese people are of the darker side like we are, but as far as being connected I can't say anything else.

Q. How do they explain that the Japanese are fighting the Chinese when they are the darker race?

A. I have heard it said that they want them to come under the same religion and they want to use force and they do have to, they have been fighting. It is contradictory to the Koran, as far as brotherly love.

Q. Do the Moors have the same religion as the Japanese?

A. Yes, that is what they tell us, sort of an on the same line.

Q. Does the average member feel that Japan will win the war and that they will have better jobs?

A. Yes, they do.

Q. Do you feel that the members follow the teachings of the leaders?

A. Yes, because most of them haven't the education and don't know any better.

Q. Did you ever hear Charles Kirkman talk about the Japs?

A. I heard him say that they were our brothers, but generally when he comes there is a party and not much religious speech going on. I heard him say about the safety of the Moors and the wearing of the fez.

Statement of William McCohron taken in the presence of Frank Zeiter, Assistant Investigator, Plant Protection, January 7, 1943, taken by Mary M. Roth, in the office of AIT APP, Buick Motor Div., GM Corp., Buick.

Q. Mr. McCohron, you called me and asked for permission to correct a statement that you made the other day in which you failed to tell the truth. Is that right?

A. That's right.

Q. Will you tell us what Tom Rhoades talked about at a meeting that went on around Thanksgiving Day 1942?

A. He said that the Japs will invade this country, and that the Japs would rule this country; the Moors will have better jobs than now in the factory. He said that the United States can't win and he said the way United States has treated the darker races, that the white man's sins would go up before Allah and Allah would take the white man's kingdom. He said, if the Japs win the war, the darkies would have better jobs in the shops and would be treated better under the Japs than they are now. When the Japs are ready to come, there is no way to keep them out, there will be thousands of airplane bombers, that they would bomb this country. He said that he walked and talked with Noble Drew Allah and he told him these things. That when the Japs come we should put out our red flag and wear our fez. All of them that aren't good Moors, will go down to desolation. He said, talk about the Koran to the police but don't mention about the Japanese. He said that the Jap part of the thing was a secret, that if you talked about it, you would go crazy or some other bad luck would befall you. He said that the country will be overthrown in one night.

Q. How long has Rhoades been teaching these things to you people?

A. Just before we declared war, around that time.

Q. What did Rhoades say about the Japs in connection with Noble Drew Allah?

A. Rhoades said that what he told us about Japan were the words of Noble Drew Allah, the prophet. He said what Noble Drew Allah said was coming true.

Q. Do you have any secret pass word to get into the meetings? Or signs?

A. Yes, for the religious service we raise our right hand with fingers and thumb extended upright and palm face out, we do this at all meetings when we first go in. At meetings we have a secret pass word which is "ISSA" and we raise both hands, fingers and thumbs extended upright palms facing out, which represents the ten wonders of the world.

Q. At the close of all meetings, I understand they read a warning, is that right?

A. Yes, they say, stop flashing your cards at Europeans, it causes confusion, because this is a new era of time and all nations should recognize nationalities.

Q. Why didn't you tell us these things the first time you were questioned?

A. I was afraid they would do something to me, take my life.
