On March 27, 1951 [redacted] of Los Angeles, was interviewed by SAS [redacted] and [redacted] during which [redacted] recalled NAT KING COLE as an old friend and contact of CP member [redacted]. [redacted] said that he had recently seen KING COLE and talked with him briefly; that he, [redacted] feels positive COLE would be amenable to discussing his CP membership and activities with a Bureau agent. [redacted] recalled that sometime in the early 1940's [redacted] and one [redacted] (phonetic) brought COLE to [redacted] and talked with him regarding receiving instruction from [redacted] in the subject of Marxism. It was decided, however, that [redacted] should not be the one to give COLE such instruction because [redacted] is colored. NAT KING COLE himself is also colored, although according to [redacted] he was at that time, and still is, associating almost exclusively with white "progressives".

For the Bureau's information, NAT KING COLE is the well known Negro musician who lives in Los Angeles and who recently received considerable mention in the press due to income tax difficulties with the Internal Revenue Department, which seized COLE's home for payment of back taxes due the Government. It has been since reported in the press, however, that COLE has recovered his property by making some sort of an arrangement for the payment of these taxes.

From information furnished this office in 1945 by [redacted] it appears that COLE [redacted] were members of the Communist Party and the Communist Political Association during that period, probably attached to the cultural groups in Hollywood. Our files indicate, however, that COLE was on tour a considerable part of the time and no particular Communist activity on his part has been reported.

It is possible that COLE may have dropped out of the CP movement since that period and, as indicated by [redacted] above, might be willing to discuss his past affiliation with representatives of this Bureau. If so, he might be able to





Unless additional information is received from other available sources, therefore, to indicate that COLE would be receptive to an interview and could furnish information of value, no attempt to contact him is being made UACB.

Justice In The Cole Case

Conviction of four men in Recorder's Court on charges growing out of the attack last week on singer Nat (King) Cole in Municipal Auditorium should give the world notice that Birmingham does not tolerate that kind of despicable business. Each of the four men was sentenced to 180 days in jail and fines also were assessed. Evidence developed by police indicates

that a large scale attack on the Negro singer was planned but that the majority of those involved apparently backed out, leaving only a small group to make the attempt. Members of the Police Department especially are to be praised for their work in breaking up this attack and in helping to bring the men accused to justice.

Resumes Monday

Four go on trial, attack details told

The slow-moving trial of four men accused in an assault on Negro Singer Nat (King) Cole resumes in Recorder's Court Monday morning.

Only one witness testified after the proceeding got under way Friday in Judge Ralph Parker's court. Fifteen were sworn in.

POLICE OFFICER H. E. Schatz, first to reach the Negro entertainer when he was felled on the stage of Municipal Auditorium last Tuesday night, told the court how police dragged two men forcibly out of the building after the assault.

Schatz testified he and Officer A. A. Norman knocked the two men into the orchestra pit when one tried to drag Cole off the stage.

Schatz's testimony mainly concerned two men not yet on trial. The four being tried are accused of a variety of misdemeanors in connection with the assault.

JUDGE PARKER ordered the trial to begin over vigorous defense objections. He overruled motions by Defense Atty. Rodrick Beddow for a two-week continuance and separate trials for the four defendants.

Beddow contended the four were "dissociated from each other."

Police investigators have charged that the assault was a conspiracy in which 150 men were to take part.

Another delay of more than an hour came when Judge Parker ordered the prosecution to prepare separate warrants in each case. He pointed out that the defendants could be found guilty of only one charge contained in a warrant.

One charge against each of three of the defendants was dropped in the proceedings.

ALL SIX MEN, the four now on trial and the two facing preliminary hearing on felony counts, are members of the North Alabama Citizens Council, a strongly pro-segregation organization.

The defendants and the charges against them now are:

Mike Fox, 36, conspiracy to commit a breach of the peace and conspiracy to commit assault and battery (one warrant).

Edgar Leo Vinson, 25, disorderly conduct and conspiracy to commit assault and battery.

Orliss Wade Clevenger, 18, disorderly conduct, carrying a concealed weapon and conspiracy to commit assault and battery.

Jesse W. Mabry, 43, disorderly conduct, refusal to obey the lawful command of an officer and conspiracy to commit a breach of the peace.

All but Mabry are from Anniston. Mabry, who lives at 9600 West-bivd, Roebuck, is associate editor of The Southerner, a publication of the North Alabama Citizens Council.

OFFICER SCHATZ said he was at the east end of the Auditorium stage about 8:50 p.m. Tuesday night when he saw Willie Robert Vinson, 23, and Kenneth Adams, 25, running down the east aisle.

W. R. Vinson and Adams, also of Anniston, face preliminary hearing April 20 on charges of assault with intent to murder. Adams is an official of the Anniston White Citizens Council.

Schatz testified W. R. Vinson dived on stage and grabbed Cole by his legs, dragging him down. Adams dived over Vinson's shoulders, the witness said.

"I went over and knocked Vinson from his hold. About that time Officer A. A. Norman grabbed Adams. Adams jerked like he was going to run and I knocked him off the stage. Norman went with him. We arrested Vinson and Adams," Schatz said.

SCHATZ SAID he saw Mabry, who followed the officers out, asking, "why we had the white boys under arrest when we ought to be in the Auditorium beating the Negro."

Needless to say, the grand prize is a first class trip for two around the world. To feature this contest, a large replica of the balloon used in the motion picture of a similar name has been placed in front of the Hotel.

I have insisted to the Agents at both Las Vegas and Reno that materially increased informant coverage is necessary, and you can be sure I will personally follow this important matter.

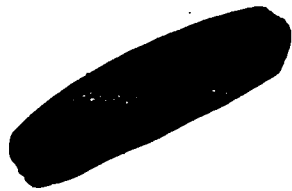





He was issued Passport Number 342195 on August 25, 1950, to depart from New York about September 1, 1950, for a six week's concert tour to England. This passport was renewed to be valid until August 24, 1954. He indicated he intended to depart from New York, March 19, 1954, for a six week's business trip as a performer to England, France, Denmark, Belgium, Switzerland, Sweden, Italy, and Norway. On December 30, 1954, COLE was issued Passport Number 33112 (San Francisco series) for a three week's entertaining tour to Australia, leaving Los Angeles about December 31, 1954.

On March 11, 1959, COLE was issued Passport Number 1327734 based on an application dated March 6, 1959, at Las Vegas, Nevada, for travel to various South American countries for seven to eight weeks on a theatrical and entertainment tour. In his application, COLE denied present or past Communist Party membership.

This last passport was renewed March 2, 1961 at Los Angeles, California, the application indicated COLE

In 1945, a confidential source furnished information to the effect that NAT COLE [redacted] were affiliated with the Communist Party (CP) or Communist Political Association (CPA) at Los Angeles during the period 1944 - 1945, probably attached to one of the CP's so-called cultural groups in Hollywood. However, it was also indicated that COLE was on tour a considerable part of the time; and no particular CP activity on his part was known to informant.

In 1951, another source, now deceased, who was once personally acquainted with COLE, recalled that sometime during the early 1940s, NAT KING COLE was brought around to see the source by a motion picture actor who was known to the source as an old time CP member. The purpose of the visit was to arrange for COLE to receive instruction in Marxism. The arrangement was not carried through, however, for the reason that it was decided that the source who was to be the instructor was colored, and NAT KING COLE, although himself colored, was at the time associating almost exclusively with white "progressives".

Confidential sources who are currently connected with the Professional-Cultural Section of the CP and who have some information regarding their membership and activities, advise they have no information that NAT KING COLE is affiliated with the CP organization at Los Angeles, nor have they heard him referred to in any CP meeting as though he might be a member or even sympathetic to the Party.


