WALLACE supporters following the 1968 Presidential election for the stated purpose of countering radical leftist and anarchist influences on the campuses of American colleges and universities. Its efforts to establish in this country a German-type national socialism of the Hitler era emphasize white racist and anti-Semitic policies. The NYA tabloid newspaper, "Attack!" in its Summer, 1971, (Number 6) issue, advocated revolutionary action to destroy the existing system, since "It is no longer possible to cure the System...by Constitutional methods." 

Wallace supporters following the 1968 Presidential election for the purpose of countering radical leftist and anarchist influences of American colleges and universities. NYA currently is controlled by individuals who militantly promote white racism and anti-Semitism and who suggest violent influences as the means for implementing their radical and political ideals in America. The NYA publishes a newspaper entitled "Attack" which aspouses the aims and purposes of the organization. This group has been under inves tigation by the FBI since 1969.

An informative note was prepared on 12/26/73 to which was attached an article, which appeared in "The Washington Post" daily newspaper, authored by Jack Anderson The article pointed out that the NYA has achieved tax exempt status from the IRS and reduced postal rates from the U. S. Postal Service as it is classified as a nonprofit organization. Neither IRS nor the U. S. Postal Service has previously been furnished, with results of our investigations Report is believed that the NIA is an active extremist organization and in view of the above, dissemination should be made of reports which have been prepared on this organization since 1969 to the RSJANdSCHWaff Postal Inspector.

The above letter dated October 30, 1973, has been reproduced and a copy is included in the appendix section of this report identified as Exhibit II.

II. OBJECTIVES AND PROGRAMS

An interview with WILLIAM L. PIERCE, Executive Director of NYA, printed in "The Journal", a weekly newspaper published at Arlington, Virginia, in its issue of April 26, 1973, is quoted in part as follows:

"One of NYA's credos is that racial tension and hatred are the inevitable outcome of a racially mixed society.

"'Separation is the only answer,' according to PIERCE. He predicted 'if we remain in our present course we're heading for cultural, national and racial choas. We already have it to some extent.'"

"NYA opposes all racially mixed marriages, as well as marriages between Jews and Christians. It is against forced racial mixing in schools, employment and housing.

"'You might say we agree with the Black Muslims in spirit, since we're both concerned that our peoples should be able to develop according to our own natures,' PIERCE observed. 'We should think of the race as the central entity, and the individual as a part of the race.'

"ABRAHAM LINCOLN, touted as the man who abolished slavery, wanted separate futures for blacks and whites after abolition, according to PIERCE. 'LINCOLN and most abolitionists wanted to settle former slaves in Africa or the Caribbean.'

"Racial pride is one answer for students without any apparent sense of community or value, according to NYA. Life is just a series of kicks to many of them. Drugs are just one outcome of this attitude of doing what you damn well please without any responsibility to anyone else,' PIERCE said.

"NYA also opposes Zionism, and U.S. aid to Israel against the Palestinians forced to leave the country. Unlike other groups termed 'right-wing,' it wants stronger rein on big business, saying that U.S. power is held by one wealth-accumulating class."


