



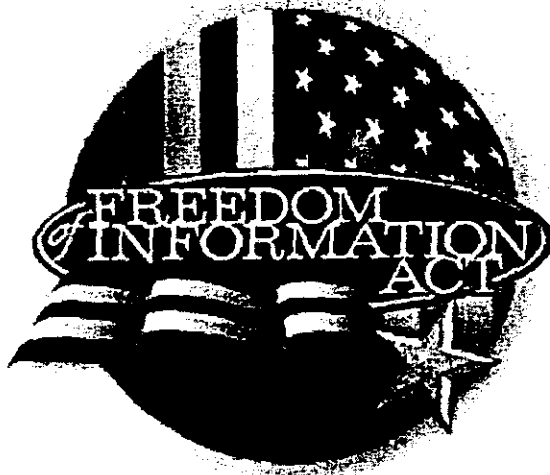

BACKGROUND:

By letter to the Director dated 10-10-64, Mr. Winchell said he had told Henry Plitt of ABC Films, Inc., New York, to write to the Director regarding "Disaster Squad." Mr. Winchell said he would appreciate permission to use it as the pilot for his upcoming series. He went on to say that "Mr. Plitt won a Peabody Award in 1962 when he and Fae Thomas (I introduced her to you and Clyde at Del Mar) co-produced a series for that network."

Mr. Winchell also enclosed a favorable editorial from "The San Diego Union," the original of which is being acknowledged by the Correspondence and Tours Section.

INFORMATION IN BUFILES:

Bufiles contain no derogatory information regarding Henry Plitt, who is President of ABC Films. He was the victim in a recent Interstate Transportation of Stolen Property - Major Theft investigation captioned [redacted] aka [redacted] aka, "Bufile 87-76251. Approximately \$72,000 in jewelry was involved in this case. Bufiles contain no information concerning Fae Thomas. ABC Films is affiliated with the American Broadcasting Company. We have enjoyed good relations with the latter concern.

RE: REFERENCE TO "DISASTER SQUAD":

Bufiles and appropriate checks of other Bureau divisions fail to reflect any information concerning "Disaster Squad" in connection with a film to be used by Mr. Winchell. It is noted that on 7-22-64, Mr. Winchell advised the Los Angeles Office that he was contracting with ABC Films, Inc., to do a television series of 39 30-minute programs entitled "Walter Winchell Narrates 'Headliners.'" Mr. Winchell advised that the format of the show would involve showing old newsreel clippings of famous incidents, particularly in the criminal field, with a narration by Mr. Winchell.

OBSERVATION:

While we have no information available concerning Mr. Winchell's proposed pilot film, presumably details are to be spelled out in a letter being prepared by Mr. Plitt. This letter has not yet been received at the Bureau. Since we do not have this information available, we are not in a position to consider Mr. Winchell's request that he be permitted to use "Disaster Squad" as the pilot film in his new series. Consequently, we are not able to comment on this at this time.

RECOMMENDATIONS:

1. That the attached letter of acknowledgement be sent to Mr. Winchell.
2. That upon receipt of a letter from Mr. Plitt, we consider his proposal and, at that time, if appropriate, an additional letter be sent to Mr. Winchell.

My memorandum of 10-14-64 noted receipt of a letter from Walter Winchell in which he advised the Director that he had told Henry G. Plitt, President, ABC Films, Inc., New York, to write to the Director regarding the "Disaster Squad." Mr. Winchell said he would appreciate permission to use it as the pilot for his upcoming series. Inasmuch as we had no information concerning such a film, a letter of general acknowledgment was sent to Mr. Winchell. It was recommended and approved that upon receipt of a letter from Mr. Plitt spelling out further details that we would consider his proposal at that time and, if appropriate, an additional letter would be directed to Mr. Winchell.

Bufiles reflected no derogatory information concerning Mr. Plitt and his company.

CURRENT DEVELOPMENT:

The Director has received a letter dated 10-15-64 from Mr. Plitt in which the latter advises that after his return from Europe, he would like to come to Washington and discuss this matter with the Director.

OBSERVATION:

The connection of Messrs. Winchell and Plitt with this program certainly indicates it will be a prime time television production and it is felt that we should give every consideration to extending cooperation.

FROM NEWSWEEK: "Ironically, Hoover has even managed to offend some of his more conservative well-wishers. DEAN DANIEL GUTMAN (of the N.Y. Law School) in the N.Y. Times: Every day in the week, criminals walk out of courts, cockier and more brazen than ever, and looking for new prey. They 'beat the rap'—a status achievement in the underworld. In many such cases, the acquittal or dismissal has resulted not from lack of evidence, but from the fact that evidence of crime was obtained by unapproved methods. A technicality has precluded its use."

But when J. Edgar Hoover protests the coddling of criminals, he is accused of being anti-civil rights.

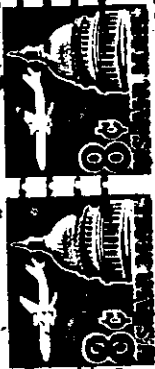

THE N. Y. TIMES editorial page recently intoned: "Under the circumstances, it would be wise to let the mandatory provisions of the Federal retirement law take effect on Mr. Hoover's 70th birthday."

The same newspaper on May 10, 1964 reported: "No one disputes Mr. Hoover's solid accomplishments. He has eliminated political influence in appointments. He had the foresight to promote—on a scale never before attempted in America—high scientific standards in detective work. And he established a huge fingerprint collection, an indispensable resource in tracking down criminals. He also created a skilled laboratory to make scientific tests on minute physical clues. Mr. Hoover also founded the National Police Academy, which trains selected officers from departments throughout the country in the latest scientific methods" . . . The newspaper added: "Mr. Hoover has made an incalculable contribution to raising the standards of law enforcement in the United States."



★
THE NOVEMBER 26th, 1964 N. Y. Herald Tribune carried a statement by a civil rights leader that "the FBI director was carrying on a vendetta against civil rights groups." On the same page was a report from Jacksonville, Florida. It quoted J. B. Stoner, a leading Atlanta segregationist. Stoner attacked the FBI as "the federal bureau of integration." And accused the FBI of violating the rights of the Ku Klux Klan.

ONE CIVIL RIGHTS LEADER has called for the resignation of J. Edgar Hoover. The FBI chief was charged with failing to protect civil rights. What is the FBI record on civil rights? . . . In 1950 the Reader's Digest examined that record. The report was authored by Morris Ernst, then counsel for the American Civil Liberties Union. It was noted: "The FBI is unique in the history of national police. It has a magnificent record of respect for individual freedom. It invites documented complaints against its agents. It has zealously tried to prevent itself from violating the democratic process."

"Among liberals I am by no means alone in this opinion. A while ago Roger Baldwin, formerly director of the American Civil Liberties Union, wrote to J. Edgar Hoover: 'It seems to me that your bureau has accomplished an exceedingly difficult task with rare judicial sense.'"

MR. 1. ★ I ALSO CERTIFIED: "I wrote articles in which I ask readers to send me any evidence they might have that the FBI had violated a person's constitutional rights. My scoreboard shows a remarkable absence of such accusations."

It is significant that those who are charging the FBI Director with failing to protect civil rights have not offered a single fragment of evidence to support their charges.

THE NOVEMBER 27TH, 1964 Time mag reported: "J. Edgar Hoover has many old foes, has made a legion of new ones recently; undoubtedly there will be vastly increased pressures on the White House from now on to boot the old fellow out of his job."

Most of Mr. Hoover's foes are criminals, Communists, Fascists and Nazis. He has devoted forty years to fighting them. His friends are the overwhelming majority of Americans, which explains why he has held his job for four decades.

A NEW YORK EDITORIAL page smear: "J. Edgar Hoover has plainly exposed himself as unfit to serve as the key figure in the battle against the segregationist mob and the racist underworld."

Newsday stressed the facts: "Actually, northern FBI men are well in the majority in the South. The FBI's record of loyalty serves as evidence that they do their duty whatever their personal feelings."

★ FROM A N. Y. NEWSPAPER: "We do not minimize the complexity of law enforcement in the backward Southern regions. We do say that Mr. Hoover has bluntly confessed that he has no heart for the effort; he is a states rights man."

THE SUGGESTION that supporting states rights violates the concept of racial equality is the sheerest of nonsense. As a matter of fact it verges on lunacy. States rights are an important segment of the American Constitution. For example, Article 10 in the Bill of Rights clearly states: "The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people." Also see Article 4.

NEW YORK: A leader of the national civil rights movement has demanded the resignation of FBI Director J. Edgar Hoover, accusing him of damaging the struggle for civil rights."

On Nov. 22 commentator Max Lerner wrote: "I doubt whether Hoover will hurt the civil rights movement much by his attack on King, or his remark about 'wet-nursing everybody who goes down South.' I should even guess that he will have to even be more on his mettle now in showing that his FBI Southern staff does not share the prejudices of local Southern police."

★ OVER AND OVER AGAIN the public record affirms J. Edgar Hoover's respect for civil rights . . . It was Mr. Hoover who once asked the U.S. Attorney General NOT to endorse a law that would legalize free use of wire-tapping . . . Such free use of wire-tapping would have made the FBI's job much easier. But Mr. Hoover explained his opposition to indiscriminate wire-tapping by police agencies: "I do not wish to be the head of an organization of potential blackmailers."

THE AFOREMENTIONED Morris Ernst has written: "On Pearl Harbor Day the FBI was able to advise the Attorney General of the basis for authorizing the arrest of some 16,000 persons. A few of the 16,000 became my clients. I defended them before hearing boards and was able to help free some of them. In every case there were fair hearings, with every consideration being shown to the defense. And although I was the lawyer for certain acquitted suspects, I must admit that Mr. Hoover had a justification in picking up my clients; there was cause for suspicion and no injustice was done."

'Free Speech' Shields CP Ties

Although "free speech" is the insurrectionists' attractive password at the University of California, the real issue is: will the administration consent to allowing its campuses to be used as recruiting and agitation centers for the Communist movement?

Despite the well-concealed strategy of the rebellion, a few obvious connections with the Communist movement were already clear:

- The Free Speech Movement and the case of identified Communist professor Eli Katz are connected according to the FSM's own admission (TOCSIN, Dec. 5, 1964).

- One outside Communist group, the Progressive Labor Movement, issued literature which began as a defense of the "free speech" rebels and quickly turned into an agitprop document against U.S. anti-Communism in the Congo and Vietnam.

- The lawyer defending arrested students is identified Communist Robert E.

Treuhart, partner in the firm of identified Communist Doris Brin Walker of a famed Korean War sedition case.

- That old Communist stand-by charge of "police brutality" was being bandied about by the FSM leadership even before police officers had made a single arrest.

- The immediate objective of the Free Speech Movement is University-approved picketing rights for the Marxist-run Ad Hoc Committee to End Discrimination.

- Newly elected California Assemblyman John Burton told a campus rally Dec. 4 that he would seek support for the student rebels from Harry Bridges' International Longshoremen's and Warehousemen's Union. Burton is wed to the former Michele Hall, a delegate to the 1962 Communist World Youth Festival and daughter of identified Communist Jack Hall, an ILWU leader in Hawaii.

- Lee Harvey Oswald's self-appointed attorney, Mark Lane of New York, spoke

YSA Leader On Campus

A self-admitted former organizer for the Young Communist League, Rustin in 1953 spent 60 days in jail on a charge of lewd vagrancy after being arrested in Pasadena, Calif. He was then employed by the Fellowship of Reconciliation, a militantly pacifist organization.

'A HEALTHY CLIMATE FOR ACADEMIC FREEDOM?'

Why UC Profs Back Rebels

How can one explain the tremendous surge of faculty support for the lawless "free speech" rebellion at the University of California?

Despite the acknowledged presence of Communist agitpropping, this factor alone is insufficient to account for the reflex sympathy which professors in widely separate fields have thrown behind the rebel movement.

A more exact explanation must take into account the cardinal principle of Communist strategy: The Communist movement does not ordinarily create situations so much as it exploits them.

In the academic world, the exploitable situation was already existent in the universal professorial horror of Babbitry and philistinism. Almost to a man, faculty members suffer from an acute sense of superiority over their stereotype of the uncultured businessman who controls the "power structure." Despite increases in faculty salaries and the handsome fringe benefits which many now derive as consultants to business, professors still feel themselves to be the unappreciated geniuses of a world ruled by squares.

FLATTER THE EGO

Where the Communist movement makes its pitch to minorities on the basis of a reverse racism and to labor unions on the basis of wage exploitation, the academic world is wooed through flattery of its ego. An equation of intellectual sophistication and Communist goals has been possible largely because the typical faculty member would rather be caught dead than look like a yokel. Conformist to a degree unheard of even in the military, he falls easy prey to the social pressures exerted by departmental colleagues. Since few university departments are without their articulate Marxist sympathizers, the professorial pattern of conformism provides a resistance-free audience.

The recalcitrant "free-speech" student mob is only acting as a lobbyist for the timid faculty members whose disgust with "unsophisticated" American society is confined to sarcastic classroom lectures. Lacking the courage of their own rebellion, faculty members cheer from the sidelines at their impassioned students who naively accept criticism of the American system as commands to direct action.

Communist strategist Alexander Trachtenberg once observed that a man who is wise in his own specialized field may be quite a child politically. This unfortunate fact helps explain why teachers who proudly practice the scientific method in their own work and condemn others for their failure to do so elsewhere fall second to no one in their use of stereotypes and destructive generalizations.

Kerr's Policies Under Spotlight

Seventeen broken windows were the last remaining physical sign of the "free speech" sit-in which ripped the University of California's Berkeley campus Dec. 3 and brought the arrest of 814 persons.

But the moral stench generated by the insurrection hovers over the nation's largest university in ugly confirmation of the rebels' promise that "You ain't seen nothin' yet."

Never in history has the American university scene beheld its like.

The fact that such an insurrection could take place at all was incredible. The fact that it took place only a few months after President Clark Kerr had received a tribute from the American Association of University Professors for "notable service in establishing a healthy climate for academic freedom" cast sorely needed illumination on Kerr's policies, as well as on the currently fashionable definition of "academic freedom."

SPEAKER BAN

For Kerr's service to the healthy climate referred to by the Association meant specifically the removal in 1963 of the University ban against acknowledged Communist speakers. The whole "free speech" insurrection resulted after the University suddenly decided last September, for reasons still unclear, to move for once in an opposite direction by cracking down on left-wing student politicking.

Though Kerr has now emerged as the spokesman for old-fashioned law and order, his past pronouncements made it seem as if he were now acting "à contre-Kerr," as one language teacher expressed it.

His long-time "see no evil" policies, now forever discredited, were typified by Charter Day aphorisms, which student rebels could interpret only as an invitation to license.

The lonely, unorganized student and faculty opponents of campus lawlessness suddenly found it impossible to draw courage from such Kerr slogans as "Our American ideals . . . need no special care except daily exercise."

'STRIKEBREAKERS'

If anyone's free speech was being violated, it was surely that of the majority of hard-working students trying doggedly to finish their college educations at a University where instructors were refusing to hold classes. Amazing only to an uninformed public was the fact that students who chose to take scheduled examinations during the Dec. 4 strike were viewed by some rebel professors as rat-finks and strikebreakers, and subtly threatened with "if you know what's good for you" looks.

California legislators, long irritated at the closed-doors decision-making that has

shrouded Kerr's administration of this sacred public trust, are now insisting on a thorough examination of the whole mess.

But in the tradition of go-getting career men in tough spots, Kerr is now a candidate for being "kicked upstairs." For several weeks rumors have been rife to the effect that President Johnson is about to appoint Kerr to the Cabinet post of Secretary of Health, Education and Welfare.

Revolt Blueprint Sold on Campus

A fifteen-cent blueprint for the kind of revolution that took place last week in Berkeley was sold to students as they enrolled for classes at the beginning of the present semester.

It bears the by-line of former UC student Herbert B. ("Brad") Cleveland, 31, and was sold under the aegis of the radical left-wing Slate political party.

Cleveland, one of Slate's elder statesmen, made these bold recommendations, which took on new meaning in the light of the Dec. 3 siege and subsequent campus strike:

(The University) "does not deserve a response of loyalty and allegiance from you. There is only one proper response to Berkeley from undergraduates: that you ORGANIZE AND SPLIT THIS CAMPUS WIDE OPEN!" (emphasis in original).

SLATE INSERT

The report was inserted in the popular "Slate Supplement to the General Catalog," which recommends courses on the basis of student polls under the editorship of Phil Roos.

Cleveland's report, subtitled "A Letter to Undergraduates," also asked for the "resignation of Clark Kerr" and "of top administrators who might employ slick diverting tactics. Reconstitution of the Board of Regents, either through firing or expansion, perhaps both."

To insure that complaints are answered, Cleveland declared that students should "Go to the top. Make your demands to the Regents. If they refuse to give you an audience, start a program of agitation, petitioning, rallies, etc., in which the final resort will be CIVIL DISOBEDIENCE. In the long run there is the possibility that you will find it necessary to perform civil disobedience at a couple of major University public ceremonies."

The letter also demanded "immediate disbanding of all University dorm and living group rules which prescribe hours and which provide a system of student-imposed discipline, thereby dividing students against themselves."

PHASING OUT

The National Committee to Abolish the House Committee on Un-American Activities, a Los Angeles-based Communist front, is circulating a petition asking that the anti-subversive committee be abolished. The appeal, addressed to the House of Representatives, also asks that HCUA's files be transferred to the Archives on condition that they not be opened for 50 years. After the U.S. government has been safely overthrown?

Letters to the editors of Communist papers indicate that docile readers are terribly confused about how to rationalize Khrushchev's ouster. "The action appears to have been entirely within the framework of democratic process," insists one letter to the National Guardian last month. Other readers are hanging on tightly to their criticisms of the "method" used.

Newest Communist-line defense committee: the Committee to Defend Resistance to Ghetto Life, an outgrowth of the Harlem race riots last July. Chairman is Bill McAdoo, a member of the so-called Harlem Defense Council which helped foment the demonstrations. Secretary is Susan Karp.

Our cosmic Communists: Whenever a Communist-supported organization is under attack, the Communist press inevitably launches a campaign of mendacious hyperbole. Example: the current probe of the Communist-infiltrated Mobilization for Youth social welfare organization "forecasts an attack on the entire anti-poverty program," according to the Worker.

Fun game: Try to locate in any Communist paper a reference to the political right-wing not preceded by the word "Ultra."

Double standard: Anti-Communists take it on the chin when the Worker slanders them with the adjective "fascist-tending," but identified Communists pose as injured innocents when our big metropolitan dailies timidly refer to them as "alleged fellow-travelers."

UC Rebels' Communist Lawyer

Identified Communist Robert E. Treuhaft and avowed Marxist Vincent Hallinan are acting as counsels for persons arrested at the University of California "free speech" sit-in Dec. 3.

No stranger to University affairs, Treuhaft was pictured at an earlier "free speech" demonstration last month on the Berkeley campus (TOCSIN, Nov. 28, 1964). He was among pickets protesting the imprisonment of atom spy Morton Sobell and other issues during the Berkeley Charter Day visit of President Kennedy, March 23, 1962. Hallinan's sons were early supporters of Slate, radical left-wing student political party founded in the late '50s.

Long associated with so-called "police brutality" cases, Treuhaft represented Oaklander Walter Owens in a suit against peace officers in 1950. Treuhaft and his

former partner, identified Communist Bertram Edises, in conjunction with a cited Communist front called the Civil Rights Congress, charged "police brutality" before a California Assembly Interim Committee on Crime and Correction as long ago as January 1950.

Observers of the Berkeley controversy have noted that the Free Speech Movement leadership has displayed a virtual fixation with the "police brutality" theme. FSM boss Mario Savio, after biting the leg of police officer Philip Mower during the first wave of demonstrations which ended Oct. 2, later insisted on raising the "police brutality" issue on a San Francisco radio forum.

TV viewers heard one limp demonstrator arrested in the Dec. 3 sit-in yell "The police are heatin' hell out of us!" while being carted off gently by two officers.

Some Sit-in Leaders Stayed Outside Hall

The campus hard-core leadership of the Free Speech Movement appears to have let a majority of naive newcomers take the rap.

Among the 814 persons arrested, the greater number are unfamiliar names. The "free speech" rebels shrewdly contrived to place an escape rope at a Sproul Hall window so that the movement's experienced leaders could keep the insurrection brewing despite mass arrests.

FSM leaders who did not turn up among the arrestees included such activists as Ken Cloke, son of identified Communists Richard and Shirley Cloke; Larry Shumm, Brian Shannon and John Belisle, of the Trotskyite-Communist Young Socialist Alliance; Robert Paul Kaufman, Steve Weissman and Martin Roysner.

Three prominent names among those who were arrested were Bettina Aptheker, daughter of leading Communist Party theoretician Herbert Aptheker; Margaret Lima, daughter of Northern California Communist Party Chairman Albert J. Lima; and Lee Goldblatt, daughter of identified Communist Louis Goldblatt, secretary-treasurer of Harry Bridges' International Longshoremen's and Warehousemen's Union.

on campus Nov. 30 in firm support of the rebellion. Lane's "brief" to the Warren Commission, first printed in the Communist National Guardian, sparked the Communists' "Oswald was framed" drive.

Fact of Life

An undeniable fact of contemporary American life is the existence of an irrational and omnipresent taboo against criticism of the Soviet "experiment."

'Germ Warfare' Prof's Kin Is DuBois Editor

Celia Rosebury Cohen, 24, has an unusual address: 1853 1/2 McAllister St., San Francisco, national headquarters of the Communist-spawned W.E.B. DuBois Clubs of America. She is serving as full-time managing editor of the new club magazine, the Insurgent.

A close friend of young Communist Party National Convention delegate Douglas Wachter of Berkeley, the present Mrs. Cohen was among students who last year signed the protest petition against the University of California ban on Communist speakers.

Mrs. Cohen is the daughter of Dr. Theodor Rosebury, of the Washington University Medical School, St. Louis, who has been affiliated with Communist fronts for more than two decades.

During the Korean War when the Communist press was seeking to raise the phony issue of "germ warfare," Rosebury joined some 40 signers of a letter to President Truman printed in the Daily Worker of June 8, 1952, in reference to the germ-warfare question. In the letter he was identified as director of U.S. armed forces germ warfare research during World War II.

Rosebury also sponsored activities of the American Peace Crusade, the American Committee for Protection of Foreign Born and the National Conference to Repeal the Walter-McCarran Law—all Communist-backed enterprises.

During the '60s, his name has appeared as a sponsor of activities of the Emergency Civil Liberties Committee, the National Assembly for Democratic Rights and other Communist-supported groups.

Non-Student Jeter at UC



NON-STUDENT HOWARD JETER (left) and University of California teaching assistant Michael Rossman are shown in attendance at a campus "free speech" demonstration recently. Jeter was the Communist-backed candidate for Congressman in 1962. A Balboa High School teacher, Jeter organized a picket of California Governor Edmund G. Brown last April in San Francisco, protesting the governor's actions on civil rights. Jeter was announced as the featured speaker at a picnic sponsored June 17, 1962, by the Communist National Guardian. Last year he was one of four persons named to speak at a 50th-birthday testimonial to identified Communist Jean Kramer, executive director of the Communist-run Northern California Committee for Protection of Foreign Born. In 1947 Jeter was arrested for possessing a deadly weapon after a fracas in an East Bay tavern. Rossman is in charge of a survey being conducted by the University of California "free speech" rebels on alleged repression of political expression.

Debunking the Bunk

The N.Y. Times editorial page recently intoned: "Under the circumstances, it would be wise to let the mandatory provisions of the Federal retirement law take effect on Mr. Hoover's 70th birthday."

The same newspaper on May 10, 1964, reported: "No one disputes Mr. Hoover's solid accomplishments. He has eliminated political influence in appointments. He had the foresight to promote—on a scale never before attempted in America—high scientific standards in detective work. And he established a huge fingerprint collection, an indispensable resource in tracking down criminals. He also created a skilled laboratory to make scientific tests on minute physical clues. Mr. Hoover also founded the National Police Academy, which trains selected officers from departments throughout the country in the latest scientific methods" . . . The newspaper added: "Mr. Hoover has made an incalculable contribution to raising the standards of law enforcement in the United States."

The Nov. 26, 1964, N.Y. Herald Tribune carried a statement by a civil rights leader that "the FBI director was carrying on a vendetta against civil rights groups."

On the same page was a report from Jacksonville, Florida. It quoted J. B. Stoner, a leading Atlanta segregationist. Stoner attacked the FBI as "the Federal Bureau of Integration." And accused the FBI of violating the rights of the Ku Klux Klan.

One civil rights leader has called for the resignation of J. Edgar Hoover. The FBI chief was charged with failing to protect civil rights. What is the FBI record on civil rights? . . . In 1950 the Reader's Digest examined that record. The report was authored by Morris Ernst, then counsel for the American Civil Liberties Union. It noted: "The FBI is unique in history of national police. It has a magnificent record of respect for individual freedom. It invites documented complaints against its agents. It has zealously tried to prevent itself from violating the Democratic process."

"Among liberals I am by no means alone in this opinion. A while ago Roger Baldwin, formerly director of the American Civil Liberties Union, wrote to J. Edgar Hoover: 'It seems to me that your bureau has accomplished an exceedingly difficult task with rare judicial sense.'"

"J. Edgar Hoover has many old foes, has made a legion of new ones recently; undoubtedly there will be vastly increased pressures on the White House from now on to boot the old fellow out of his job."

Most of Mr. Hoover's foes are criminals, Communists, Fascists and Nazis. He has devoted 40 years to fighting them. His friends are the overwhelming majority of Americans, which explains why he has held his job for four decades.

The suggestion that supporting states rights violates the concept of racial equality is the sheerest of nonsense. As a matter of fact it verges on lunacy. States rights are an important segment of the American Constitution. For example, Article 10 in the Bill of Rights clearly states:

"The powers not delegated to the United States by the constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people." Also see Article 4.

"New York: A leader of the National Civil Rights Movement has demanded the resignation of FBI director J. Edgar Hoover, accusing him of damaging the struggle for civil rights."

On Nov. 22 commentator Max Lerner wrote:

"I doubt whether Hoover will hurt the civil rights movement much by his attack on King, or his remark about 'wet-nursing everybody who goes down South.' I should even guess that he will have to even be more on his mettle now in showing that his FBI Southern staff does not share the prejudices of local Southern police."

Over and over again the public record affirms J. Edgar Hoover's respect for civil rights . . . It was Mr. Hoover who once asked the U.S. attorney general not to endorse a law that would legalize free use of wire tapping . . . Such free use of wire-tapping would have made the FBI's job much easier. But Mr. Hoover explained his opposition to indiscriminate wire-tapping by police agencies: "I do not wish to be the head of an organization of potential blackmailers."

The aforementioned Morris Ernst has written:

"On Pearl Harbor Day the FBI was able to advise the attorney general of the basis for authorizing the arrest of some 16,000 persons. A few of the 16,000 became my clients. I defended them before hearing

Debunking the Bunk

The N.Y. Times editorial page recently intoned: "Under the circumstances, it would be wise to let the mandatory provisions of the Federal retirement law take effect on Mr. Hoover's 70th birthday."

The same newspaper on May 10, 1964, reported: "No one disputes Mr. Hoover's solid accomplishments. He has eliminated political influence in appointments. He had the foresight to promote—on a scale never before attempted in America—high scientific standards in detective work. He established a huge fingerprint collection, an indispensable resource in tracking down criminals. He also created a skilled laboratory to make scientific tests on minute physical clues. Mr. Hoover also founded the National Police Academy, which trains selected officers from departments throughout the country in the latest scientific methods" . . . The newspaper added: "Mr. Hoover has made an incalculable contribution to raising the standards of law enforcement in the United States."

"J. Edgar Hoover has many old foes, has made a legion of new ones recently; undoubtedly there will be vastly increased pressures on the White House from now on to boot the old man out of his job."

Most of Mr. Hoover's foes are non-Communist, Fascist and Nazi. He has devoted 30 years to fighting them. His friends are the overwhelming majority of Americans, which explains why he has held his job for four decades.

The suggestion that supporting civil rights violates the concept of federalism is the sincerest of non-sense. As a matter of fact it verges on lunacy. Supporting civil rights is an important segment of the American Constitution. For example, Article III in the Bill of Rights clearly states:

"The powers not delegated to the United States by the constitution, nor prohibited by it to the states, are reserved to the states respectively, or to the people." sec. article 1

"New York: A leader of the Civil Rights Movement demanded the resignation of FBI director J. Edgar Hoover, accusing him of damaging the struggle for civil rights."

On Nov. 22 commentator Max Lerner wrote:

"I doubt whether Hoover will hurt the civil rights movement more by his continuing, or his remarks about the movement, or anybody who goes down Southern roads to even a guess that he will have to even come on his mettle now knowing that his FBI Southern staff is not share the prejudices of local Southern police."

Over and over again the public record affirms J. Edgar Hoover's respect for civil rights . . . It was Mr. Hoover who once asked the U.S. attorney general not to endorse a law that would legalize free use of wire tapping . . . Such free use of wire-tapping would have made the FBI's job much easier. But Mr. Hoover explained his opposition to indiscriminate wire-tapping by police agencies: "I do not wish to be the head of an organization of potential blackmailers."

The aforementioned Morris Ernst has written:

On Pearl Harbor Day the FBI was able to advise the attorney general of the basis for authorizing the arrest of some 10,000 persons. A few of the 10,000 became my clients. I defended them, and was able to help them out of jail. In every case there were no charges with every consideration given to their defense. And although I have the honor for certain acquitted persons, I must admit Mr. Hoover had a great deal in helping up my clients; there was no cause for suspicion and no injustice was done."

Can you or your neighbor have any evidence to prove a member of the FBI violated any American's civil rights—you can borrow this space to make it pub-

The Nov. 26, 1964, N.Y. Herald Tribune carried a statement by a civil rights leader that "the FBI director was carrying on a vendetta against civil rights groups."

On the same page was a report from Jacksonville, Florida. It quoted J. B. Stoner, a leading Atlanta segregationist. Stoner attacked the FBI as "the Federal Enforcer" and accused the FBI of "rights of the Ku Klux Klan."

A civil rights leader has called for the resignation of J. Edgar Hoover. The FBI chief was charged with failing to protect civil rights. What is the FBI record on civil rights? . . . In 1950 the Reader's Digest examined that record. The report was authored by Morris Ernst, then counsel for the American Civil Liberties Union. It noted: "The FBI is unique in history of national police. It has a magnificent record of respect for individual freedom. It invites documented complaints against its agents. It has zealously tried to prevent itself from violating the Democratic process."

"Among liberals I am by no means alone in this opinion. A while ago Roger Baldwin, formerly director of the American Civil Liberties Union, wrote to J. Edgar Hoover: 'It seems to me that your bureau has accomplished an exceedingly difficult task with rare judicial sense.'"

Mr. Ernst also certified: "I wrote articles in which I asked readers to send me any evidence they might have that the FBI had violated a person's constitutional rights. My scoreboard shows a remarkable absence of such accusations."

It is significant that those who are charging the FBI director with failing to protect civil rights have not offered a single fragment of evidence to support their charges.

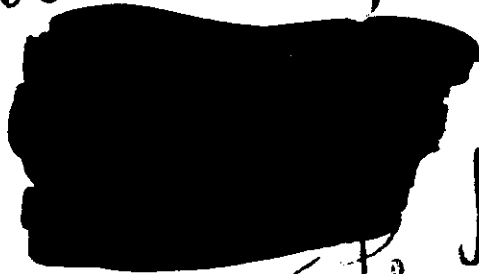

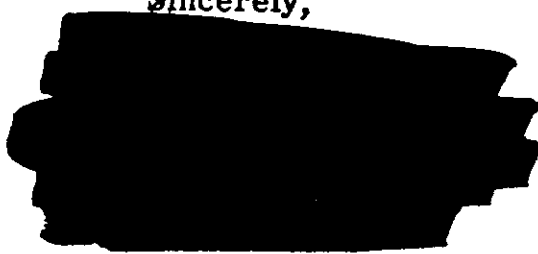

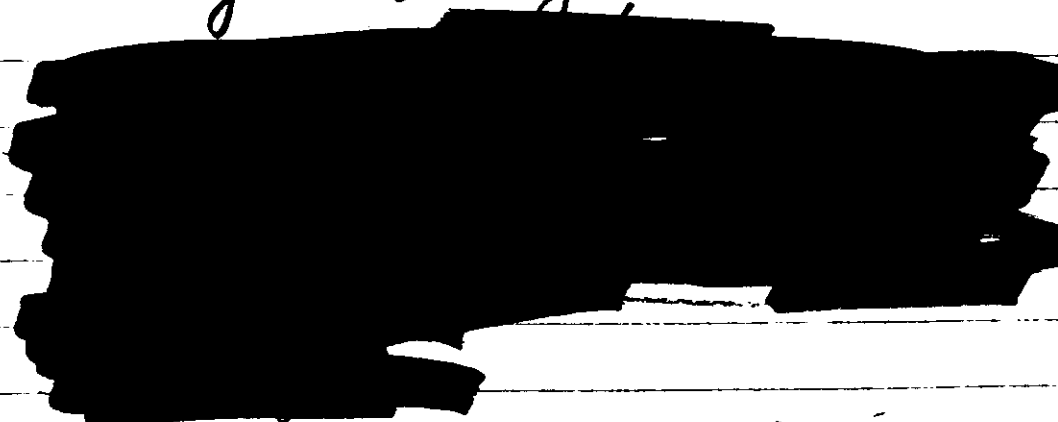

SUBJECT: ITEM RE "RED SPIES IN THE UN"
IN WALTER WINCHELL COLUMN

Reference is made to captioned column in the 2-26-65 issue of the "New York Journal American" which states that Pierre Huss and George Carpozi collaborated on captioned book and were given 50 photos of spies in action over here by the FBI. The Director noted "Is this correct?"

In early 1964 George Carpozi came to the Bureau and requested public source data on spies in the United Nations for a book he and Pierre Huss were writing. Approval was given to furnish him write-ups of old persona non grata cases.

In 8-64 Carpozi called the Bureau and asked for photos to illustrate his book. Upon approval, he was furnished 11 photographs in the Martynov case; these pictures involved the meeting of the FBI Agent disguised as an Army colonel with Martynov. They have been widely circulated previously. Carpozi on being furnished these pictures was told that he was not to attribute them to the FBI.

It is noted also that Carpozi recently sent us his manuscript which was a combination of facts woven with imagination. To protect our best interests, it was approved that we furnish Carpozi suggested changes. Carpozi was also told that the FBI was not responsible for data in his book and that he should make no public mention that he had been in contact with the FBI concerning the book.

White House (IES) -- The strong bipartisan go-ahead from Capitol Hill on Vietnam is regarded as a firm commitment, like the Democratic majority's endorsement of the Eisenhower Doctrine in 1958.

Capitol Hill (IES) -- Regardless of its merits the Dirksen constitutional amendment permitting state legislatures to be patterned after the Congress, with one House based on population and the other on factors other than population, appears doomed this year.

House Ways and Means Committee (IES) -- The Medicare bill (H.R. 1) will be taken up the third week of April, if not sooner, after the committee disposes of excise tax reduction.

Senate (IES) -- Chairman Willis Robertson's Banking and Currency Committee hearings next week on the international trade payments deficit will show U.S. tourism abroad is negligible in accounting for the dollar drain.

Paris (IES) -- Rep. Wayne Hays' proposal to levy a \$100 departure tax on Americans bound for France, as against a \$1 levy on Americans traveling elsewhere abroad, is regarded as frivolous. It's recalled that Hays is a regular traveler abroad, on official business, and once favored Air France on excursions to Paris.

Harrisburg (IES) -- Gov. Scranton can't run in 1966 to succeed himself and pretends to be indifferent about GOP presidential prospects in '68. But there's talk of drafting recently reelected Sen. Hugh Scott for governor, and of finding some way of keeping Scranton in the limelight. He's dealing with a Democratic-controlled House, a Republican-controlled legislature.

Albany, N.Y. (IES) -- Newcomer Democrats from suburbia and upstate "Bible Belt" districts frown on legalized off-track betting. If the Republicans remain solidly behind Rockefeller, enough Democratic votes are available to sustain a veto.

New York (IES) -- The talk about Sen. Jack Javits running for mayor if a Fusion ticket is organized shouldn't be taken seriously. Look for increasing emphasis on Rep. John V. Lindsay as GOP nominee.

Jerusalem (IES) -- France is supplanting West Germany as supplier of arms shipments Bonn suspended under pressure from Cairo. Bonn is expected to make up for its fumbling in this episode through other trade with Israel. West German rocket scientists still in Egypt will be under increasing pressure to come home or forfeit citizenship.

New York (IES) -- It's estimated that 1,800 hard-core conservationists in Westchester County constitute the nucleus of the fight against hydroelectric development in the Hudson Highlands. The Cornwell generating station is urgently needed for increasing metropolitan area power needs. Pols are puzzled as to why Sen. Bob Kennedy is joining with Rep. Richard Ottinger in backing the Interior Department-drafted bills to turn the area into a national park; Gov. Rockefeller is opposed to federal intervention and Secretary Udall six months ago said he had no objection to the power development, during FPC proceedings on the issue.

Tourism is Ireland's "invisible" export, that helps counter a deficit that is more theoretical than real. Irish International Airlines boasts the highest load factor in the transatlantic passenger traffic and is booked solid for this year's summer season.

Boston (IES) -- Columnist A.A. Michelson, writing in the Boston Globe and other Massachusetts dailies, notes that Sen. Ted Kennedy is the first member of his family to take on the leadership responsibilities of the Democrats in preparation for next year's election wars. The Democrats will have to field candidates against the formidable Leverett Saltonstall, a fixture in the U.S. Senate since his first election in 1944, after rating as a gubernatorial ball-of-fire on Beacon Hill, and Gov. John Volpe, who is certain to seek reelection in 1966 for what will be the first four-year term in that office. Michelson brushes off Kenny O'Donnell and Larry O'Brien as hot prospects for nomination for high elective office. The voters don't know either man well, he holds, and there is doubt among the polls as to how much the two know about state problems. They have been preoccupied since 1960 with sundry duties as aides of the late J.F.K. and, in 1964, the Johnson-Humphrey Presidential campaign.

Los Angeles (IES) -- The authoritative Field Survey rates Sen. Kuchel and George Christopher, ex-Mayor of San Francisco, as the strongest available Republicans for next year's gubernatorial race. Actor Ronald Reagan is ruled out despite his claim to political fame on the strength of a speech last fall denouncing Medicare. So is Los Angeles oilman Joe Shell, one-time Assemblyman. How well the Republicans fare will turn on the outcome of intra-party Democrats squabbling, which is worse than even that of New York State Democrats. Speaker Jesse Unruh's latest clash with Gov. Pat Brown is over the mayoralty race here, in which Unruh is backing incumbent Sam Yorty. Brown is backing Rep. Jimmy Roosevelt. Yorty was a flaming liberal in the House early in the Eisenhower era, but defected to Nixon in 1960, and has been at war with the City Council on most issues. Unruh's last "triumph" over Gov. Brown was in masterminding Pierre Salinger's upset primary win over Alan Cranston, a respected state official, and Salinger's ill-fated contest against winner George Murphy in November. Pat Brown is odds-on favorite to prevail, and to win a third gubernatorial term, if he decides next year to run.

Civil Aeronautics Board (IES) -- Airline officials are feverishly speculating about reports Chairman Alan Boyd will go to the Commerce Department as Undersecretary for Transportation, succeeding C. D. (Dan) Martin, a West Coast Cadillac distributor. Martin's career since the New Frontier began has been a lacklustre one, and a speech in Baltimore a few weeks ago appears to have been a Swan Song: He denounced federal aid for commuter transportation systems, despite the commitment of the Kennedy Administration and L.B.J., who inherited it, to provide Washington cooperation in coping with urban problems, especially those of an interstate character. The move by the New Haven RR's trustees to end passenger services generally, beginning with commuter trains between Westchester County and Manhattan, coincided with Martin's speech. The Senate's contingent from New York, Connecticut and Massachusetts is known to be worried about the New Haven's plight, as are governors in Albany, Hartford and Boston, as well as state legislators in those capitals. Boyd is known to aspire to run for governor of Florida some day, but reportedly turned down a bid to get into administrative office as manager of Dade County (metropolitan Miami).

House Ways and Means Committee (IES) -- Democratic whip Hale Boggs is expected to offer the Administration-backed bill providing for generous tax credits for private U.S. investment in underdeveloped countries. The President referred to such plans in his Foreign Aid message. The tax credits would be applicable to insured investments (against expropriation, nationalization, discriminatory tax treatment, etc.) and would stimulate U.S. exports of capital goods as well as of technical (managerial) services, offsetting the dollar outflow. The substitution of private investment for U.S. grants and development loans under the increasingly unpopular Foreign Aid program would satisfy Congress that a sensible alternative to "giveaways" is now available, and end the annual hassle over authorization and appropriation bills.

Washington is a town full of opinions, few of them any good. The proliferation of columnists has resulted in a torrential flow of garbage, mendacious, unprincipled and cruel. Such is the attack now being made upon the President. He is a very human man, high-minded and responsible. It is time that the great brains of Washington let him alone, to do the job for which he was elected, the job to which he is dedicated.

The television people, to a certain extent, have taken over the impartial characteristics of the press. Television burns up people very quickly, so the telecasters do not emerge as Washington institutions. People like Ed Murrow, who did so much for the radical left, gradually wear out their welcome and are not entertainment after a while. A dull, ponderous man, like Cronkite, who reads mostly straight news, hangs on longer.

But the columnists have multiplied like rabbits in the past few years because newspapers have been too broke to hire their own help, so have bought the product of a lot of prestidigous people. And all of them, swimming around the Federal capital like a school of fish, have a tendency to pick up the war cry of the leaders. It becomes quite a clamor.

Lately the idea has to be "negotiate". No one has come up with whom or why, but just the same the opinions are set forth. One columnist specializes in weaving quite a web to enmesh the President. He points out that Johnson must be irresponsible because he resents unfair criticisms, and therefore he will lose the war in Viet Nam and then the world. If this man ever had his advice taken, Chou En Lai would be presently in the White House.

The sainted Martin Luther King has added beautifully to the President's woes. At the height of Viet Nam, Mr. King contrived a crisis worthy of the Kremlin. It was just like Khrushchev and Berlin. King went to a place called Selma, Alabama, turned children and a mob of hysterical, ignorant people into the streets and got properly locked up. Then when the television had saturated the country with the martyrdom of this holy man, he quickly bailed himself out and announced he was going to see the President for the redress of his wrongs in the sovereign State of Alabama.

He said this with all the pomp of--yes, Khrushchev--and started off for Washington with a roar of engines and 22 retainers. This man has more people to hold his coat than Charlemagne.

This was indeed, one hell of a time to blast his way into the White House, but he did and to blazes with North Viet Nam, South Viet Nam and the rise or fall of the American Republic.

The Passing Parade -- Part 1

It has been said that Lincoln's birthday would hardly be noticed were it not for the politicians who use the event for self-serving oratory. Perhaps the same could be said about St. Patrick's Day and Columbus Day. But the boring speeches of these observances can be tolerated and put down as a necessary exercise of political awareness, but nothing in these black-tie rituals can compare with the blasting enthusiasm of the street parade. Given fair weather and some lilting bands, there is nothing politically like it, even unto the second generation.

Up in the dusty, sharp and corrupt city of Boston, they have three holidays which no one else knows about, and which are political touchstones. The first is Evacuation Day, which coincides with St. Patrick's Day on the 17th of March; the second is the 19th of April, when Paul Revere made his famous ride; and the third is Bunker Hill Day, on the 17th of June. The March parade is held in South Boston and the June parade is in Charlestown, the site of the famous battle. Patriot's Day doesn't have a big city parade, but it is observed in the towns of Lexington and Concord, and also in the running of the annual marathon race.

The local parade is a fine opportunity for aspiring politicians to whet their appetites and sharpen their wits. Regardless of the Alamos, Bunker Hill days and various other local fiestas, the one, standard, all-American observance in every hamlet and town has been Fourth of July. "The Fourth!" was a cry from hill to hill, coast to coast and from the Great Lakes to the Gulf. Every man, woman and child thrilled to anticipation of the day. And the politicians made the most of it.

They marched with the old Grand Army and the United Confederacy, the Sons of the Revolution and the Order of Cincinnati. They turned up in the ranks of the militia or leading it. They rode with the Indian War vets and those of the Spanish struggle. Some played in the community band and some just walked along with a flag over one shoulder and eyes beaming from one side to the other.

Some were featured in the "Horribles", a section of the parade with clown costumes and designed to give the crowd a laugh, especially the future voters.

Fourth of July parades were always held in the morning because of the heat and the fact that everyone was celebrating and might not be able to make it later on. This holiday was one in which the lid was off. One grim New England preacher once proclaimed that alcohol was the Devil's kindling wood except on the Fourth of July. It was the one holiday in which the juveniles could stay out all the "night before".

But the politician had no illusions about HIS duty. He did not stay out. He got up early, pressed and brushed his uniform or best suit, soaked his feet in Epsom salts, rubbed yellow laundry soap on the inside of his socks before he pulled them on, and went out fresh and clean to trudge in the gravel or on the asphalt to the delight of his fans.

A local Mayor or chairman of the Selectmen had quite a day. He got up early and attended to the rituals mentioned above. He took his place in the parade until it reached the reviewing stand. Then he left the line of march and took his place on the stand and reviewed the marchers. Then he partook of refreshments at the firehouse or G.A.R. building. Everyone went home at noon for a feast of boiled salmon, white sauce, green peas, watermelon and home-made ice cream, generally served outdoors under a tree.

Then he went off to the ball park and threw out the first ball. He remained dutifully through the game. If a riot of over-stimulated fans took place he always was able to make his way out of the crowd unseen.

In the evening he went back to the same ball park and led the "Oooos" and "Ahaas" at the fireworks. It was always quite a day. (A continuing feature.....)

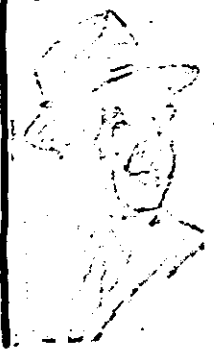

TITLE: THE AMERICANIZATION OF EMILY

COMMENT: This film is the culmination and the antithesis of eighteen years of brilliant propaganda films produced by party writers, directors, and actors in Hollywood.

PSYCHOLOGICAL WARFARE THEME

This film bluntly and blatantly states that patriotism and defense of ones country in wartime is immoral, stupid, and inhumane. It is a classic propaganda film since it hides its true message under a veil of humor, but the scenes showing the horror of war clearly define its meaning. In this film the major star JAMES GARNER delivers a 10 minute eulogy on the stupidity and wastefulness of war and blame the making of wars on the GENERAL STAFF. Thru vivid close pictorial scenes the high ranking officers in the E.T.O. are portrayed as brutal, sadistic, opportunist, drunkards, sex maniacs, and psychopaths.
