Doubleday and Company, 277 Park Avenue, NYC, advised SA THOMAS J. HARRINGTON, JR., that Doubleday has dropped negotiations with WALTER WINCHELL and has no present plans to publish WINCHELL'S book. [REDACTED] stated that his company had done preliminary negotiations with WINCHELL and WINCHELL'S attorney, WILLIAM SIMON of Los Angeles, California, who is a former official with the FBI. According to [REDACTED] before Doubleday would publish WINCHELL'S book his company requested an indemnity from WINCHELL. [REDACTED] stated confidentially that there was a good chance of lawsuits developing as a result of WINCHELL'S book, and his publishing firm wanted to be protected. However, WINCHELL has refused to grant any indemnity to Doubleday. [REDACTED] stated that as far as he knows WINCHELL has not completed his book, and that WINCHELL expects to do the book by recording notes on a tape recorder.

[REDACTED] volunteered that WINCHELL is being sued by Dr. SAM SHEPARD of Ohio, who was recently released from jail after serving ten years for the murder of his wife. According to [REDACTED] word in the publishing field is that Dr. SHEPARD has an excellent suit against WINCHELL.

[REDACTED] also advised that he understands McCall's Magazine is going to publish between two and four articles by WINCHELL.

[REDACTED] stated that, should Doubleday again negotiate

WW: I assume the editors of The Newark Eve'g News know all this, but it just came over the phone from Youknowho (cq)...That many white people in Newark have organized to protect themselves against expected Black Power-mad rioters and their dupes. Mostly, I was told, "some very strong Italians." Not members of The Cosa Nostra. These worried people are many respectable Italians--in the large group... All have weapons (many kinds) to repel any mob that causes trouble, etc...The FBI knows that the Kluxers are on a weapons-buying spree throughout the South. 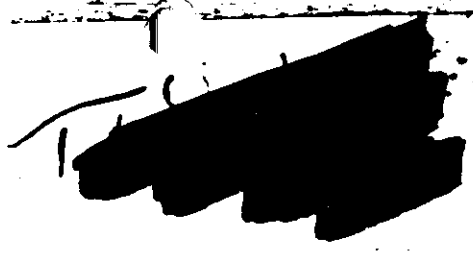

Dear Walter:

Yesterday I wrote you about [redacted] If you use this item I hope you will make it appear that it originated in New York or Tifton, Georgia. It may be that the police chief in Tifton will know who [redacted] is, by his description if not by his name.

Speaking of banking, one of the most successful bank heists of the 20th century occurred about four years ago at the Chase Manhattan Bank in Paris and to my knowledge not a line appeared about it in the U.S. newspapers. I was in France at the time and the French newspapers carried it, but even in France Chase managed to get the story played down. If you have not heard about the heist, here is what happened:

A man representing himself to be a big businessman from Mexico walked into the Paris branch of the Chase Manhattan Bank. He had a bank draft for \$100,000 and he wanted the money in cash. His credentials were excellent and the Paris branch cabled the New York office for confirmation. The New York office cabled back that the credentials were o.k., so the Paris branch gave the man the \$100,000. Within an hour, or so, however, someone at Chase clicked, and the bank called the French police. By that time, though, the man had left the country, and that was that. If you wanted to update the story you might want to call Chase and find out if they ever caught the man. I don't think they have.

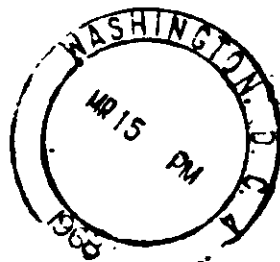

Early this morning Mr. Walter Winchell dropped by my office and spoke to SA Bland. He said he had stopped in the Director's Reception Room to extend his greetings to the Director and Mr. Tolson and was "killing time" until he fulfilled an appointment at The White House at 11 a.m. today. Mr. Winchell said that he had come in early this morning from New York, had an appointment at 11 a.m. at The White House and was going to cover a show tonight, after which he would return to New York City.

Mr. Winchell said that in recent days he had been up at Columbia University covering the student unrest there and in all of the confusion surrounding the removal of students from university buildings by the police he had been hit in the mouth. He said he had not been hurt by this action but understood from a friend of his that some newspaperman had taken a picture of his being struck. He said he doubted whether there would be any publicity attendant to the incident.

Mr. Winchell said that he was feeling well and was continuing to "charge" as a good newspaperman should. He asked that his best wishes and regards be furnished to the Director and Mr. Tolson.

After remaining a short period of time in my office, he advised that he was going to go to The White House press room where he expected to be most of the morning.

Discreet inquiry by the New York office disclosed the following:

The tentative title of the book in question is "THE VOYEUR", a French word which really means "peeping tom". The book will be published by BERNARD GEIS, and will be distributed by Grove Press. They are noted for distribution of many books that deal with pornography and that would be considered by some to be obscene. They are very successful. The book is being written under the pen name of HENRY SUTTON. The name HENRY SUTTON was also used on the recent book that was on the best seller list for a period of time, "THE EXHIBITIONIST", also published by BERNARD GEIS. The man's real name is DAVID SLAVITT. By way of background the source advised that two or three months ago, in ESQUIRE magazine, there was a rather extensive article about DAVID SLAVITT, who has some excellent academic degrees and is considered a very fine poet. He further advised that there have been articles in TIME and LIFE and other magazines about DAVID SLAVITT; that SLAVITT did not want his name to be associated with the book titled "THE EXHIBITIONIST" but did agree to write it; that he prepares his material by taping it, which is then transcribed, then the editor, DON PRESTON, goes over it and after DON PRESTON has reviewed it, then DAVID SLAVITT starts to work over the manuscript again and they come up with a book. The source further advised that the book, "THE VOYEUR" does not mention names but the people can easily be identified by references to them. He cited as an example, "well known publisher of girlie magazine", which automatically would be HUGH HEFFNER. The source indicated that references clearly point to the person intended and where they say that "the head of the FBI", name not mentioned, is a "fag", naturally since there has only been one head of the FBI for the last 30 years or more, a mistake cannot be made. The source volunteered to make available the copy of ESQUIRE referred to with background material on SLAVITT.

He believes they reside in the Navarre Apartments, Central Park South, New York City. He stated that JACQUELINE SUSANNE and her husband are wrangling with the publisher of "VALLEY OF THE DOLLS". The matter has been taken into court because SUSANNE and MANSFIELD claim they are not receiving all the royalties derived from the book. Two days ago, WINCHELL stated, he met MANSFIELD on the street in New York and asked him how his law suit was coming. MANSFIELD stated it was progressing satisfactorily.

During this conversation, MANSFIELD mentioned that he had heard some revolting news concerning a very good friend of WINCHELL. He said that BERNARD GEIS is publishing a book in which he will name J. EDGAR HOOVER as a homosexual. WINCHELL was not able to furnish any further details as to the author of the book. He suggested that we might want to contact IRVING MANSFIELD for further information.

WASHINGTON—A secret electronics espionage laboratory allegedly located in offices formerly occupied by an assistant deputy Secretary of State (for security) carried out systematic eavesdropping on State Department executives and many newspaper people.

room since the allegations appeared in a reliable publication for federal employees called "The Exchange."

The "buggings" reportedly took place during John F. Kennedy's one thousand days in the White House and the early administration of Lyndon Johnson, according to a former electronics

specialist hired by the Central Intelligence Agency.

The decision to institute the electronic keyhole-peeking at the State Department was taken at the White House following a series of news leaks to James Reston of "The New York Times" and Chalmers Roberts of the "Washington Post." President Kennedy was especially irritated, he stated, because one of his own "planted leaks" to Reston was disguised by the editors of "The Times" as originating in Europe via a foreign capital dateline.

Besides State Department officials, others whose conversations were tapped and made into "voice profiles" (since 1963) numbered about 85 newspaper men and women.

Among these were John Hightower and Andre Marton of the "Associated Press," Richard Eder, John Finney and others staffers of "The New York Times," Mary McGroory of the "Washington Star" and Rowland Evans and Robert Novack, columnists of the "New York Herald Tribune."

\$1 Million Gift Reveals J.E. Hoover Foundation

By WALTER WINCHELL

The John Edgar Hoover Foundation, the existence of which has never before been made public, is the recipient of a New Yorker's \$1 million in securities. He does not want his name publicized. The foundation's president and guiding light is Lou Nichols—with the FBI 24 years until retirement. He was assistant to the director.

Before the million-dollar gift was pledged, the foundation (created about two years ago) received almost \$200,000 from admirers of the FBI and its Chief. All donors contributed voluntarily. The new foundation was created to perpetuate the ideals to which Hoover has dedicated his life.

"It is educational in concept. It will combat Communism and related subjects and promote Americanism," Nichols told this reporter. "It is," he added, "a Washington, D.C., corporation with offices in the Capital and New York City."

FBI: U.S. Faces College Anarchy

By CARL T. ROWAN

WASHINGTON—A couple of weeks ago, 23-year-old Cathy Wilkerson stood on the campus of American University here, fanning the fires of student rebellion.

Miss Wilkerson was only one of several Students for a Democratic Society (SDS) non-students who were encouraging or abetting campus revolts in May. At least partly because of the zeal of these young revolutionaries, two great spasms of violence had rocked Columbia University, resulting in 897 arrests and injuries to 216 persons.

What does it all add up to? Is it just a new "campus fad," or is it a development that merits the attention of those concerned with national security?

Some key people in the Justice Department are convinced that Columbia is only an early target in a national plan by student revolutionaries to either seize control of dozens of universities or wreck them.

FBI and other reports indicate that even as violence raged at Columbia some of the ringleaders were fanning out around the country trying to intensify conflicts on other campuses.

These reports also show that many of those doing the most haranguing on campuses are not students at all but well-organized outsiders exploiting campus grievances to further their goal of "changing American society."

One Justice Department report says that "trained

agitators and subversive elements represent a hard core whose basic objective is to promote outright anarchy. There is growing evidence that this hard core is composed of many non-students. There is growing evidence, too, that there is a

Who Wrote It?

King's Last Talk: A Murder Clue?

By PAUL SCOTT

WASHINGTON—The Federal Bureau of Investigation's massive probe of the assassination of Dr. Martin Luther King is taking a possibly sensational turn.

With James Earl Ray, the suspected assassin, apparently either outside the U.S. or now dead, FBI agents have increased their surveillance of several American Communists known to have been closely associated

with King, including one who wrote speeches for him in the past.

This new development was triggered by evidence gathered by the more than 1,000 agents who have worked on the mysterious King shooting and by several "tips" and letters sent to the FBI.

One of the most interesting of these "tips" came from an

When a reporter (who forgot to pin his press pass on his lapel) was asked to produce credentials, another scribe cracked, "They trust everybody but the press!"

Greece: Two High Clerics In Sex Trial

By GEORGE ANDREWS

ATHENS — Two high dignitaries of the Greek Orthodox Church will be brought to trial before the Greek Ecclesiastical Court on charges of homosexuality.

The Archbishop of Greece, Msgr. Ieronymos, said they are the former Archbishop of Greece, 72-year-old Iakovos, and the present Metropolitan of Salonika, 65-year-old Pandeileimon, who has been under house arrest since Jan. 1.

The Archbishop's announcement did not name the charges. But both defendants were sharply attacked in the remote and recent past — openly by Greek lay and religious newspapers, for homosexuality.

The present Archbishop Ieronymos, who flew to Rome late last month as mediator between King Constantine and the government, yesterday set up a five-member ecclesiastical court to try the two cases.

The decision seemed to be the first step of the synod to carry out a moral purge of the Greek clergy.

According to reliable sources, several more Metropolitans will be asked to appear before the court to answer similar charges.

Their exact number is not known, but state and church authorities are believed to be in possession of evidence sufficient to justify their being sent to trial on homosexual charges.

Reds Wave Flag of Arrogance

The Communist Party convention currently being held in New York City to nominate candidates for president and vice president is arrogance to the ultimate degree.

Timing of the convention to coincide with the most patriotic holiday in the United States of America — the anniversary of the Declaration of Independence — is outright sneering at the nation's ideals and heritage.

And the first order of business for the convention was to announce boldly that it is fanning the flames of exhibitionism, rioting and civil insurrection in the United States. This is tantamount to an open admission of subversion.

The arrogance and audacity are not surprising.

There was a time when the United States had the menace of communism in better perspective. The Communist Party of the United States has not held a presidential nominating convention since 1949.

Its present boldness stems directly from 1953 Supreme Court decisions which invalidated much of the 1950 Subversive Activities Control Act.

Since then the Communist Party has openly infiltrated religion, education and defense plants. It has overtly opened a checking account in a New York bank. Plans are imminent to make the Communist publication, "The Worker," a daily newspaper.

None of the party's boldness was visible in 1966 when Dorothy Healey polled 53,000 votes running for tax assessor in Los Angeles County. That same year Herbert Aptheker, party theoretician, ran openly for Congress in Brooklyn. Ben Debbs, a California Communist, is seeking office this year.

Now the party is again flaunting its arrogance by the national "open" convention that will select candidates from among Gus Hall, national secretary; Henry Winston, national chair-

man; Claude Lightfoot, Illinois party chairman, or Aptheker.

The motive is, of course, pure propaganda. Hall and his ilk have no hope of capturing the White House this year through legitimate political means.

So the Communist convention is a continuing attempt of the party to gain the image of respectability and legitimacy. This will help Communists in the United States to sow the seeds of anarchy, dissent, violence and rebellion wherever they find fertile ground.

The people of the United States had better tune in to the meaning of the Communist meeting in New York. It is telling us that the danger and menace of the movement is increasing despite the relatively few members of the party in proportion to population. The history of communism is that it always has come to power through minority movements.

And the Communist Party's flaunting admission that it is seeking to tear apart law and order in the United States is a vindication for J. Edgar Hoover, director of the Federal Bureau of Investigation.

Mr. Hoover, despite his outspoken critics, was right in insisting that the insurrection in the United States was instigated or accelerated by the Communists on an organized basis.

Perhaps now this obvious fact will help people assess the integrity and value of Mr. Hoover's careful opinions and better assess the credibility of public figures in the future.

Strengthening of national laws to stamp out subversion — along the lines of the 1950 act — is mandatory. Thirty-seven states have laws barring Communists from the ballot, yet the party circumvents this roadblock. A national law is a must. And the people of the United States must beware of the danger of internal Communists and support Congressional controls.

This is what the Communist convention in New York should be telling us.

THE unity of the human race, as envisaged by Bahá'u'lláh, implies the establishment of a world commonwealth in which all nations, races, creeds and classes are closely and permanently united, and in which the autonomy of its state members and the personal freedom and initiative of the individuals that compose them are definitely and completely safeguarded. This commonwealth must, as far as we can visualize it, consist of a world legislature, whose members will, as the trustees of the whole of mankind, ultimately control the entire resources of all the component nations, and will enact such laws as shall be required to regulate the life, satisfy the needs and adjust the relationships of all races and peoples. A world executive, backed by an international Force, will carry out the decisions arrived at, and apply the laws enacted by, this world legislature, and will safeguard the organic unity of the whole commonwealth. A world tribunal will adjudicate and deliver its compulsory and final verdict in all and any disputes that may arise between the various elements constituting this universal system. A mechanism of world inter-communication will be devised, embracing the whole planet, freed from national hindrances and restrictions, and functioning with marvelous swiftness and perfect regularity. A world metropolis will act as the nerve center of a world civilization, the focus towards which the unifying forces of life will converge and from which its energizing influences will radiate. A world language will either be invented or chosen from among the existing languages and will be taught in the schools of all the federated nations as an auxiliary to their mother tongue. A world script, a world literature, a uniform and universal system of currency, of weights and measures, will simplify and facilitate intercourse and understanding among the nations and races of mankind. In such a world society, science and religion, the two most potent forces in human life, will be reconciled, will cooperate, and will harmoniously develop. The press will, under such a system, while giving full scope to the expression of the

diversified views and convictions of mankind, cease to be mischievously manipulated by vested interests, whether private or public, and will be liberated from the influence of contending governments and peoples. The economic resources of the world will be organized, its sources of raw materials will be tapped and fully utilized, its markets will be coordinated and developed, and the distribution of its products will be equitably regulated.

National rivalries, hatreds, and intrigues will cease, and racial animosity and prejudice will be replaced by racial amity, understanding and cooperation. The causes of religious strife will be permanently removed, economic barriers and restrictions will be completely abolished, and the inordinate distinction between classes will be obliterated. Destitution on the one hand, and gross accumulation of ownership on the other, will disappear. The enormous energy dissipated and wasted on war, whether economic or political, will be consecrated to such ends as will extend the range of human inventions and technical development, to the increase of the productivity of mankind, to the extermination of disease, to the extension of scientific research, to the raising of the standard of physical health, to the sharpening and refinement of the human brain, to the exploitation of the unused and unsuspected resources of the planet, to the prolongation of human life, and to the furtherance of any other agency that can stimulate the intellectual, the moral, and spiritual life of the entire human race.

A world federal system, ruling the whole earth and exercising unchallengeable authority over its unimaginably vast resources, blending and embodying the ideals of both the East and the West, liberated from the curse of war and its miseries, and bent on the exploitation of all the available sources of energy on the surface of the planet, a system in which Force is made the servant of Justice, whose life is sustained by its universal recognition of one God and by its allegiance to one common Revelation—such is the goal towards which humanity, impelled by the unifying forces of life, is moving.

Reference is made to the attached newspaper column by Walter Winchell which appeared in The New York Daily Column of September 12, 1968. The Director asked if we knew the identity of three individuals referred to by Winchell in the column who were among the protesters in Chicago, one of whom allegedly has an extensive criminal record, the second of whom was a "hophead," and the third a homosexual.

We went through all the information reported to us by the Chicago Office concerning individuals active at the Democratic National Convention in Chicago and could not identify the three individuals on the basis of information available to us.

I called our Chicago Office and instructed them to check their files and also to check with the Intelligence Unit of the Chicago Police Department. There were a number of individuals among the thousands of demonstrators with previous criminal records and there were also a number known to have used dope and to have engaged in homosexual activities, but neither the Police Department nor the Chicago Office could specifically identify the individuals to whom Winchell made reference.

The only way we could specifically pin this down would be to interview Winchell, and in view of his known penchant for using half truths and innuendos to develop sensationalism in his stories, it is believed that direct contact with Winchell would be undesirable.

ACTION: None. Unless the Director desires, we will not contact Winchell to resolve this.

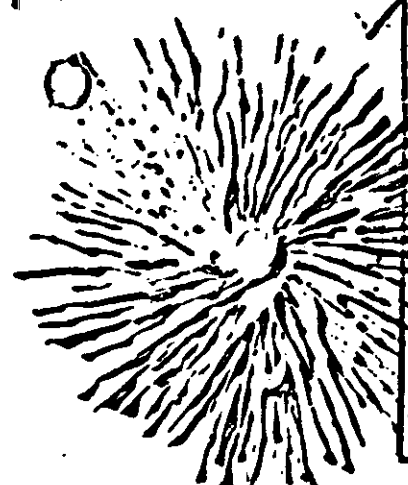

Reference is made to my memorandum of December 7, 1970, regarding plans for publication of the new New York City paper, "The New York Daily Mirror."

The New York Office has advised that the backers for this paper are shooting for an initial publication date of December 21, 1970; however, there is still a great deal of uncertainty as to whether this date can be met.

The New York Office advised a flyer put out last month lists a proposed list of columnists who were scheduled to appear in "The New York Daily Mirror"; however, Mr. Winchell's name was not included.

It has been ascertained that Robert W. Farrell, former publisher of the defunct "Brooklyn Eagle," is heading the new venture. Bufiles contain no derogatory information concerning Farrell and reflect limited correspondence with him. It has also been learned that this group is proposing to hold a press conference shortly in New York furnishing additional details regarding plans for the Mirror.

RECOMMENDATION:

My office will continue to follow with our New York Office regarding plans for this new proposed venture and will have items of possible interest available for Mr. Winchell once the paper gets underway.

SYNOPSIS:

Thomas' book is an apparently slightly fictionized, although highly readable, treatment of the life and times of former newspaperman Walter Winchell. The book is replete with references both to the Director and the Bureau, few of which are complimentary but most of which are neutral. Thomas, who apparently is not above dealing fast and loose with the truth, alleges the basis of the friendship between the Director and Winchell was that Winchell deplored the fact that FBI Agents risked their lives for minor pay and no pension during the 1930's and that he brought this to the public's attention. As a result, Congress took notice of Winchell's statements and boosted the Bureau's appropriation as well as expanding its jurisdiction. The Director was therefore grateful to Winchell.

Another example of Thomas' lack of proximity with the facts is his capsulized version of the capture of Louis Lepke Buchalter. The facts relating to Lepke's surrender are essentially correct which occurred on August 24, 1939. The author claims, however, that when Winchell called his newspaper, "The Mirror," with the biggest scoop of his career, Winchell's editor said "That's a good story, Walter -- but Hitler just invaded Poland." The fact of the matter is, Poland was invaded by Nazi forces, of course, on September 1, 1939.

The author states that the only persons immune from attack by Winchell in his column were former President Franklin Roosevelt and the Director. He also states that Winchell's friendship with the Director was unquestioning and one of the rare cases of hero worship on Winchell's part.

DETAILS:

The following are specific references both to the Director and the Bureau.

On page 91, the author alleged the basis of the friendship between the Director and Walter Winchell was that Winchell deplored the fact FBI Agents, in the 1930's, risked their lives for minor pay and no pension, and that widows of slain Agents were given scant compensation. As a result of Winchell's activity, Congress took notice and boosted the FBI's appropriation as well as its area of jurisdiction. The Director was therefore grateful to Winchell and he and Winchell formed an enduring friendship. The author then proceeds to describe a fictionalized incident which allegedly occurred in 1934 in Chicago, which cannot be substantiated because the only person named is Winchell, Thomas alleges that when Winchell arrived in Chicago in 1934, he was met by two Agents who advised him that Mr. Hoover had assigned them to protect him while he was in Chicago. Winchell was then also confronted by two additional men who were with the Chicago Police Department, and after being advised by Winchell that he was already accompanied by two FBI Agents, the Chicago policemen replied "Those fairies? What can they do for you?" The author then states two additional men who were cousins of Al Capone, also joined Winchell to protect him. Upon the completion of Winchell's engagement, a party was given for Winchell and his bodyguards from the FBI, the Chicago police, and Al Capone's cousins. When the party ended, one of the Agents, according to the author, told Capone's cousin "Some day I'm going to shoot you down."

The next pertinent reference to the Director is found on page 108, where Thomas says Winchell bought a \$700 Ford in the 1930's because J. Edgar Hoover had told him that Dillinger used that type of car because it had the most pickup.

On page 114, the old canard concerning a New Year's Eve party in 1936 at the Stork Club is related again. This relates to one Terry Reilly, who was described by the author as a notorious gangland murderer who was on parole for extortion and impersonating an FBI Agent, being asked to pose holding a toy machine gun on the Director. Reilly refused to pose for the picture and left.

The author states on page 116, that "no public figure, with the exception of Franklin D. Roosevelt and John Edgar Hoover, was exempt from criticism in the Winchell column."

On page 121, the author states that the Director served as a peacemaker between Winchell and one of his friends, Louis Sobol, whom Winchell was angry at for an alleged slight.

Pages 151 through 153 relate Winchell's activities pertaining to the capture of Louis Lepke Buchalter in 1939. He relates the meeting of Lepke and the Director in New York but then alleges that when Winchell reported the story to his newspaper as the biggest scoop of his career, his editor stated "That's a good story, Walter -- but Hitler just invaded Poland." The author is apparently unaware of the fact Hitler invaded Poland September 1, 1939, and not August 24 or 25, 1939.

On page 194, Thomas states Winchell and the Director were together on December 10, 1946, when they learned of the death of Damon Runyon. He states the Director ultimately suggested something could be done to help other victims of cancer. As a result, the Damon Runyon Memorial Fund for Cancer Research was formed, which by 1970, had resulted in more than 32 million dollars being disbursed to cancer research throughout the world.

The reference on page 201 states that Winchell's friendship with the Director was unquestioning and one of the rare cases of hero worship on the part of Winchell.

On page 213, the author states that on Winchell's visits to Florida and elsewhere, J. Edgar Hoover provided a bodyguard and the fact that the FBI could protect him was the major reason why Winchell never traveled abroad. Thomas again either ignores or is unaware of the fact that Winchell traveled to Africa.

On page 228, the author, in considering the relationship between former Senator Joseph McCarthy and Walter Winchell, claims that one of the charges against McCarthy was that he permitted a secret FBI document "to fall into the hands of a gossip columnist." When Winchell was called to Washington to testify, he told the chairman of the committee which was called to investigate charges leveled at Senator McCarthy that he, Winchell, did not recall who gave him the document--and he would not tell if he knew. He added that J. Edgar Hoover advised him he would be jailed if he made the information public, so Winchell burned the papers and flushed them down the toilet of his Washington hotel room.

On page 230, Thomas alleges that shortly after the broadcast by Winchell wherein he mentioned that the number-one star of television was a communist, a conversation ensued between Desi Arnaz and Lucille Ball in which Miss Ball asked her husband why he was so calm about the allegations concerning her. According to the author, Arnaz replied that he had known about it for two weeks because J. Edgar Hoover told him about it at the racetrack and advised Arnaz there was nothing he could do about it.

The last reference to the Director or the Bureau is found on page 245, pertaining to a broadcast by Winchell wherein he listed other famous Americans who did not vote and he stated John Edgar Hoover couldn't vote for President because he lives in the District of Columbia.

A BOOK FOR TODAY

The Man They All Read With One Hand

WINCHELL. By Bob Thomas. Doubleday. 233 pages. \$7.95.

He was a sixth-grade dropout who came into the newspaper business through the back door, armed with a dictionary given him by his Aunt Beatrice.

The first daily paper Walter Winchell joined was a journalistic travesty called the New York Evening Graphic, published by Bernarr Macfadden, millionaire physical culture and diet crank.

The flip, breezy, often-scandalous Winchell column on the Broadway scene quickly captivated the public. It was credited with being responsible for about one-third of the Graphic's peak 300,000 circulation.

Bob Thomas has written a candid appraisal of an unusual personality, a writer and broadcaster who became one of the most influential voices in the nation, yet vitiated his success by his careless disregard for truth and his massive egotism which often led him into malice and vindictiveness.

Subway riders who moved their lips as they read were fascinated by accounts in Winchell's imaginative lingo about moon pitchers, blessed events, who was Cupidizing, who middle-aisled it, who was getting storked, who was Reno-vating, as well as further gossip about Merry Magdalens, messers of ceremonies, starlets' romances and the lights and shadows of life around Harp Times

The crisp tone of the column appealed to intellectuals, also. "Winchell wrote like a man honking in a traffic jam," said Ben Hecht.

Alexander Woolcott applauded the newcomer for injecting zest into an otherwise solemn newspaper atmosphere, and introduced him to members of the Algonquin Roundtable, the wits and wisemen of the New York literary and theatrical scene.

Hundreds of papers throughout the country carried "Your Broadway and Mine" and Winchell's reknown increased proportionately. His word of praise assured the success of a new musical comedy, a popular song or an obscure nightclub act. Press agents struggled to get a line about their clients in the column.

Winchell moved his column to Hearst's Daily Mirror and added a radio program delivered in staccato tones which fascinated millions. At the peak of his fame the columnist told jokes to President Franklin D. Roosevelt and received exclusive stories in return. He arranged for the surrender of gangster Louis Buchalter, to FBI Director J. Edgar Hoover and publicized the Stork Club until it became nationally known.

I don't know who Thomas is but he is a scavenger as I know Winchell as well as any other living person. NJ

But despite his popularity and influence, many readers regarded his material as tasteless. Moreover, Broadway's No. 1 celebrity would not follow the customary newspaper routine of checking out the accuracy of the flood of stories, tips and gossip which poured in on him.

The New Yorker magazine analyzed the column during a given period and found that out of 239 items, 106 were unverifiable; 53 were completely accurate; 24 were partially inaccurate and 54 were totally inaccurate. The columnist's accuracy rate during the period was 40.5 percent.

Bob Thomas also notes that because of Winchell's aversion toward research, sometimes his entire column would be written by a press agent.

Despite his loyalty to FDR, Winchell bitterly attacked President Truman, Adlai Stevenson and Defense Secretary James V. Forrestal, thus antagonizing a substantial segment of his readers. He also supported the anti-Communist drive of Sen. Joe McCarthy. Winchell had so many feuds and lawsuits going with so many persons individually and collectively that his influence began to dwindle.

Many of his devotees were irritated, also, that the brassy Broadway bugler would comment dogmatically on world affairs, about which he knew next to nothing. Shysters took advantage of his ignorance to plant stories designed to injure political or business rivals.

The public mood changed, but Winchell didn't. The Graphic and the Mirror died and television became the pre-eminent entertainment medium. A new generation wasn't turned on by this graying character who never removed his hat on TV. As the columnist's long downhill slide gathered momentum, he was airing tips on horse races and the stock market in his Sunday night broadcasts.

At his apogee Winchell was the super-charged chronicler of an era that crackled with drama and excitement. But in his later years he was only a fringe attraction, aging and beset by my family troubles. Along the new Broadway there was no place for the excitable performer who said.

"I want to be like a newsboy hollering 'Extra!'"
