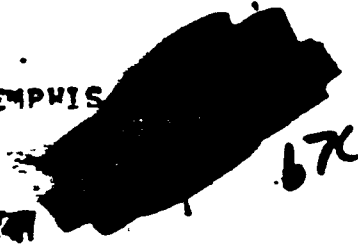

REQUEST OF THE BUREAU

1. FBI Identification Division, Latent Fingerprint Section, is requested to process enclosed nine sheets of paper for any latent fingerprints and compare any obtained therefrom with fingerprints of record for FREDERICK P. PRO, white, male, born August 3, 1926, FBI Number [REDACTED]. If latents of PRO are developed, Identification Division is further requested to prepare a clear plastic overlay which can be used on top of the examined material to show graphically how the hand was placed in holding the paper. Latents, should they be PRO's, should be so placed on the paper as though PRO were holding the paper in position while writing. Memphis advised in 12/9/77 airtel to Miami, referenced above, that this technique is being used most effectively in ITSP prosecutions at Memphis. b7C

2. FBI Identification Division, Handwriting Section, is also requested to determine if the handwriting appearing on the nine sheets of paper is identical to any of records for that of FREDERICK P. PRO.

The Laboratory should be advised that trial date in this matter is tentatively scheduled for sometime in March.
