The above-mentioned called yesterday and stated that he was doing research with regard to the background of his family and wondered whether it would be possible to furnish him from our Identification Division records the names of all people named Tiboni represented in the records together with their dates of birth and the names of their parents. Father Tiboni stated that his family came from Italy originally and that he had had difficulty identifying many people by the same name in the United States.

I advised Father Tiboni that, as much as we would like to be of assistance to him, it was just not possible to take people from their regular work to perform a non-law enforcement function such as he had in mind. Father Tiboni stated he understood but was just curious as to whether our fingerprint records could assist him in his research.

b7c-1 On 6/7/71 at approximately 1:45 a.m. [REDACTED] who resides at [REDACTED] Alton, Illinois, telephone [REDACTED] advised Extra Duty Supervisor Elroy Anthony that he was attempting to contact Agent Harrington of the Springfield Division with whom [REDACTED] had previously discussed two or three threatening telephone calls made to him.

b7c-1 Upon inquiry, [REDACTED] assured that the Alton Police Department was aware of these calls since the threats were against his life. Further, he was merely seeking the Bureau's assistance in notifying Agent Harrington since he did not know how to do so at this late hour.

b7c-1 [REDACTED] was assured that the information would be channeled to the Springfield Division and that an Agent would contact him concerning his complaint. [REDACTED] expressed his gratitude.

b7c-1 Inasmuch as [REDACTED] asked for an Agent by name, the Springfield Division was so apprised telephonically and instructed to promptly interview [REDACTED] for any violation within Bureau's jurisdiction.

On 5-29-71 at 10:30 p.m. Mr. **[REDACTED]** Danville, California 94526, telephonically spoke with Extra Duty Agent Lawrence Sarhatt, Special Investigative Division, concerning the lack of FBI investigation in locating the source of persons killing the Bald Eagles in Colorado. He stated that the FBI could tap his phone easily enough but could not find out who was killing the eagles.

SA Sarhatt advised **[REDACTED]** that primary jurisdiction in this matter is with the Fish and Wildlife Service of the Department of Interior. He stated he didn't care who had jurisdiction and wanted action.

Mr. **[REDACTED]** did not have any information which would assist in investigating the death of these eagles. He also asked whether his conversation was being recorded. He was advised that it was not. Mr. **[REDACTED]** again indicated that he thought his phone was tapped. He was told to contact his phone company with any such complaints if he had reason to believe that his phone was tapped.

Mr. **[REDACTED]** then demanded that his conversation with SA Sarhatt be confirmed by letter to him. He was advised that this request would be noted. He then stated that if he didn't receive a letter by Wednesday 6-2-71 he would take it to higher authorities.

**[REDACTED]** appeared to have been worked up over the death of the Bald eagles after reading accounts in the newspaper that he had mentioned during the course of conversation.

He professed that his wife has been receiving anonymous telephone calls since June 9, 1971, wherein the caller allegedly demanded \$10,000 or the complainant's 23-month-old daughter, [REDACTED] also known as, [REDACTED] would be kidnaped. The complainant's wife is a fan of singer [REDACTED] and has named the infant daughter after her. No one in the household other than the wife has received anonymous calls. No demand notes have been received. He called to obtain FBI body-guard assistance.

*b7c-1* [REDACTED] was advised of the FBI's jurisdiction under the Kidnap Statute and was referred to the Bordentown Police Department.

*b7c-1* [REDACTED] who is an automobile mechanic, professed not to know the identity of the alleged caller. When queried, he did admit that he had had arguments with people in the community but has had no "hard words."

At 3:05 a.m. on 6/16/71 the captioned individual, who said he was calling from the Holiday Inn Motel, Coos Bay, Oregon, telephonically contacted the Bureau and spoke to SA Orvis J. Auerswald, on duty in the Special Investigative Division.

The caller stated he is from Las Vegas, Nevada; however, when asked for his address he appeared confused and said he had forgotten it. He advised he has been married for six weeks to the former Joanne Wooten, who had six children, ranging in age from one to eight years, during a previous marriage. He said he and his wife separated shortly after their marriage, and his wife took three of her children with her to Spokane, Washington, while he, Mr. Parker, took the other three to Las Vegas, Nevada. Mr. Parker stated his wife called him several days ago requesting money, and he arranged to meet her in Coos Bay, Oregon. He advised that approximately three hours prior to his call to the Bureau his wife, accompanied by police officers, came to the motel. He said the officers took the three children from his motel room and turned them over to his wife, who then departed. Mr. Parker stated he was not told why the children were being taken. He advised he was calling to find out what could be done to have them returned to him. At one point in his call he said he is the father of one of the children born to his wife during her prior marriage.

Mr. Parker was advised this is not a matter within the Bureau's investigative jurisdiction. It was suggested he might desire to consult an attorney.

No information identifiable with the caller or his wife was found in Bureau files based on available information concerning them.

At 8:55 p.m. 6/16/71 Bureau operator contacted night supervisor SA William M. Gallagher on duty in the Special Investigative Division and advised that a Mr. Kyle was on the line from New Orleans, Louisiana, and wanted to speak with "someone in authority around there." Kyle sarcastically asked Bureau operator what "FBI" stood for. SA Gallagher took the call and identified himself to Mr. Kyle who responded, "What is your name again and where do you work there?" Kyle was appropriately informed. Kyle refused to further identify himself other than his last name, saying, "that's all you need to know."

Kyle then said he wanted the telephone number of the warden of "the correction institution at Danbury, Connecticut," to tell him about the death of an inmate's relative. Kyle was advised that we did not have this information available and it was suggested that he contact the Justice Department switchboard, area code 202-737-8200, if he was referring to the Federal penitentiary there; or to contact the telephone company if the institution he wanted was state controlled. Kyle then stated he was a taxpayer and insisted that the FBI had this information and should make it available to him since he was paying the salaries of Mr. Hoover and all FBI Agents who are "really servants of the public."

Kyle's comments were derogatory concerning the work of the Director and the Bureau. He was obnoxious, overbearing, and insulting, and SA Gallagher terminated the conversation.

New Orleans office advised no record of any chronic complainant with last name of Kyle, and there was no such record in the box of chronic complainant cards maintained in the Special Investigative Division. In the absence of any further identifying data Bureau indices could not be checked.

He further indicated that he is 46 years of age and was contacted in 1942 for recruitment into the FBI. Mr. [REDACTED] stated that he now wishes he would have pursued the matter.

On June 21, 1971, a highly emotional individual identifying herself as Mrs. Bogart (phonetic), telephonically contacted Coding Clerk Donald A. Flynn, Crime Records Division, and stated that she had seen the picture of Agent Flynn in Sunday's newspaper and that had prompted her telephone call.

The caller apparently was making reference to the photograph of former Special Agent William Flynn, now Athletic Director at Boston College, which appeared in the Washinton Post on June 20, 1971, in connection with an article by Jack Anderson on the subject of former Special Agents. Coding Clerk Flynn has not had his picture in the newspapers.

B. APPROX. 1976

Mrs. Bogart described herself as white, Jewish, forty-five years of age, blonde hair, who resides in Laurel, Maryland, and is employed as a [redacted] at the Laurel store of the [redacted]. Flynn attempted to explain that he was not Special Agent Flynn, however, she persisted in outlining her complaint. She stated that three hoodlums with whom Special Agent Flynn had contact, had been responsible for ruining her reputation, with the result that she had been raped, spent ten days in jail, and had her money stolen while in jail. She stated that she had written to fifty Senators and President Johnson in an attempt to gain an appointment with the Director for the purpose of having Mr. Hoover clear her name, but to date had been unsuccessful in seeing him.

At 5:32 a.m., Mr. Donovan was contacted and furnished the above information from FAA. Mr. Donovan requested recontact of FAA to determine if any plane crashes involving an adult and three children, in the entire country.

At 5:37 a.m. Mr. Slater, FAA advised that there were three plane crashes in the past 48 hours. One involved the death of several persons on a chartered flight at Eureka, California, a private plane crash at Lake Tahoe killing two and a military plane mishap.

This will record that at 8:58 p.m., 11/13/71, Mr. [REDACTED] telephonically contacted Extra Duty Supervisor C. A. Nuzum. [REDACTED] advised he is a retired Air Force sergeant; and he is constantly being arrested by the police at Prattville, Alabama, for "no reason." He said he works for Daniel Construction Company, Greenville, South Carolina, and on weekends comes home. He said that the police were harassing him and kept telling him he should go home from various taverns in the area. He claimed he never drank to excess. He felt the FBI should instruct the Prattville police to leave him alone. Mr. [REDACTED] was tactfully advised that his complaint appeared not to relate to a matter within the jurisdiction of the FBI, and he expressed appreciation for being listened to and hung up. Bureau files indicate that Mr. [REDACTED] in September, 1968, called the Bureau in another personal situation (Bures 9-0-14838 and 9-0-14991). The Columbia Office determined that according to the Greenville County, South Carolina, Sheriff's Office, [REDACTED] is an alcoholic who gets drunk frequently and, when in a drunken state, makes telephone calls to numerous persons in which he makes false claims and ridiculous allegations. The Sheriff's Office advised that he is completely unreliable and that members of his own family pay no attention to his statements.

At 10:10 p. m., 11/21/71, Extra-duty supervisor, E. J. McDonough, received long distance telephone call from Mrs. [redacted] Pasadena, California. Mrs. [redacted] who exhibited a demanding hysterical attitude, went into a long tirade as to the activities of her neighbors in running their mini-bikes up and down the street and otherwise harassing her. She stated she had contacted the police and although she had no faith in the local police, they had answered her previous complaints but she didn't think they acted strongly against the neighbors.

She wanted the FBI to come out to her house and afford her protection and the Los Angeles Office said they could not afford protection. She was advised by SA McDonough that the FBI could not afford her protection and if she desired, she could contact state law enforcement authorities. She then launched into a profane diatribe against all law enforcement including the FBI and the conversation was terminated.

Miss Suzanne Avels, Bureau switchboard operator, received a call from a commercial operator at 2:18 p.m. asking if a collect call would be received from a Mrs. Colby (phonetic), no city named. Miss Avels refused to accept this call in accordance with existing policy at which time the caller was overheard to angrily state, "Give Mr. Hoover this message. If I don't get satisfaction in Texas, there will be nothing left of his office in Washington..." At this point the commercial operator terminated the call and Miss Avels was unable to recontact the commercial operator in order to determine more facts about the caller. Miss Avels advised the entire incident transpired within a minute and she was not certain she could recall the commercial operator in order to identify both the operator or the caller.

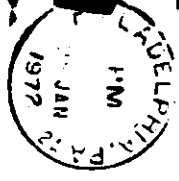

The apartment was the epitome of squalor itself in that papers, clothing, as well as large accumulations of trash and rubbish were thrown at random throughout the residence. Cockroaches were clearly visible during the entire interview as were a cat and dog who roamed at will over food, furniture and occupants.

As soon as introductions were completed, Mrs. [redacted] became emotional and began rambling incoherently. After extreme difficulty, agents determined that approximately two weeks ago she had written a letter to the Attorney General of the United States requesting information as to how she could register a complaint against FBI employees. When she did not receive an answer she wrote a letter to J. EDGAR HOOVER in which she claims to have outlined specifically detailed incidents of misconduct on the part of two agents, SA [redacted] and SA [redacted] as well as an unidentified blonde lady.

While it was impossible to be certain what Mrs. [redacted] desired to convey or may have detailed in her letter, it appears she alleges that in 1967 while residing in New York she was operating a boarding house. At that time an unemployment compensation check was stolen from a boarder. The boarder wrote a letter to the FBI concerning Mrs. [redacted]. It is noted that Mrs. [redacted] declined to furnish information concerning the boarder or the residence at which she ran the boarding home.

Subsequent to the above mentioned incident, unidentified persons in the neighborhood told her FBI agents [redacted] and [redacted] as well as an unnamed blonde lady had installed a television camera to watch all of her activities and were paying an unidentified neighbor \$80.00 to \$90.00 per month for his assistance.

b7c-1 At the same time unidentified persons began mailing her letters on stolen official letterhead stationery from an unrecalled Government agency. This resulted in her loosing her home. Mrs. [redacted] then travelled to the "West Indies" where she was followed by FBI agent [redacted] and the blonde girl who Mrs. [redacted] had never seen before.

b7c-1 Upon Mrs. [redacted] return from the West Indies, she had a conversation with her mother and then came to Philadelphia. Upon arriving in Philadelphia a woman she had never seen before told her exactly what she and her mother had discussed.

b7c-1 Mrs. [redacted] further advised after moving to Philadelphia she received several calls from [redacted] who she believed to be SA [redacted]. However, she did not recall what was said in these conversations.

b7c-1 Mrs. [redacted] also indicated she had seen several television shows in which people claimed the FBI bugged private person's homes. She further stated unidentified persons in her present neighborhood have told her Agent [redacted] and [redacted] have watched her apartment and are telling people what she does in her home.

b7c-1 As indicated above during the interview Mrs. [redacted] rambled at length and was extremely difficult to understand. It is felt that she may well be experiencing some type of emotional stress and it is felt further personal contact with her would not be in the best interest of this Bureau.

With reference to the memorandum of February 11, 1972, concerning captioned individual who had called the Bureau late 2/11/72 alleging he had been victimized in an extortion plot, at 12:35 p. m., 2/15/72, a Mrs. Mildred Barron, Administrative Assistant to Pennsylvania State Deputy Attorney General Dante Mattioni, Philadelphia, telephonically made inquiry concerning [REDACTED]. According to Mrs. Barron, [REDACTED] who identified himself as a doctor called from Southern New Jersey [REDACTED] advising he had just returned from Washington, D. C. He indicated he had been in touch with a Chief Justice Ben Jones and had reported his difficulties to a Mr. Shroder of the FBI. He requested that Mr. Mattioni contact him on a very urgent matter as soon as possible.

Telephone Calls

Mrs. Barron indicated that since he had mentioned the FBI Mr. Mattioni did not want to become involved unless it was a matter of interest to the State of Pennsylvania. She was advised that a quick check would be made and she would be recontacted forthwith.
