U.S. House of Representatives

On May 2, 1977, a search of the files of the Sergeant at Arms, House of Representatives, was caused to be made by SA [REDACTED] which disclosed the following information concerning the appointee:

ALBERT ARNOLD GORE took his seat in the House of Representatives as the Representative from the Fourth Congressional District of Tennessee on January 3, 1939. He resigned this seat on December 4, 1944, in order to enter the Armed Forces of the United States. He was reinstated March 6, 1945, again as the Representative from the Fourth Congressional District of Tennessee and served continuously in the House until January 2, 1953.

This record noted that in January, 1953, Mr. GORE took his seat as one of the two U.S. Senators from the state of Tennessee.

The records of the Sergeant at Arms further indicated that the appointee's son, ALBERT GORE, JR., took his seat in the House as the Representative for the Fourth Congressional District of Tennessee on January 3, 1977 (95th Congress) and is serving in that capacity at the present time. His local residence address is given as 1212 26th Street, South, Arlington, Virginia 22202. His district residence is listed as Route 2, Carthage, Tennessee 37030.

The following interviews were conducted by SA [REDACTED] on May 2, 1977.

Representative JAMES H. QUILLEN, Tennessee, advised as follows:

Mr. QUILLEN began by stating that he has known former Senator ALBERT GORE on both a personal and professional basis for approximately the past 30 years. He described Senator GORE as a very excellent person who is widely admired and respected by both his professional colleagues as well as by his personal associates. Mr. QUILLEN pointed out that he and the appointee are members of

different political parties, however, he has enormous respect for Senator GORE's ability and personal integrity. He emphasized that no adverse information concerning the appointee's moral character, patriotism or reputation has ever come to his attention. He recommended Senator GORE for a responsible appointive position of trust and confidence.

Representative JOHN J. DUNCAN, Tennessee, advised as follows:

Mr. DUNCAN has enjoyed a professional association with former Senator ALBERT GORE for approximately the past 20 years. Prior to entering the House of Representatives, Mr. DUNCAN served as the Mayor of Knoxville, Tennessee. In that capacity he had frequent and close professional contact with Senator GORE. He described Senator GORE as being a "mighty fine man" in every respect. He, too, noted that he and the appointee are members of opposite political parties, however, he likewise has an enormous amount of respect for Senator Gore's personal integrity. No unfavorable information of any kind which would cause him to question the appointee's moral character or loyalty to his country has ever been made known to him. Mr. DUNCAN recommended Senator GORE for a responsible position of trust and confidence.

Representative ED JONES, Tennessee, advised as follows:

Mr. JONES has enjoyed a close personal and professional association with former Senator ALBERT GORE for approximately the past 30 years. He described the appointee as being a man of "sterling character." Mr. JONES was especially closely associated with Senator GORE during the years that the appointee served in the U.S. Senate; namely, 1953 through January, 1971. He has the upmost respect for the appointee's competency and spoke favorably of his integrity, patriotism and associates.

Mr. JONES then went on to say that the appointee's son, Representative ALBER JONES, JR., was elected to his father's former seat in the House as the Representative

of the Fourth Congressional District of Tennessee last fall and took his seat in the 95th Congress in January, 1977. As an aside, Mr. JONES mentioned that the election of his son to the House was an enormous source of pride for Senator GORE.

During the course of the interview Representative JONES advised that he and former Senator GORE both resided in the Methodist Building, 110 Maryland Avenue, N.E., Washington, D.C. He noted that both he and Senator GORE have resided there for a number of years and the appointee, of course, enjoys an excellent reputation among his neighbors in that building.

Mr. JONES reiterated the highest esteem that he has for Senator GORE and described him further as being, in his opinion, "one of the greatest men in the United States today." He strongly endorsed Senator GORE for a responsible position of trust and confidence.

He is very capable, sincere, personable, honest, and trustworthy. He commented favorably regarding his character, loyalty, associates, and reputation recommending him for a position of trust and confidence.

U. S. Senator HERMAN E. TALMADGE, Georgia, advised he knew the appointee as a former colleague in the

U. S. Senate for over 12 years and they served together on the Finance Committee. The appointee is a very capable, dedicated, dependable, and trustworthy person who would serve as a credit to his country. He commented favorably regarding his character, loyalty, associates, and reputation recommending him for a position of trust and confidence.

U. S. Senator JACOB K. JAVITS, New York, advised he knew the appointee as a former colleague in the U. S. Senate from 1956 to 1971, and they both served together on the Foreign Relations Committee. He described the appointee as being a very fine man. He thinks very highly of him. He is capable, dependable, and trustworthy. He commented favorably regarding his character, loyalty, associates, and reputation recommending him for a position of trust and confidence.

U. S. Senator ABRAHAM RIBICOFF, Connecticut, advised he has known the appointee since 1962, as a former colleague adding he is very capable, very personable, trustworthy, reliable, and sincere. He commented favorably regarding his character, loyalty, associates, and reputation adding he gives his consenting approval of the appointment of the appointee to a position of trust and confidence.

U. S. Senator WARREN G. MAGNUSON, Washington, advised he knew the appointee as a former colleague in the U. S. Senate during the appointee's period of employment as a Senator from Tennessee. The appointee is very capable, hardworking, highly regarded by his former colleagues, and he commented favorably regarding his character, loyalty, associates, and reputation. He recommended the appointee for a position of trust and confidence.

THE INVESTIGATION OF SENATOR GORE COVERED INQUIRIES AS TO HIS CHARACTER, LOYALTY, ABILITY, AND GENERAL STANDING, BUT NO INQUIRIES WERE MADE AS TO THE SOURCES OF HIS INCOME.

Birth

Senator Gore was born on December 26, 1907, in Granville, Tennessee.

Education

Senator Gore attended Middle Tennessee State University, Murfreesboro, Tennessee, from September, 1925, to June, 1932, on a part-time and full-time basis, receiving a B.S. degree

He also attended the Young Men's Christian Association (YMCA) Law School, Nashville, Tennessee, as a student in evening sessions from September, 1933, to June, 1936, receiving an LL.B. degree.

Military Service

Records of Senator Gore's military service could not be located during the course of this investigation and may have been destroyed in the fire at the National Personnel Records Center, St. Louis, Missouri, on July 12, 1973.

Senator Gore has advised he enlisted in the United States Army in December, 1943, and served for approximately one year until he was honorably discharged in 1944. He was unable to furnish any specific dates for his military service.

Employment

From September, 1927, to May, 1928, Senator Gore was employed as an elementary school teacher at the Highland Elementary School, Livingston, Tennessee.

From June, 1928, to June, 1933, he was employed as a teacher at the Pleasant Shade High School, Pleasant Shade, Tennessee.

From July, 1933, to December, 1935, he served as Superintendent of Education of Smith County, Carthage, Tennessee.

From January, 1936, to December, 1937, he served as Commissioner of Labor, State of Tennessee, Nashville, Tennessee.

From January, 1938, to December, 1938, Senator Gore was engaged in the private practice of law in Carthage, Tennessee, and also campaigned during a portion of that time for the position of United States Representative from Tennessee.

He served as United States Representative from the 4th district of Tennessee from January, 1939, to January, 1953, in Washington, D. C.

From January, 1953, to January, 1971, he served as United States Senator from Tennessee in Washington, D. C.

Subsequent to his service in the United States Senate, Senator Gore was a member or associate member of the law firm of Gore, Barrett, Mitchell and Barrett, Nashville, Tennessee (1971 - 1973), and the law firm of Peabody, Minick, Gore, Schaubert and Washburn in Washington, D. C. and Los Angeles, California (1971 - 1973).

During the spring semester of 1971, Senator Gore served as a guest lecturer in public affairs at Vanderbilt University, Nashville, Tennessee, and he also served as a Fellow in the Institute of Politics, John F. Kennedy

School of Government, Harvard University, Cambridge, Massachusetts, during the period from May, 1971, to June, 1971.

Since September, 1972, Senator Gore has been associated with the Island Creek Coal Company, Lexington, Kentucky, as Chairman of the Board of Directors. He also serves as Executive Vice President and Member of the Board of Directors of Occidental Petroleum Corporation, Los Angeles, California, which is the parent company of Island Creek Coal Company.

In addition to the foregoing, Senator Gore also served as United States Representative to the 17th Session of the General Assembly of the United Nations, New York, New York, from September, 1962, to December, 1962. Senator Gore also owns and operates Gore Farms, Incorporated, Carthage, Tennessee, and he is a partner and part owner of Cumberland Feed Mill, Incorporated, and Gore Supply, Incorporated, both located in South Carthage, Tennessee.

Marital Status

Senator Gore is married to the former Pauline LaFon, and they reside at Gore Farms, located on Route 2, Carthage, Tennessee. They also maintain residences in Apartment 8L at 101 South Hanover Street, Lexington, Kentucky, and in an apartment at 110 Maryland Avenue, Northeast, Washington, D. C.

Interviews

An individual who has requested confidentiality advised he has known Senator Gore for approximately five years. He said that during the late 1960's and early 1970's, he had what he described as an intermittent professional association with Senator Gore. This person stated he had an opportunity to observe Senator Gore in Washington, D. C.

He stated he believes he knows the Senator quite well and considers him to be a man of integrity whose character, associates, loyalty and reputation are outstanding. He also said the Senator is a man experienced in public affairs who has a high level of intelligence.

Albert Arnold Gore

This individual stated, however, in his opinion Senator Gore is a man of good intentions who undoubtedly means well, but is never able to see anything in the "gray area." He stated by this he means that the Senator apparently views situations as "only black and white." He said by way of illustration that the Senator picks a position and thereafter will not deviate from that position and will not listen to other sides of the argument. He said in his opinion the Senator is a very dogmatic individual. He said because of this it is his belief that Senator Gore may be inclined to make up his mind too quickly, believing he is doing the right thing, and refusing to be swayed from his position. He said because of this he could not recommend Senator Gore for a position of trust and confidence.

Fifty-eight additional persons, consisting of current and former supervisors and co-workers, present and former neighbors, references, professional associates, and social acquaintances of Senator Gore's, were interviewed. They advised he is a loyal American whose character, reputation, and associates are above reproach. They highly recommended him for a position of trust and responsibility. Several of Senator Gore's professional associates commented very favorably concerning his outstanding ability in the area of negotiation and renegotiation of contracts, particularly during his employment with Island Creek Coal Company. Several United States Representatives and United States Senators who served with Senator Gore in the past stated that while a United States Representative and United States Senator, he performed in an outstanding manner as a Congressman from the State of Tennessee. They commented on his excellent ability to get along with all people, regardless of their station in life. Others described him as an astute businessman who has always been interested in the welfare and well-being of the people of the United States.
