Not All Protesters Part Of Conspiracy

TULSA. (UPI) — A former member of America's New Left told the 14th annual Christian Crusade convention Friday night that campus groups were not automatically a part of any conspiracy just because they supported a political cause in which other people did not believe.

"Many campus groups may be part of the New Left syndrome, but just because someone is espousing a political cause with which you do not agree is no reason to pre-suppose he or she is a New Leftist," Phillip Abbott Luce told the convention in Tulsa.

"Neither should we assume that a local protest organization is automatically a part and parcel of some 'international' or 'national' conspiracy."

Luce was the featured speaker at Friday's session of the convention, organized by Dr. Billy James Hargis of the Christian Crusade for Christ.

Hargis described Luce as a "defector from the Maoist Progressive Labor group." Since leaving the New Left in 1965, Luce has been touring college campuses and writing articles on the movement.

"The most heartening note I have recently found is that many of the young people who call themselves 'Leftists' or 'New Leftists' are not buying the collectivist doctrine of the established (Communist) organizations," Luce said. "They are quite simply libertarians, rebelling against unreasonable power and authority, whether it comes via established government or totalitarian (leftist) organizations."

Luce said there are actually three Communist parties in the United States: The American Communist Party, which follows the Moscow line of "peaceful co-existence"; the Trotskyite Socialite Workers Party, which made most of the inroads among Leftists in recent years, and the Progressive Labor Party, which follows Peking.

"These young Communists are few in number but vibrant and vehement in their programs," he said. "Their three R's might well be riot, rebellion and revolution."

Luce himself was a member of the latter group in the early 1960s. He was indicted by a grand jury for illegal trips to Cuba in 1963 and 1964 to meet with Maoist leaders.

Luce said the young Communists are "an irrational part of an irrational system."

"We live in a country in which politics has taken on the character of a national advertising campaign, where honesty is rare, where campaign promises are made to be knowingly violated upon election, where the public has come to accept, and even smile at, the corruption and bribery incorporated into state and national legislatures."

During the afternoon sessions Friday, Dr. Jess Pedigo of Tulsa told the convention that "a Satan church has been established here in conservative Tulsa."

Pedigo said political assassination, such as those of President John F. Kennedy and Sen. Robert Kennedy, were inspired by Satan. He said both Lee Harvey Oswald and Sirhan Sirhan were worshipers of the devil.

"The tidal wave of occultism is sweeping America," Pedigo said. He said Satan worshipers also are increasing in numbers around the world, particularly in Great Britain.

Sharing the platform with Pedigo Friday afternoon was Dr.

Russell Grow, administrative head of the American Christian College in Tulsa.

Grow told the convention that western civilization was becoming extinct.

"It is difficult for us to think of all this as approaching extinction, particularly our own part of it," Grow said. "Yet evidences of great civilizations of the past show that they

flourished as we have, and were destroyed.

"We are now confronted with less developed but disciplined, vigorous nations, preparing to take over what they believe to be our certain failure. Russia appears to be much more advanced than China, but both are challenging us and our way of life."

The convention will continue in Tulsa through Sunday.

Hargis Says Devil Behind Movement

TULSA (AP) — Dr. Billy James Hargis, Christian Crusade founder-director, said Saturday night, "a conspiracy so monstrous it staggers the human mind is now gaining worldwide proportions."

Hargis said the conspiracy is Satanic in nature. "I believe that hidden behind the vile Communist revolution and the Christless, anarchistic revolutionary movement inside high circles in the United States is Satan himself."

Hargis addressed more than 4,000 delegates, from 25 states and five foreign countries.

It's impossible to get at the root of world problems without recognizing "there is a real devil," he said.

In his "State of the Union" address, Hargis also announced construction of a field house, multi-story administration building

and radio and TV studios.

"We have run out of space, classroom space, kitchen space, dining room space, auditorium space, and chapel space," he said. "Our American Christian College is growing, and we must keep pace with this growth with proper facilities."

He said the three buildings would cost nearly \$600,000, and that a Tulsa bank had agreed to lend the organization \$400,000.

Titles have been changed to reflect the new name used by the National Association To Keep and Bear Arms (NAKBA) and additional names used by the New Christian Crusade Church. As reflected in the January 1975 edition of Armed Citizens News, a copy of which is enclosed for the Bureau, the new name of the NAKBA is given as National Alliance To Keep and Bear Arms. Information set forth herein indicates that other names utilized by the New Christian Crusade Church are Christian Crusade, New Christian Crusade and Crusaders.

The following information is set forth in an effort to show the indications of an increasingly close cooperation between captioned organizations and their leaders and also the progressively increasing influence of [REDACTED] among these organizations.

Copies of this communication are being furnished not only to the Offices of Origin concerning captioned investigations, but also to other offices believed to have activities connected with captioned organizations within their respective divisions.

On 9/18/74, [REDACTED] advised that [REDACTED] of Los Angeles, California; [REDACTED] of Escondido, California; [REDACTED] of Fallbrook, California; and JAMES WARNER were to meet with ROBERT DE PUGH in Kansas City, Missouri, on 9/21-22/74.

WARNER is the Western Head of the New Christian Crusade Church (NCCC) and [REDACTED] is [REDACTED] and [REDACTED] are among a small group of individuals residing in the North San Diego County, California, area who are members of both the NCCC and the Ministry of Christ Church (MCC), aka Identity Group. They have consistently attended MCC monthly meetings in San Diego and NCCC meetings held in their individual homes. Recently they have attended the regular monthly NCCC meetings in San Diego, which are conducted by BERTRAND COMPERATE, a retired attorney.

This same source advised that about 200 persons representing 50 right-wing organizations were to be present at the above mentioned meeting, the purpose of which was unknown.

This same source also stated that on 8/11/74, [REDACTED] and [REDACTED] were among ten affiliates of the NCCC who distributed leaflets outside a church in Oceanside, California, espousing the white supremacy philosophy commonly held by those in the "Identity Movement".

Referenced San Diego LHM dated 11/13/74 reflected that the above mentioned source, on 8/9/74, 8/14/74 and 8/18/74, furnished amplifying information concerning the above mentioned

NCCC demonstration in Oceanside, California, that the demonstrators had distributed copies of the Christian Vanguard, the official publication of the NCCC. [redacted] and [redacted] as leaders of this demonstration, stated that they were planning to lead similar monthly demonstrations somewhere in San Diego County. [redacted] said that he anticipated that photographs of the demonstration were going to appear in the Christian Vanguard and thereby they hoped to spur similar events as their Oceanside demonstration across the United States, which would be the beginning of a "militant Christian movement". Both [redacted] and [redacted] had voiced their impatience with the Reverend WILLIAM P. GALE who heads the MCC because they believed that he was not enough "action oriented". They hoped to force GALE to join them in becoming more action oriented by their boycotting his meetings to demonstrate against his passiveness.

Referenced Indianapolis airtel and LHM dated 11/8/74, reflected that on 10/22/74, [redacted] advised that the NCCC had authorized the establishment of a congregation in the Indianapolis, Indiana, area which was to operate under the name of American's First Party, and that this group had been urged to form "Crusader" units to picket churches which promote false doctrines such as race mixing or falsely proclaiming that Jesus was a Jew. (It is noted that in a recent demonstration at the United States-Mexican border at San Ysidro, California, the same NCCC group that had previously demonstrated in Oceanside, California, referred to themselves in pamphlets as "Crusaders". The details of this demonstration will be set forth in form suitable for dissemination. Referenced San Diego teletype to Bureau dated 12/5/74 advised of the plans for this demonstration.)

Referenced Indianapolis teletype dated 9/24/74 reflected the following information furnished by [REDACTED] on 9/24/74:

The 9/21-22/74 meeting at Norborne, Missouri, was hosted by ROBERT DE PUGH, National Co-ordinator of the Minutemen, and was attended by leaders of right-wing groups. The purpose of this meeting was to unify various factions of the right wing. Some of these groups which were represented at this meeting were the United Klans of America, Inc., represented by ROBERT SHELTON; the National Knights of the Ku Klux Klan, represented by DAVID DUKE; and the National States Rights Party, represented by Dr. EDWARD FIELDS. The attendance varied from 125 to 175 people. The only substantive conclusions arrived at during this meeting were:

- (1) The proposed establishment of a Wide Area Telecommunications System (WATS) that was to be financed by DE PUGH and which would enable rapid and economical communications; and
 - (2) The establishment of a "black list" to enable the reportedly 50 groups represented at this meeting to identify individuals who were not true to the beliefs of the right-wing groups. It was agreed upon to hold future similar meetings at unspecified places on unspecified dates.

Referenced Indianapolis airtel and LIM dated 10/21/74 reflects that [REDACTED] on 9/23/74, advised that [REDACTED] of Fallbrook, California, while attending the Patriots Leadership Conference at Norborne, Missouri, on 9/21-22/74, stated that he was with the NCCC, which was closely affiliated

with WILLIAM POTTER GALE of the Identity Group, in both ideology and leadership. [REDACTED] further advised that he was then in charge of [REDACTED] for both the NCCC and the Identity Group, aka MCC. [REDACTED]

[REDACTED] He further stated that he was currently [REDACTED] at Manasseh Ranch, California, which is owned by WILLIAM GALE. [REDACTED] also said that GALE was having trouble restraining his followers from violence; and, that the Identity Group was supposed to have planned several maneuvers of a violent nature in the past but that GALE had called these off at the last minute. Because of this, many of the members are becoming disgruntled at GALE's "foot dragging".

On 9/24/74, [REDACTED] furnished the following information:

At the Patriots Leadership Conference, Norborne, Missouri, on 9/21-22/74, it was stated that ROBERT DE PUGH's parole officer had told him that because of this conference, DE PUGH's parole might be revoked. [REDACTED]

[REDACTED] Verbal attacks on the Jews by most of the speakers at this conference were loudly and almost unanimously applauded by those present. It was stated at this meeting that a [REDACTED] who was attending this conference, had recently returned from several years residence in Italy where he had been closely associated with the M.S.I. (Italian Fascist Party). Upon his return to the United States, his first contacts were with MATT KOEHL, leader of the National Socialist White People's Party (NSWPP) and WILLIE CARTO, National Head of the Liberty Lobby. It was made known at this conference that [REDACTED] intended to assist JAMES K. WARNER in his work in the NCCC.

[redacted] and [redacted] made it known that they had decided to exert heavy pressure against WILLIAM K. SHEARER, National Chairman of the American Independent Party (AIP), to unite under the racist banner with DE PUGH, ROBERT SHELTON, JAMES WARNER and other similar extremists. If they could not succeed in this, then they hoped to destroy SHEARER's ability to lead the AIP even if it meant wrecking the AIP itself. Upon hearing the "far rights version" of the death of KATHY AINSWORTH which supposedly happened in Mississippi several years ago, [redacted] remarked, "It made me just want to go out and kill all the Agents I could." He was referring to Federal Agents, according to the source.

Referenced Indianapolis teletypes dated 1/7/75 and 1/14/75 reflect that according to [redacted]

[redacted] Due to WILLIAM GALE's "negativism" concerning operations, [redacted] was withdrawing slightly from GALE [redacted]

Referenced Kansas City letter to the Bureau dated 12/12/74 furnished a copy of a "Petition to the Congress of the United States of America From 700,000 Registered Voters" which was drawn up during the Patriots Leadership Conference in Norborne, Missouri, on 9/21-22/74.

On 1/6/75, [redacted] (Protect) of the [redacted] furnished the above described document (which is enclosed for the Bureau) as well as the letter, and a separate sheet setting forth the purposes of the Patriots Inter-Organizational Communications Center, and also material advertising products marketed by ROBERT DE PUGH. All of these above items were received in an envelope postmarked 12/10/74 at Norborne, Missouri, bearing the pre-printed return address of BIOLAB Corporation, Norborne,

Missouri, 64668. The letter claimed that the petition, which is opposed to the confirmation of NELSON ROCKEFELLER as Vice President, was "the first gesture of united action by 70 different leaders of patriotic organizations". Copies of these documents are attached to this communication, with the exception of the petition, which is only attached to the copies for Denver, Las Vegas and Phoenix.

On 1/22/75, [REDACTED] furnished a copy of the Armed Citizens News, which this source had received in the mail. This January 1975 edition indicated it was the official publication of the NAKBA which had just changed its name to the National Alliance To Keep and Bear Arms and also recently had a change of leadership in the organization. It showed the National Headquarters of NAKBA to still be Medford, Oregon, but also listed the publication office as Post Office Box 71, Norborne, Missouri, 64668. This edition indicated that the new leadership consists of President - JACK MARLOW; Vice President - ROD ROSE; Secretary - ROBERTA OWENS; Treasurer - ROBERT B. DE PUGH; Field Representative - JOHN GRIGSBY; and Legislative Chairman - W. A. (AL) BLACKFORD. Much of the material in this edition is either written by or about ROBERT DE PUGH. On Page 3, Column 1, DE PUGH stated, "In my position as Director of the Patriots Inter-Organizational Communications Center, I have been able to arrange loans for the NAKBA which I hope will be sufficient to see us through this crisis. Using my friendly contacts with other patriotic organizations, I have enlisted their help in planning a new membership drive to help NAKBA grow into a better, larger and more effective organization than it has ever been in the past."

(Note: Following DE PUGH's release from parole in April 1973, in June 1973, he indicated that he planned to revitalize the Minutemen into a "two-armed organization".

Arm Number 1 was to be utilized as a political front organization to sway elections and control local and state political structures. Arm Number 2 was to be an underground guerrilla organization made up of "strike teams". These "strike teams" are to be under the direct control of DE PUGH and their existence is to be unknown to everyone, including Minutemen State Co-ordinators.)

On 12/31/74, [REDACTED] furnished a copy of a letter from the NCCC dated Christmas 1974, which was signed by JAMES K. WARNER, copies of which are attached to each copy of this communication. Among other things this letter states, "As you know, the Patriotic Leadership Conference in Norborne, Missouri, in September was a great success. Leaders of over 90 different organizations were present. Those leaders represented over 700,000 patriotic Americans." WARNER advised that in response to BOB DE PUGH's urging that the September meeting be followed up with regional meetings all over America to further cooperation between right-wing organizations, they are now planning to hold a West Coast Patriots Leadership Conference in Los Angeles on 2/15/75, which was to be attended by patriotic leaders from California, Colorado, Texas, Arizona, New Mexico, Washington, Nevada and Oregon. According to WARNER, the Chairman of this conference is to be JACK AZEVEDO from California. This letter also advised that on 2/16/75, a National Convention of the NCCC would be held in Los Angeles and that ROBERT SHELTON would be the key speaker.

Referenced Kansas City LHM dated 10/9/74 reported that JACK AZEVEDO, [REDACTED] Road, Fort Bragg, California, was among those attending the Patriots Leadership Conference at Norborne, Missouri, held on 9/21-22/74. According to information furnished on 6/7/74 by [REDACTED] (protect at her request), [REDACTED] with whom contact has been insufficient to (continued)

determine reliability, during late April or early May 1974, the leader of the Posse Comitatus at Fort Bragg, JACK AZEVEDO, [REDACTED] Road, Fort Bragg, made comments to the effect that Posse Comitatus groups were being chartered everywhere. AZEVEDO had recently sold his meat market called "Jack's Market" and was considering moving to Michigan where [REDACTED], who is connected with the Identity Group and the Posse Comitatus, resides. ARMIN MOTHS (who leads the Know Your Rights group and who is reportedly a Posse Comitatus contact in San Diego) of El Cajon, California.

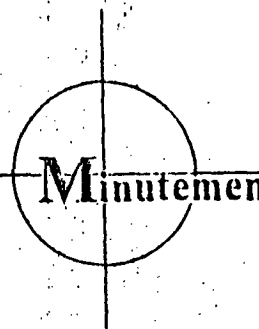
